# Installation

Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90? clockwise or counterclockwise installation may induce poor ventilation and successive component damage.

# Installing the Monitor Stand Assembly


1. Insert the display neck onto the indentation on the back of the monitor.



2. Press and hold down the button on the back of the monitor (as indicated in the picture). While holding down the button, pull the neck upwards (as indicated in the picture) in order to take the display neck plate out.



3. Once the display neck plate is out attach the display neck plate to the display neck and secure it with 2 screws. Also attach the base to the display neck assembly and secure the base with 2 screws from the bottom. Now you have a complete display stand.



4. Hang the display onto the display stand and arch downwards (as indicated in the picture) until you hear a clicking sound which indicates the monitor is securely attached to the stand.



- 5. To finalize your installation of the display, please read the following:
  - a. If you are placing the display on a stand, we would recommend you to use a display safety strap (not included) in order to minimize the possibility of the display toppling over.
  - b. Securely install all screws and connections.

# **Removing the Stand for Wall Mounting**

1. To uninstall the stand assembly, lay the monitor facing downwards on a table. Press the button on the back of the monitor located near the monitor's neck plate and while holding the button down lift the stand assembly up.



2. Once the stand is removed, you will see the indentation with 4 holes. You can mount the monitor using M4 screws at 12mm length.

# **Identifying Front and Rear Panel**


### **Front View with Buttons**




