
Installation

Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and successive component damage.

Installing the Monitor Stand Assembly

1. Lay the monitor screen facing down on a table and install the neck to the back of the monitor. Secure the installation by inserting and tightening the two neck screws.








- 3. To finalize your installation of the display, please read the following:
 - a. If you are placing the display on a stand, we would recommend you to use a display safety strap (not included) in order to minimize the possibility of the display toppling over.
 - b. Securely install all screws and connections.

Removing the Stand for Wall Mounting

1. To uninstall the stand assembly, lay the monitor facing downwards on a table. Look for the two screws between the joint where the neck and the monitor meets. Remove the screws and the stand assembly can be pulled off.



2. Once the stand is removed, you will see the indentation with 4 holes. You can mount the monitor by **installing the 4 spacers first** then using M4 screws at 12mm length.

Identifying Front and Rear Panel

Front View



Indicator Light – The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.


Panel Tilt Adjustment

The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the specific model of the device. Generally, it may be inclined $3\pm 2^{\circ}$ forward and $15\pm 2^{\circ}$ backward with a combined angle of $18\pm 4^{\circ}$.


• When adjust the angle of the monitor, be sure not to touch or press the LCD screen.

Rear View with Buttons




- 1. Solution activates the On Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
- 2. ▲ With no OSD, this button cycles between PRESET modes. With the OSD turned on, this button moves the selection upwards. This button will also increase the value of an adjustment while an option is open.
- 3. ▼ With no OSD, this button activates a permanent crosshair for first person shooting games. With the OSD turned on, this button moves the selection downwards. This button will also decrease the value of an adjustment while an option is open.
- 4. (S)– When the OSD is active, this button acts as the EXIT button and exits out of the option or OSD. This button switches between all the different inputs of the display.
- 5. U This button turns the display on or off.

Rear View with Connections



- 1. **POWER** This plug is responsible for providing power to the monitor. Use it with the included AC adapter.
- 2. **DVI** DVI stands for Digital Video Interface. This connection is for computers to send video signals to the monitor by a digital signal.
- 3. **HDMI** HDMI stands for High Definition Multimedia Interface. This connection is for computers with HDMI video output.
- 4. **DISPLAY PORT** Display port is a digital video connection for connection to computers with display port video output.
- 5. **AUDIO IN (3.5mm Mini-jack)** This connection is for audio in from the computer going into the monitor.
- 6. **AUDIO OUT (3.5mm Mini-jack)** This connection is for audio out from the monitor to multimedia speakers or headphones.




- 1. Make sure the power of the C27 LED MONITOR is turned off.
- 2. Obtain a HDMI cable and connect one end to the back of the monitor and the other end to the back of the computer.


