



Installation

Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. Use only the Sceptre provided power cable or AC adapter approved for use with this device. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. 

Identifying Front and Rear Panel

Front View



Indicator Light – The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

Panel Tilt Adjustment

The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the specific model of the device. Generally, it may be inclined $2\pm1^{\circ}$ forward and $10\pm1^{\circ}$ backward.

Please Note:

• When adjust the angle of the monitor, be sure not to touch or press the LCD screen.


Rear View with Buttons



Buttons from right to left

- HDMI 1 HDMI stands for High Definition Multimedia Interface. This connection is for computers with HDMI video output. HDMI supports adaptive sync, a feature that eliminates picture tearing and stuttering.

- 5. **AUDIO OUT (3.5mm Mini-jack)** This connection is for audio out from the monitor to multimedia speakers or headphones.


