This product is designed and manufactured to operate within defined design limits, and misuse may result in electric shock or fire. ## Opening the Package

---

The SCEPTRE display is packaged in a carton. The size and weight of the product might be too heavy for 1 person to handle. In the event of that happening; it is recommended that the display package must be handled by a minimum of 2 or more persons. Since the glass can be easily scratched or broken, please handle the product gently. Never place the unit on a surface with the glass facing downwards unless it is on protective padding. When opening the carton, check that the product is in good condition and that all standard accessories and items are included. Save the original box and all packing materials for future shipping needs.

## Installation

---

Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. Use only the Sceptre provided power cable or AC adapter approved for use with this device. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and successive component damage.



## Installing the Monitor Stand Assembly

---

1. With the packing foam still on, lay the monitor screen facing down on a table and open the top half of the packing foam. Install the neck to the base and insert the 1 neck screw into the back of the neck. Tighten the screws to secure the neck.



2. Insert the rubber cover to the back of the neck.



3. Attach the base to the bottom of the neck.



4. Secure the base by inserting and tightening 2 base screws to the bottom of the base.

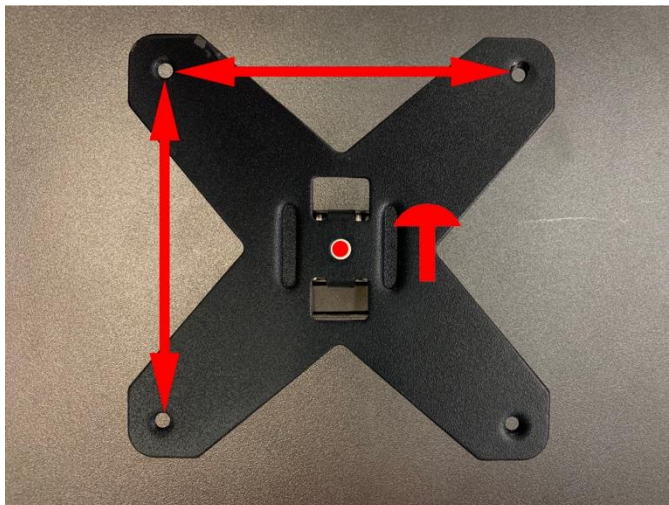


5. To finalize your installation of the display, please read the following:
  - a. If you are placing the display on a stand, we would recommend you to use a display safety strap (not included) in order to minimize the possibility of the display toppling over.
  - b. Securely install all screws and connections.

## Removing the Stand for Wall Mounting

---

1. To uninstall the stand assembly, lay the monitor facing downwards on a table. Remove the rubber cover and unscrew the single screw to remove the stand.



2. Once the stand is removed, you will see the indentation where you can install the mounting plate. **The mounting pattern is 75mm x 75mm using M4 x 10mm screws.**

# Identifying Front and Rear Panel

---

## Front View



**Indicator Light** – The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

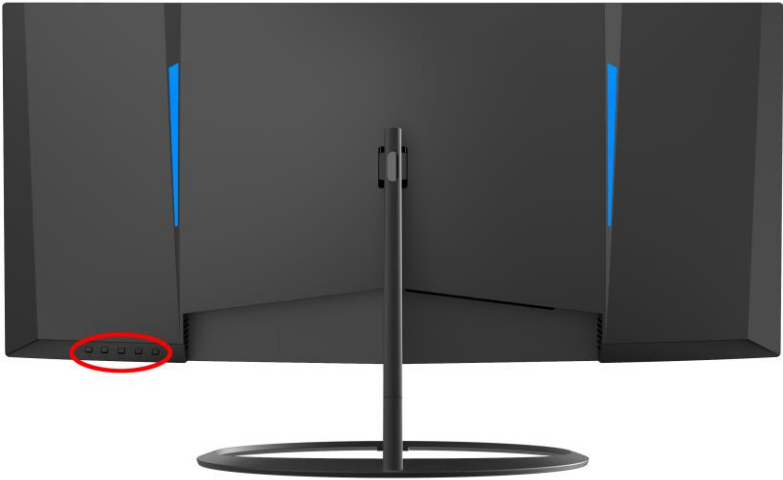
## Panel Tilt Adjustment

The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the specific model of the device. Generally, it may be inclined  $2\pm1^\circ$  forward and  $10\pm1^\circ$  backward.

Please Note:

- When adjust the angle of the monitor, be sure not to touch or press the LCD screen.

## Rear View with Buttons



### Buttons from right to left

1. **M** – This button activates the On Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
2. **▼** – With no OSD, this button lowers the volume of the monitor. With the OSD turned on, this button moves the selection downwards. This button will also decrease the value of an adjustment while an option is open.
3. **▲** – With no OSD, this button increases the volume of the monitor. With the OSD turned on, this button moves the selection upwards. This button will also increase the value of an adjustment while an option is open.
4. **E** – When the OSD is active, this button acts as the EXIT button and exits out of the option or OSD. With no OSD, this button switches between all the different inputs of the display.
5. **⏻** – This button turns the display on or off.

## Rear View with Connections



1. **POWER** – This plug is responsible for providing power to the monitor. Use it with the included AC adapter.
2. **DP** – DisplayPort (DP) is a digital video connection for connection to computers with display port video output. DP supports MPRT (Moving Picture Response Time) a feature that reduces motion blur and adaptive sync a feature that eliminates picture tearing and stuttering. **MPRT and Adaptive Sync cannot be turned on at the same time. Only one will be active at a time.**
3. **HDMI 1** – HDMI stands for High Definition Multimedia Interface. This connection is for computers with HDMI video output. HDMI supports adaptive sync, a feature that eliminates picture tearing and stuttering.
4. **HDMI 2** – HDMI stands for High Definition Multimedia Interface. This connection is for computers with HDMI video output. HDMI supports adaptive sync, a feature that eliminates picture tearing and stuttering.
5. **AUDIO OUT (3.5mm Mini-jack)** – This connection is for audio out from the monitor to multimedia speakers or headphones.

Please Note:

- MPRT can only be enabled at 85Hz refresh rate.
- Adaptive Sync is always turned on for HDMI ports.
- HDMI ports do not support MPRT.
- MPRT and Adaptive Sync cannot be turned on at the same time.

## If You have HDMI Connection on Your Video Card...



1. Make sure the power of the C30 LED MONITOR is turned off.
2. Obtain a HDMI cable and connect one end to the back of the monitor and the other end to the back of the computer.
3. Turn on the power of both the C30 LED MONITOR and the computer.



## If You have DisplayPort Connection on Your Video Card...

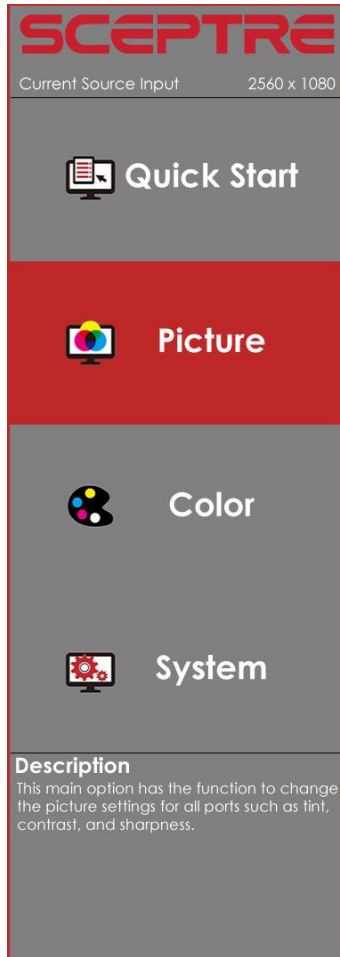


1. Make sure the power of the C30 LED MONITOR is turned off.
2. Obtain a DisplayPort cable and connect one end to the back of the monitor and the other end to the back of the computer.
3. Turn on the power of both the C30 LED MONITOR and the computer.

## On Screen Display (OSD) Menu

The OSD menu of the monitor provides various adjustments for the monitor such as color, brightness, and contrast .....etc.



When you press the **M** button on the monitor, the OSD screen will appear. Select each of the functions with the **▲** or **▼** buttons. Use the **M** button again to enter each of the function or when you're in the function already, use the **M** button to select the option you want to adjust. Use the **▲** or **▼** buttons to adjust each option's values. When you want to exit press the **E** button.

## How do I clean the LED Monitor?

---

### IMPORTANT

1. The power cable has to be removed from the socket before cleaning the display.
2. Do not use volatile solvent (alcohol, rosin, and toluene) to clean the display. These types of chemicals might damage the housing and the LCD glass.

### Cleaning the bezel

1. Use a 100% cotton cloth or micro-fiber cloth for cleaning.
2. If the bezel is dirty to the point where you cannot simply dry wipe it, please lightly dampen the wiping material with clean water and wipe again. Wipe the display with a dry micro-fiber cloth or 100% cotton cloth afterwards.

Please Note:

- Make sure you wring the water out of the cloth before cleaning the bezel in order to prevent water from penetrating into the electronics.

### Cleaning the Screen

1. Use a 100% cotton cloth or micro-fiber cloth for cleaning.
2. The LCD screen glass is extremely fragile. Do not scrape it with any material. Do not press or tap the screen to avoid cracking. When the screen is dirty to the point where you cannot simply dry wipe it, please lightly dampen the wiping material with clean water and wipe again. Wipe the display with a dry micro-fiber cloth or 100% cotton cloth afterwards.
