

Installation


Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. 
Installing the Monitor Stand Assembly

1. Connect the neck to the base and secure the installation by screwing in the 2 screws from the bottom of the base.



With the monitor in the packing foam, place the monitor face down on a table.
 Open the rubber piece on the back of the neck and connect it to the back of the monitor. Screw in the 2 screws to secure the installation.

Front View



Indicator Light – The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

Panel Tilt Adjustment

The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the specific model of the device. Generally, it may be inclined 5±2° forward and 15±2° backward with a combined angle of 18±4°.

Please Note:

 When adjust the angle of the monitor, be sure not to touch or press the LCD screen.

Rear View with Buttons




- 1. This button activates the On Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
