

Installation

Identifying Front and Rear Panel

Front View



Indicator Light –The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor. **The light faces downwards so the user will only see a blue light reflection on the table.**

Rear View



Mounting Specification – The mounting specification is 75mm x 75mm. The screw size is M4 x 7mm.

Panel Tilt Adjustment

The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the specific model of the device. Generally, it may be inclined $5\pm2^{\circ}$ forward and $15\pm2^{\circ}$ backward with a combined angle of $20\pm4^{\circ}$.
