Opening the Package

The SCEPTRE display is packaged in a carton. The size and weight of the product might be too heavy for 1 person to handle. In the event of that happening, it is recommended that the display package must be handled by a minimum of 2 or more persons. Since the glass can be easily scratched or broken, please handle the product gently. Never place the unit on a surface with the glass facing downwards unless it is on protective padding. When opening the carton, check that the product is in good condition and that all standard accessories and items are included. Save the original box and all packing materials for future shipping needs.

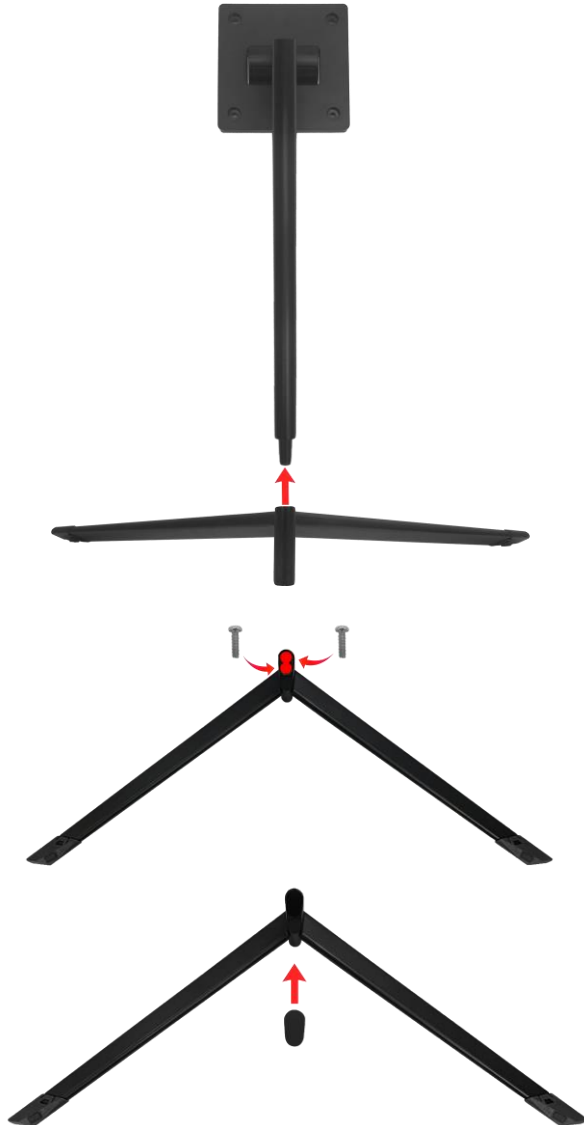

Installation

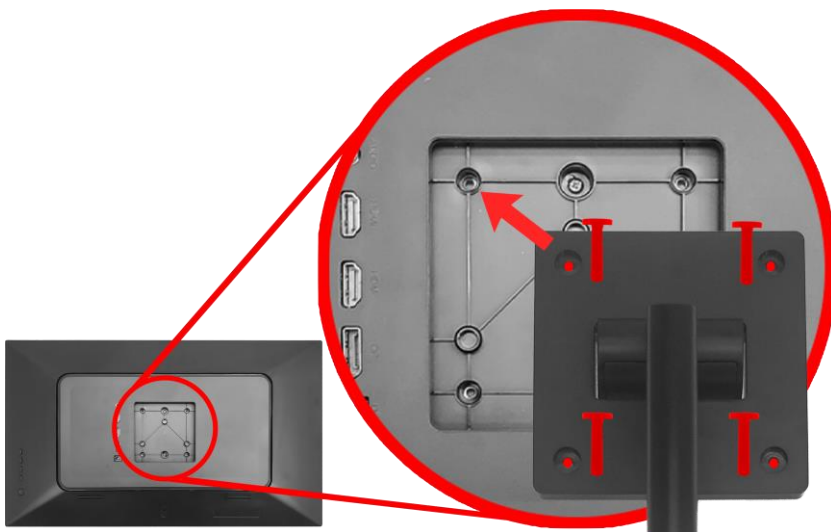
Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. Use only the Sceptre provided power cable or power adapter approved for use with this device. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and successive component damage.

Assembling the Stand

1. Obtain the base and the neck of the monitor. Insert the neck onto the base. Afterwards, secure the installation by screwing in the base screws from the bottom of the base. After, use the rubber feet provided to seal the bottom hole where the base screws are located.



2. With the monitor still lying in the package foam, lay the foam + monitor down on a table with the display facing downwards. Open up the top foam exposing the back. Insert the assembled stand (neck+base) into the opening.



3. Secure the installation by screwing in 4 neck screws.



4. To finalize your installation of the display, please read the following:
 - a. If you are placing the display on a stand, we would recommend you to use a display safety strap (not included) in order to minimize the possibility of the display toppling over.
 - b. If you are mounting the display on the wall
 - a. Make sure the wall is structurally safe for the weight of the display.
 - b. Make sure the wall mount kit is compatible with the display.
 - c. Read and follow all instructions provided by the wall mounting kit.
 - d. Securely install all screws and connections.

Disassembling the Stand

1. To remove the stand, lay the display with the screen portion facing down. Unscrew and remove the 4 neck screws.



2. Take out the stand piece.
3. To disassembly the stand itself, unscrew the screws from the bottom of the base. The neck can now be removed.

Identifying Front and Rear Panel

Front View



Indicator Light – The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

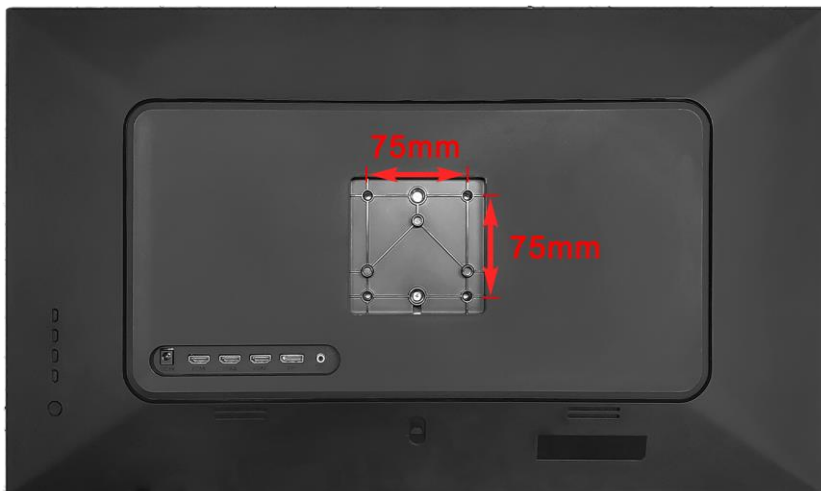
Panel Tilt Adjustment

The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the specific model of the device. Generally, it may be inclined $5\pm2^\circ$ forward and $15\pm2^\circ$ backward.

Please Note:

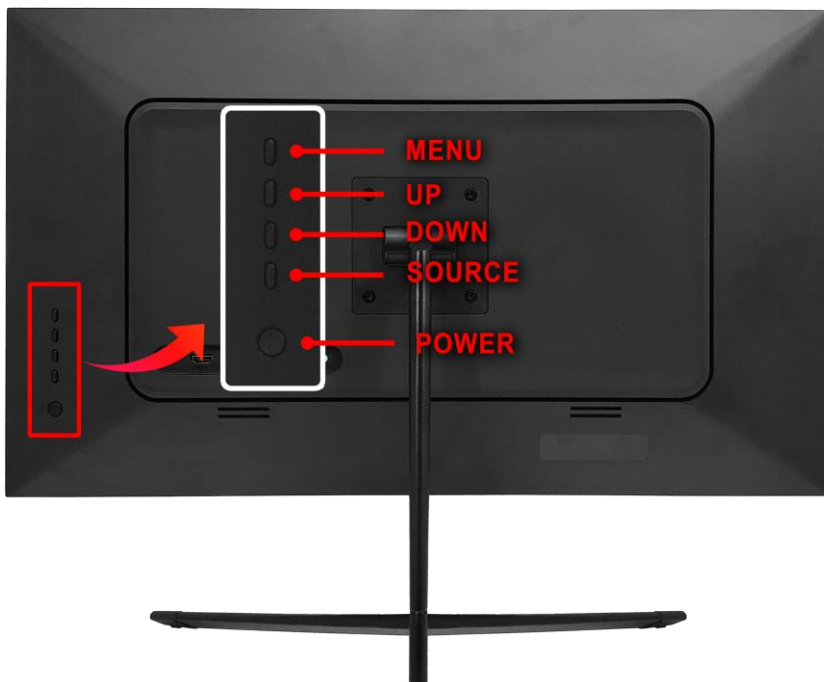
- When adjust the angle of the monitor, be sure not to touch or press the LCD screen.

Rear View Mounting Pattern



Mounting Specification: **75mm x 75mm** using screw size **M4**. Length of screw should not exceed 12mm. Please Note: The **12mm** length of screw refers to how deep the screw can go inside the mounting holes. When you are buying screws, you should add the original 12mm to the thickness of your mounting plate in order to get the total screw length.

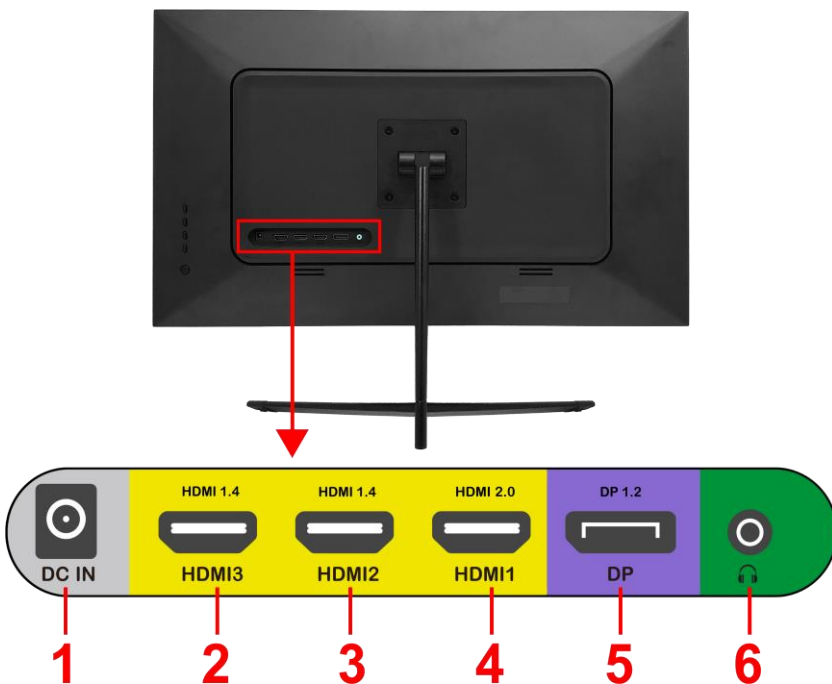
Rear View with Buttons



Buttons from top to bottom

1. **MENU** – This button activates the On-Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
2. **▲** – This button moves the selection up while the OSD is active. This button will also increase the value of an adjustment while an option is open. When the OSD is not active, this button increases the volume of the speakers.
3. **▼** – This button moves the selection down while the OSD is active. This button will also decrease the value of an adjustment while an option is open. When the OSD is not active, this button decreases the volume of the speakers.
4. **SOURCE** – This button switches between all the different inputs of the display. When the OSD is active, this button acts as the EXIT button and exits out of the option or OSD.
5. **POWER** – This button turns the display on or off.

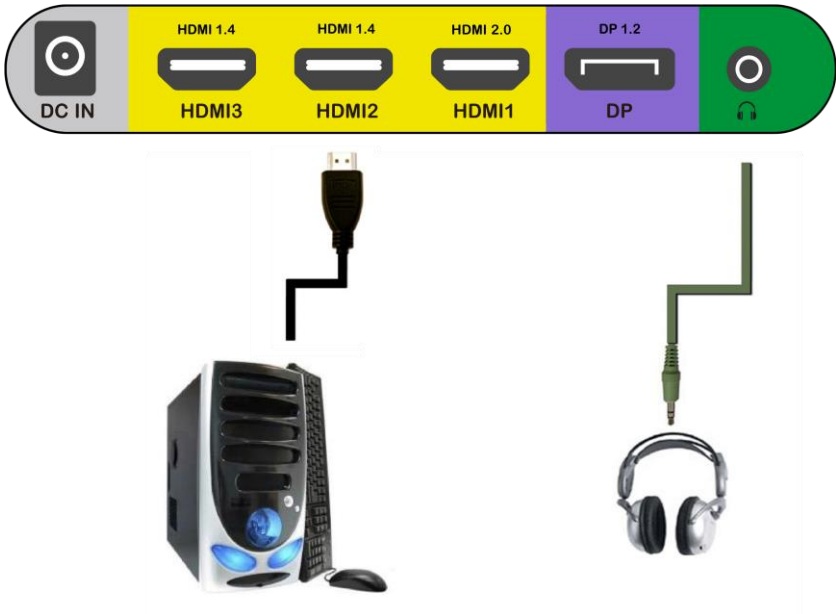
Rear View with Connections



1. **DC IN** – This plug is responsible for providing power to the monitor. Use it with the included AC adapter.
2. **HDMI 3** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video output.
3. **HDMI 2** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video output.
4. **HDMI 1** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video output.
5. **DP (DISPLAYPORT)** – DisplayPort is a digital video connection for connection to computers with display port video output.
6. **AUDIO OUT (3.5mm Mini-jack)** – This connection is for audio out from the monitor to multimedia speakers or headphones.

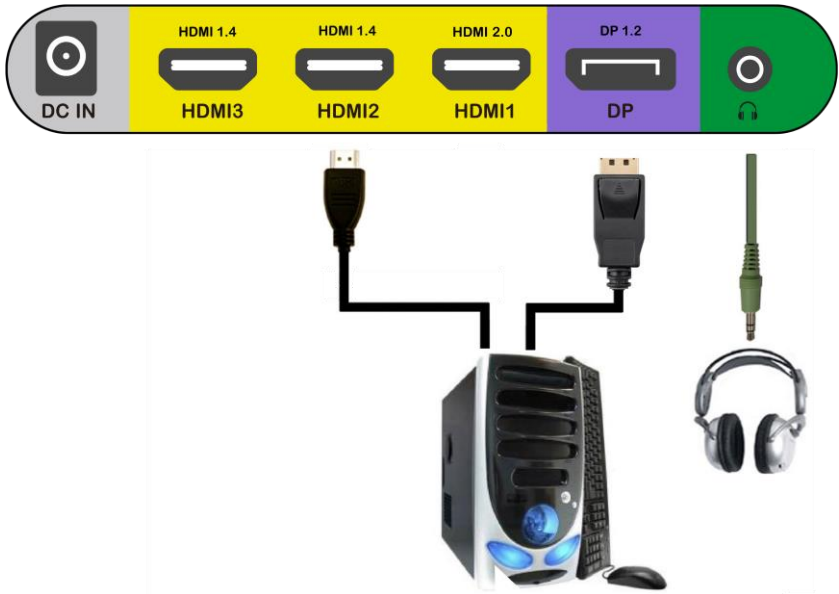

3. Turn on the power of both the E27 LED MONITOR and the computer.

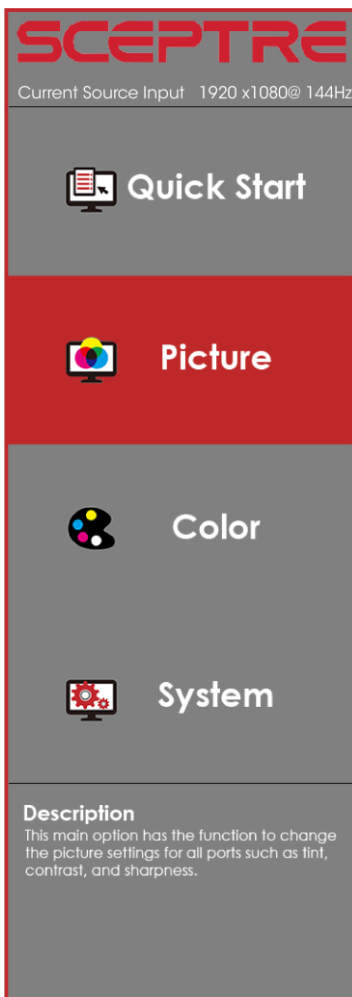
If you want to use Multi-Window with your video card...

2. Obtain a DisplayPort cable and connect one end to the back of the monitor and the other end to the back of the computer.
3. Obtain a HDMI cable and connect one end to the back of the monitor and the other end to the back of the computer.
4. Turn on the power of both the E27 LED MONITOR and the computer.
5. From the monitor side, open the OSD by pressing the MENU button. Under PICTURE, select and turn on Multi Window either by using PIP or PBP. Change to the correct HDMI source (diagram above shows computer connected to HDMI 2) for the secondary input.
6. From windows go to display settings and select extend display to show the desktop on both inputs.

The OSD menu of the monitor provides various adjustments for the monitor such as color, brightness, and contrast ...etc.





1. **TEMPERATURE** – This option let users select different color temperatures of the monitor.

1. **OVERDRIVE** – This option increases the pixel response time of the LED screen.
2. **Freesync™ PREMIUM** – This option enables syncing with variable frequency with AMD video cards.
3. **SLEEP MODE** – With the monitor given no video signal, enabling this option will make the monitor automatically shut off after 30 minutes, 60 minutes, or 2 hours.
4. **BACKCOVER LIGHT** – This option cycles through different light modes from the LED lights that are from the back cover of the monitor.
5. **LANGUAGE** – This option allows users to change the menu language of the monitor.

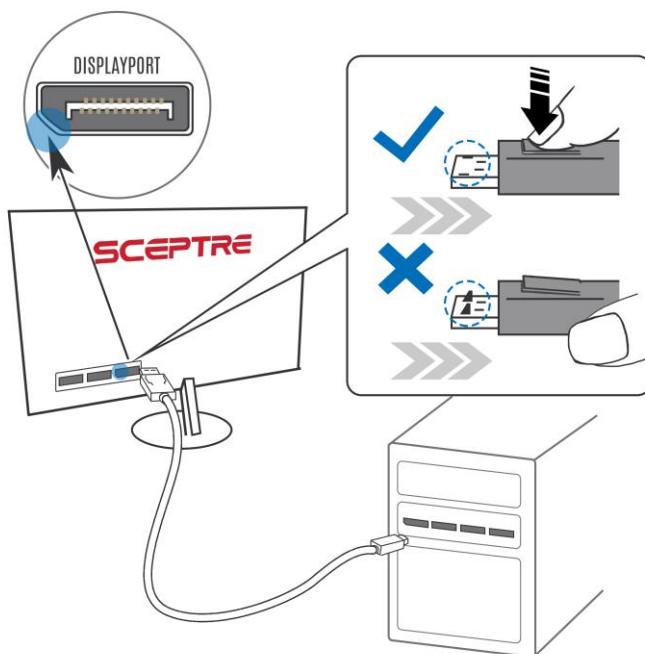

Swap out the video cable for another one to see if the monitor will work. Check your power plug. See if it is fully plugged in on both the monitor and the wall.
MONITOR SAYS "SIGNAL OUT OF RANGE"	<p>If you have a CRT monitor, please connect the CRT monitor to the computer and change the refresh rate down to 60 Hz via your video card's display settings menu. After the setting of 60 Hz has been changed, you can then use the E27 LED Monitor on the computer.</p> <ol style="list-style-type: none">1. To change the setting go to display settings by right clicking on your desktop with nothing selected. Choose the PROPERTIES option.2. How do I detach the DisplayPort Cable?

To detach the DP cable from the monitor, press down on the cables unlocking button while pulling the cable out.



How do I clean the LED Monitor?

IMPORTANT

1. The power cable must be removed from the socket before cleaning the display.
