Installation

Please read the user manual carefully before performing the installation. Please use the AC Adapter designated for the product. When an extension cord is required, use one with the correct power rating. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. If you would like to mount the display onto the wall, please be sure to read all instructions provided by the display mounting company and this manual. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and successive component damage.

Assembling the Stand

 Take the screen and lay it flat on a table with the display side facing downwards and insert the neck piece into the indentation on the bottom of the screen until you hear a click sound.



Obtain the base and align the indentation on the base with the neck piece starting off centered to the left. Insert the base to the neck piece and twist counterclockwise.



- 3. To finalize your installation of the display, please read the following:
 - a. If you are placing the display on a stand, we would recommend you to use a display safety strap (not included) in order to minimize the possibility of the display toppling over.

Disassembling the Stand

- To disassembly the base, place the monitor face down on a flat, smooth surface and look at the bottom of the base. You will see a small plastic buckle that secures the neck from twisting. Lightly lift up the buckle and twist the base clockwise. The base can now be removed.
- To disassemble the neck press the button on the back of the monitor and slide out the stand.

The buckle at the bottom of the base is made of plastic. Users are cautioned not to apply too much force.

Mounting Specification: **75mm x 75mm** using screw size **M4.** Length of screw should not exceed **8mm**. Please Note: The **8mm** length of screw refers to how deep the screw can go inside the mounting holes. When you're buying screws, you should add the original 8mm to the thickness of your mounting plate in order to get the total screw length.

Rear Control Buttons



- 1. This button activates the On Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
- ▲ With no OSD, this button this button will also increase the volume of the internal speaker. With the OSD turned on, this button moves the selection upwards.
- 3. ▼ With no OSD, this button will also decrease the volume of the internal speaker. With the OSD turned on, this button moves the selection downwards.
- 4. S—When the OSD is active, this button acts as the EXIT button and exits out of the option or OSD. This button switches between all the different inputs of the display.
- 5. This button turns the display on or off.






