
# **SAFETY INSTRUCTIONS**





The SCEPTRE display is packaged in a carton. The size and weight of the product might be too heavy for 1 person to handle. In the event of that happening, it is recommended that the display package must be handled by a minimum of 2 or more persons. Since the glass can be easily scratched or broken, please handle the product gently. Never place the unit on a surface with the glass facing downwards unless it is on protective padding. When opening the carton, check that the product is in good condition and that all standard accessories and items are included. Save the original box and all packing materials for future shipping needs.

# Installation

Please read the user manual carefully before performing the installation. Please use the AC Adapter designated for the product. When an extension cord is required, use one with the correct power rating. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. If you would like to mount the display onto the wall, please be sure to read all instructions provided by the display mounting company and this manual. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and successive component damage.

# **Assembling the Stand**

1. Clear the table. Obtain the display base and set it flat on a table. Obtain the display neck and insert the display neck into the display base, clockwise rotation until you hear a light click.



 Obtain the display and lay it flat on a table with the screen side facing downwards. Slide the neck + base display stand assembly into the indentation on the lower back of the monitor.

- 3. To finalize your installation of the display, please read the following:

    - ii. Make sure the wall mount kit is compatible with the display.
    - iii. Read and follow all instructions provided by the wall mounting kit.
    - iv. Securely install all screws and connections.

## **Front View**




## **Rear View Mounting Pattern**




Mounting Specification: **100mm x 100mm** using screw size **M4.** Length of screw should not exceed **14mm**. Please Note: The **14mm** length of screw refers to how deep the screw can go inside the mounting holes. When you are buying screws, please be aware of the screw depth of the monitor VESA Wall Mount.

## **Rear Control Buttons**



- 1. **M** This button activates the On-Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
- 2. ▲ With no OSD, this button this button will also increase the volume of the internal speaker. With the OSD turned on, this button moves the selection upwards.
- 3. ▼– With no OSD, this button will also decrease the volume of the internal speaker. With the OSD turned on, this button moves the selection downwards.
- E When the OSD is active, this button acts as the EXIT button and exits out of the option or OSD. This button switches between all the different inputs of the display.
- 5.  $\mathbf{U}$  This button turns the display on or off.

## **Rear View Connections**



- 1. **HDMI 2** HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video output.
- 2. **HDMI 1** HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video output.
- VGA VGA stands for Video Graphics Array. This connection is for computers to send video signals to the monitor by an analog signal.
- 4. **AUDIO IN** This connection is for audio in from the computer going into the monitor. This connection is used with VGA.
- 5. **AUDIO OUT** This connection is for connecting to 3.5mm mini-jack headphones or audio out to multimedia speakers.
- 6. **DC IN** This connection is for electricity supplied from the included power adapter.

# Connections

## If You have HDMI Connection on Your Video Card...




- 1. Make sure the power of the E27 LED MONITOR is turned off.
- 2. Obtain a HDMI cable and connect one end to the back of the monitor and the other end to the back of the computer.
- 3. Turn on the power of both the E27 LED MONITOR and the computer.

Please Note:

• Make sure to set audio output from your computer to PCM output.

## If You have VGA Connection on Your Video Card...



- 1. Make sure the power of E27 LED MONITOR is turned off.
- 2. If you were previously using a CRT (bulky) monitor, please hook up your old monitor first and make sure your refresh rate is set to 75 Hz frequency before using the E27 LED MONITOR. You can find the refresh rate information and change it by RIGHT CLICKING on the desktop with nothing selected. After you have right clicked, select the PROPERTIES option. Click on the SETTINGS tab. Click on the ADVANCED button. Click on the MONITOR tab. In that tab, change the refresh rate to 75 Hz and click on APPLY. After the refresh rate changed, please shut down the computer and monitor.
- Obtain the VGA cable and connect to the VGA connection on your PC. Connect the other end of the cable to your E27 LED MONITOR.
- 4. Turn on the power of both the E27 LED MONITOR and the PC.

Please Note:

- The PC's clearest picture is ran with 1920 x 1080 at 75Hz.
- If the VGA port receives no signal for over 1 hour, the monitor will auto shutoff.

## **On Screen Display (OSD) Menu**

The OSD menu of the monitor provides various adjustments for the monitor such as color, brightness, and contrast .....etc.



When you press the **M** button on the monitor, the OSD screen will appear. Select each of the functions with the  $\triangledown$  or  $\blacktriangle$  buttons. Use the **M** button again to enter each of the function or when you are in the function already, use the **M** button to select the option you want to adjust. Use the  $\triangledown$  or  $\bigstar$  buttons to adjust each option's values. When you want to exit press the **E** button.
