The purpose of this agreement is for evaluation of product(s).

IN CONSIDERATION OF DEPOSIT, SCEPTRE INC, HEREBY AGREES TO SHIP EVALUATION PRODUCT(S) UNDER THE FOLLOWING TERMS AND CONDITIONS:

- 1. Term:**
 - a. The term of loan shall be fifteen (15) days from the date of original invoice.**
- 2. Conditions:**
 - a. All unit(s) must be returned in "new" condition and in the original package as provided by Sceptre. Any damage caused by Customer will constitute forfeiture of the full deposit held by Sceptre.
 - b. Should Customer keep the loaned product(s) longer than fifteen (15) days, Sceptre shall assume the unit(s) as "sold" and the Customer will be charged accordingly.
 - c. If any product(s) delivered to Customer, by Sceptre, is/are found to be defective and/or damaged upon delivery, Sceptre must be notified within 48 (forty-eight) hours of receipt.
 - d. Customer agrees to provide a deposit in an amount equal to the current market value at the time the evaluation product(s) is invoiced, via cash or credit card (Visa or MC), and until such time as Sceptre receives the evaluation unit back in the condition time frame defined supra.
 - e. Should Customer keep any product(s) longer than the allowed time, a restocking and compensation of depreciation fee may be charged at the full discretion of the Sceptre.
 - f. Customer agrees to return any / all loaned product(s) back to Sceptre's designated warehouse at 16800 E. Gale Ave., City of Industry, Ca 91745, freight pre-paid.
- 3. Risk of Loss:** All units are provided to borrower FOB Sceptre's warehouse, Los Angeles, California. I.e., for any equipment or property that is in transport to, from, or in possession of, Borrower, Borrower agrees to assume all "risk of loss" for said equipment or property. Further, Borrower agrees to indemnify Owner for any loss or damage caused to any equipment or property that occurs while in Borrower "possession" as described herein.
