SAFETY INSTRUCTIONS

Opening the Package

The SCEPTRE display is packaged in a carton. The size and weight of the product might be too heavy for 1 person to handle. In the event of that happening; it is recommended that the display package must be handled by a minimum of 2 or more persons. Since the glass can be easily scratched or broken, please handle the product gently. Never place the unit on a surface with the glass facing downwards unless it is on protective padding. When opening the carton, check that the product is in good condition and that all standard accessories and items are included. Save the original box and all packing materials for future shipping needs.

Installation

Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and successive component damage.

Assembling the Stand

1. Obtain the base and the neck of the monitor. Insert the neck onto the base. Afterwards, secure the installation by inserting and tightening in the 2 base screws from the bottom of the base.



2. Insert the red triangle accent into the base for better looks.



3. With the monitor still lying in the package foam, lay the foam + monitor down on a table with the display facing downwards. Open up the top foam exposing the back. Insert the constructed stand piece into the opening on the back of the monitor. Insert and tighten a screw to the back of the stand.



4. Insert the display neck rubber cover into the opening on the display neck.



5. Install the display connection plastic cover to the lower part of the display.



6. To finalize your installation of the display, please read the following:
 - a. If you are placing the display on a stand, we would recommend you to use a display safety strap (not included) in order to minimize the possibility of the display toppling over.
 - b. If you are mounting the display on the wall
 - a. Make sure the wall is structurally safe for the weight of the display
 - b. Make sure the wall mount kit is compatible with the display
 - c. Read and follow all instructions provided by the wall mounting kit.
 - d. Securely install all screws and connections.

Preparing For Wall Mounting

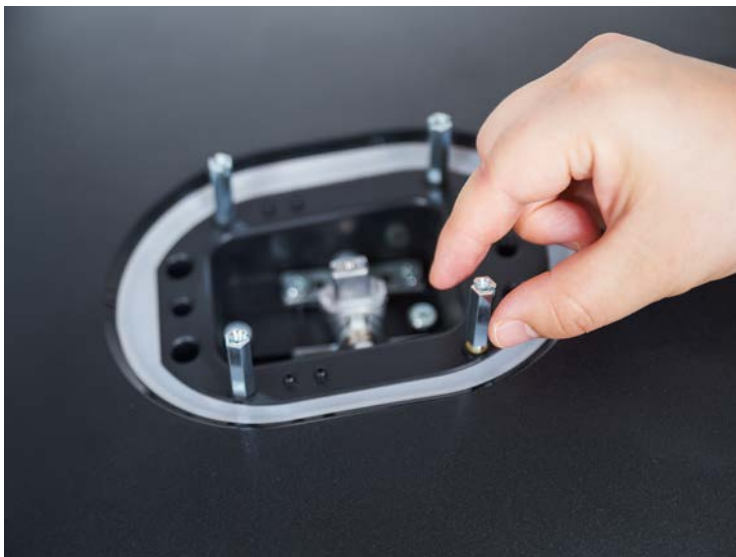
1. Remove the stand by laying the display with the screen portion facing down. Open the cover on the back of the neck and unscrew the neck from the back of the display.



2. Take out the stand piece.
3. To disassembly the stand itself, unscrew the screws from the bottom of the base. The neck can now be removed.
4. Use a finger to hook and pull out the back plate.



5. Insert and screw in the 2 longer wall mount spacers for the top 2 holes and the 2 shorter wall mount spacers for the bottom 2 holes.



6. Once all 4 spacers are installed the display is ready to be mounted. The mounting specification of the display is **75mm x 75mm using M4 screws at 8mm length**.

Identifying Front and Rear Panel

Front View



Indicator Light – The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

Panel Tilt Adjustment

The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the specific model of the device. Generally, it may be inclined $3\pm2^\circ$ forward and $15\pm2^\circ$ backward with a combined angle of $18\pm4^\circ$.

Please Note:

- When adjust the angle of the monitor, be sure not to touch or press the LCD screen.

Rear View Mounting Pattern



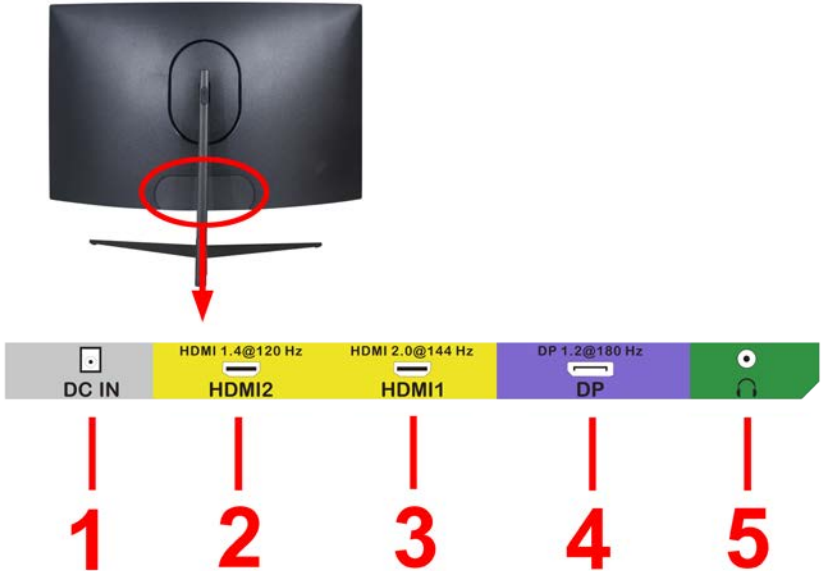
Mounting Specification: **75mm x 75mm** using screw size **M4**. Length of screw should not exceed 8mm. Please Note: The **8mm** length of screw refers to how deep the screw can go inside the mounting holes. When you're buying screws, you should add the original 8mm to the thickness of your mounting plate in order to get the total screw length.

Rear View with Buttons



1. **M (MENU)** – This button activates the On Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
2. **▼** – This button moves the selection down while the OSD is active. This button will also decrease the value of an adjustment while an option is open. When the OSD is not active, this button decreases the volume of the speakers.
3. **▲** – This button moves the selection up while the OSD is active. This button will also increase the value of an adjustment while an option is open. When the OSD is not active, this button increases the volume of the speakers.
4. **E (EXIT)** – This button switches between all the different inputs of the display. When the OSD is active, this button acts as the EXIT button and exits out of the option or OSD.
5. **POWER** – This button turns the display on or off.

Rear View with Connections



1. **POWER** – This plug is responsible for providing power to the monitor. Use it with the included AC adapter.
2. **HDMI 2** – HDMI stands for High Definition Multimedia Interface. This connection is for computers with HDMI video output. This HDMI is version 1.4 with refresh rate up to 120Hz.
3. **HDMI 1** – HDMI stands for High Definition Multimedia Interface. This connection is for computers with HDMI video output. This HDMI is version 2.0 with refresh rate up to 144Hz.
4. **DISPLAY PORT** – Display port is a digital video connection for connection to computers with display port video output.
5. **AUDIO OUT (3.5mm Mini-jack)** – This connection is for audio out from the monitor to multimedia speakers or headphones.

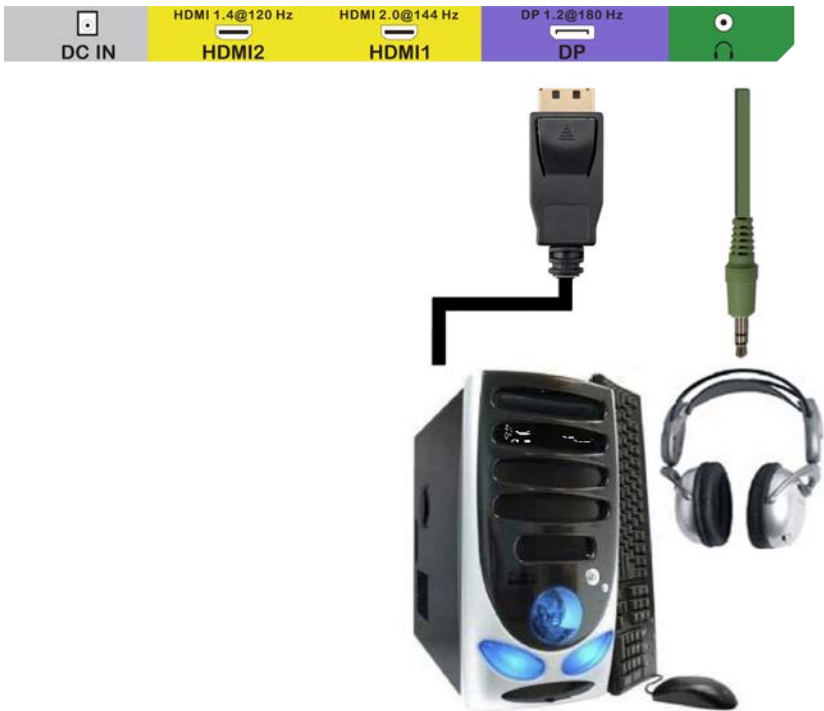


1. Make sure the power of the C24 LED MONITOR is turned off.
2. Obtain a HDMI cable and connect one end to the back of the monitor and the other end to the back of the computer.
3. The monitor supports Audio passthrough through the 3.5mm Audio Out Jack. To use, connect the auxiliary 3.5mm audio jack from your speaker or headphone to the C24 LED MONITOR's audio out.
4. Turn on the power of both the C24 LED MONITOR and the computer.

- Make sure to set audio output from your computer to PCM output.

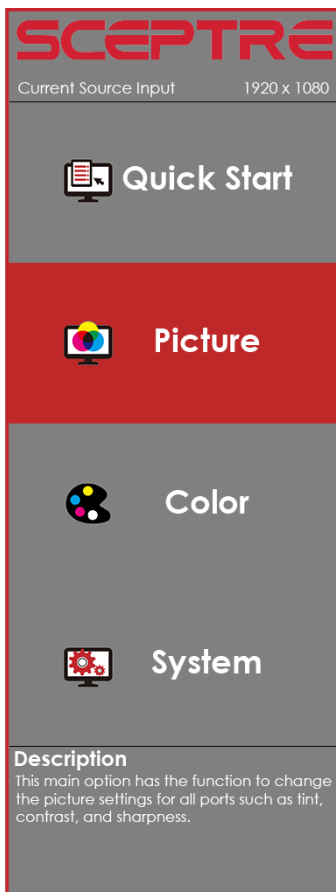

On Screen Display (OSD) Menu

The OSD menu of the monitor provides various adjustments for the monitor such as color, brightness, and contrastetc.



When you press the **M** button on the monitor, the OSD screen will appear. Select each of the functions with the **▲** or **▼** buttons. Use the **M** button again to enter each of the function or when you're in the function already, use the **M** button to select the option you want to adjust. Use the **▲** or **▼** buttons to adjust each option's values. When you want to exit press the **E** button.

1. **TEMPERATURE** – This option let users select different color temperatures of the monitor.
 - a. **NORMAL** – This color temperature is for users who prefer a neutral white balance.
 - b. **COOL** – This color temperature is for users who prefer a cool white balance.
 - c. **USER** – This color temperature is for users who would like to adjust the RGB (red, green, blue) values manually.
 - i. **ADVANCED** – This setting adjusts finer values besides RGB going into cyan, magenta, and yellow.

1. **OVERDRIVE** – This option increases the pixel response time of the LED screen.
2. **Freesync™ PREMIUM** – This option enables syncing with variable frequency with AMD video cards.
3. **SLEEP MODE** – With the monitor given no video signal, enabling this option will make the monitor automatically shut off after 30 minutes, 60 minutes, or 2 hours.
4. **BACKCOVER LIGHT** – Turns on or off the Backcover Light of the monitor.
5. **LANGUAGE** – This option allows users to change the menu language of the monitor.
6. **OSD H POSITION** – This option adjusts the placement of the OSD menu horizontally.
7. **OSD TIMER** – This option adjusts the time it takes for the OSD menu to automatically shut off.

How do I clean the LED Monitor?
