


# Installation

Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and successive component damage.

# **Installing the Monitor Stand Assembly**

 Lay the monitor screen facing down on a table and install the neck to the back of the monitor. Secure the installation by inserting and tightening the two neck screws.






2. Install the base to the bottom of the neck and screw the installation by screwing in the 2 base screws provided.



- 3. To finalize your installation of the display, please read the following:

  - b. Securely install all screws and connections.

# **Removing the Stand for Wall Mounting**

 To uninstall the stand assembly, lay the monitor facing downwards on a table. Look for the two screws between the joint where the neck and the monitor meets. Remove the screws and the stand assembly can be pulled off.



Once the stand is removed, you will see the indentation with 4 holes. You can
mount the monitor by installing the 4 spacers first then using M4 screws at
12mm length.

#### **Front View**



**Indicator Light** – The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.


# **Panel Tilt Adjustment**

The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the specific model of the device. Generally, it may be inclined 3±2° forward and 15±2° backward with a combined angle of 18±4°.


 When adjust the angle of the monitor, be sure not to touch or press the LCD screen.

#### Rear View with Buttons

- 5. U This button turns the display on or off.



### How do I clean the LED Monitor?

#### **IMPORTANT**

- 1. The power cable has to be removed from the socket before cleaning the display.
