The SCEPTRE display is packaged in a carton. The size and weight of the product might be too heavy for 1 person to handle. In the event of that happening, it is recommended that the display package must be handled by a minimum of 2 or more persons. Since the glass can be easily scratched or broken, please handle the product gently. Never place the unit on a surface with the glass facing downwards unless it is on protective padding. When opening the carton, check that the product is in good condition and that all standard accessories and items are included. Save the original box and all packing materials for future shipping needs.

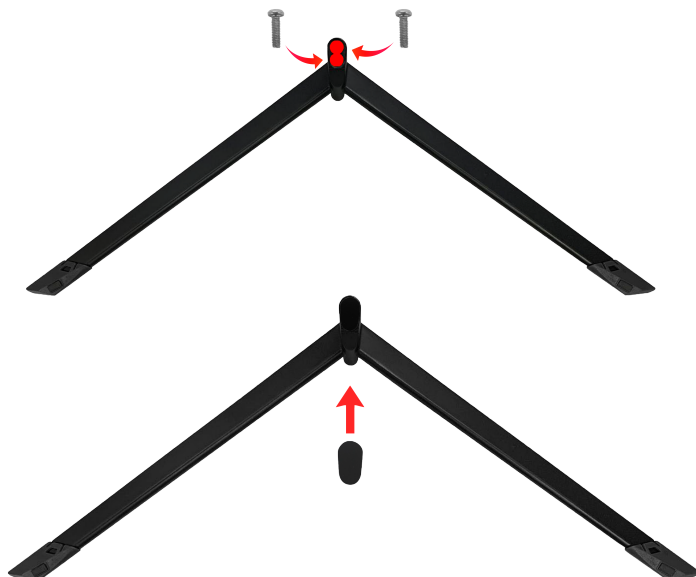

Installation

Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and successive component damage.

Assembling the Stand

1. Obtain the base and the neck of the monitor. Insert the neck onto the base. Afterwards, secure the installation by screwing in the base screws from the bottom of the base. After, use the rubber feet provided to seal the bottom hole where the base screws are located.



2. Insert the red triangle accent into the base for better looks.



3. Open the packing foam with the monitor resting facing downwards. Take the assembled stand piece and insert it headfirst into the square opening on the back of the monitor.



4. To finalize your installation of the display, please read the following:
 - a. If you are placing the display on a stand, we would recommend you to use a display safety strap (not included) in order to minimize the possibility of the display toppling over.
 - b. If you are mounting the display on the wall
 - a. Make sure the wall is structurally safe for the weight of the display
 - b. Make sure the wall mount kit is compatible with the display
 - c. Read and follow all instructions provided by the wall mounting kit.
 - d. Securely install all screws and connections.

Preparing For Wall Mounting

1. To prep the monitor for wall mounting, remove the back plate by pushing up on the lever near the neck joint with the monitor and lifting the stand piece upwards. Once the stand is lifted upwards you can slide out the entire stand assembly.



2. With the indentation now open to you, you will see 4 screws installed on the back of the monitor. Please unscrew them.
3. Once all 4 spacers are installed the display is ready to be mounted. The mounting specification of the display is **75mm x 75mm using M4 screws at 26mm length**.

Identifying Front and Rear Panel

Front View



Indicator Light – The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

Panel Tilt Adjustment

The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the specific model of the device. Generally, it may be inclined $3\pm 2^\circ$ forward and $15\pm 2^\circ$ backward with a combined angle of $18\pm 4^\circ$.

Please Note:

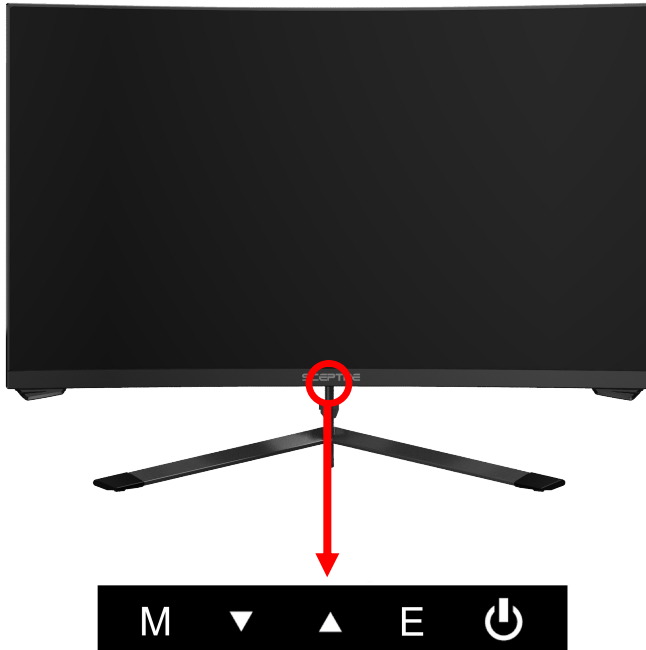
- When adjust the angle of the monitor, be sure not to touch or press the LCD screen.

Rear View Mounting Pattern



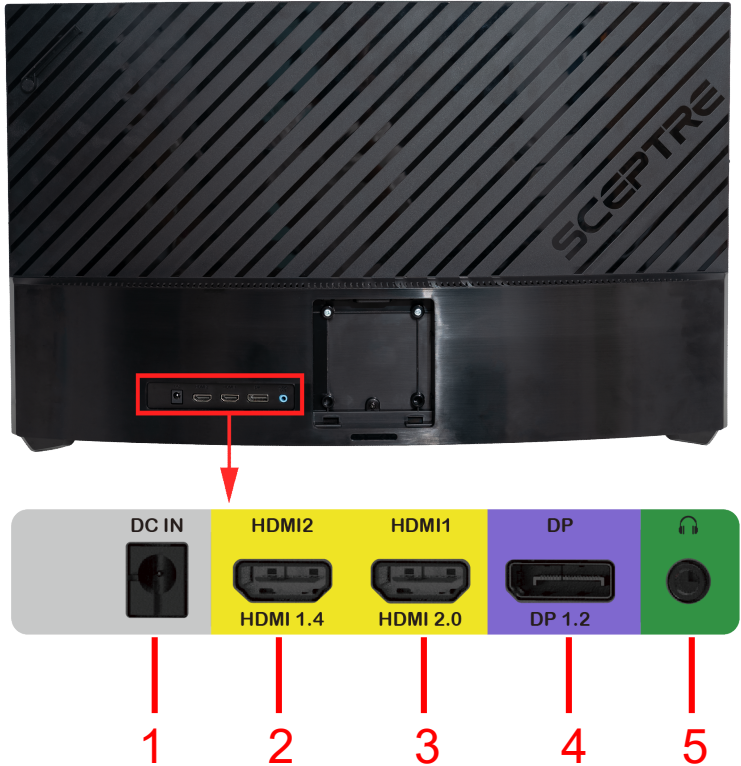
Mounting Specification: **75mm x 75mm** using screw size **M4**. Length of screw should not exceed 8mm. Please Note: The **8mm** length of screw refers to how deep the screw can go inside the mounting holes. When you're buying screws, you should add the original 8mm to the thickness of your mounting plate in order to get the total screw length.

Rear View with Buttons



1. **M (MENU)** – This button activates the On-Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
2. **▼** – This button moves the selection down while the OSD is active. This button will also decrease the value of an adjustment while an option is open. When the OSD is not active, this button decreases the volume of the speakers.
3. **▲** – This button moves the selection up while the OSD is active. This button will also increase the value of an adjustment while an option is open. When the OSD is not active, this button increases the volume of the speakers.
4. **E (EXIT)** – This button switches between all the different inputs of the display. When the OSD is active, this button acts as the EXIT button and exits out of the option or OSD.
5. **POWER** – This button turns the display on or off.

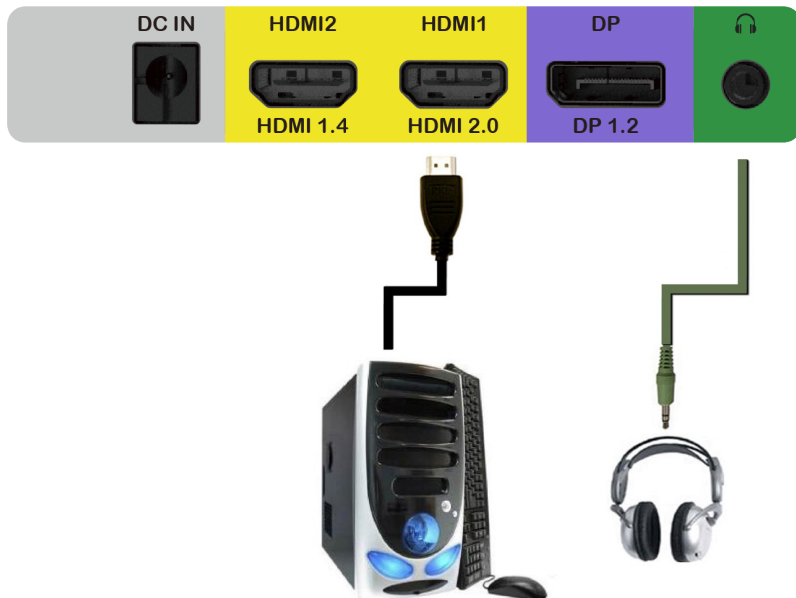
Rear View with Connections



1. **POWER** – This plug is responsible for providing power to the monitor.
2. **HDMI 2** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video output. This HDMI is version 1.4 with refresh rate up to 144Hz.
3. **HDMI 1** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video output. This HDMI is version 2.0 with refresh rate up to 165Hz.
4. **DISPLAY PORT** – Display port is a digital video connection for connection to computers with display port video output.
5. **AUDIO OUT (3.5mm Mini-jack)** – This connection is for audio out from the monitor to multimedia speakers or headphones.

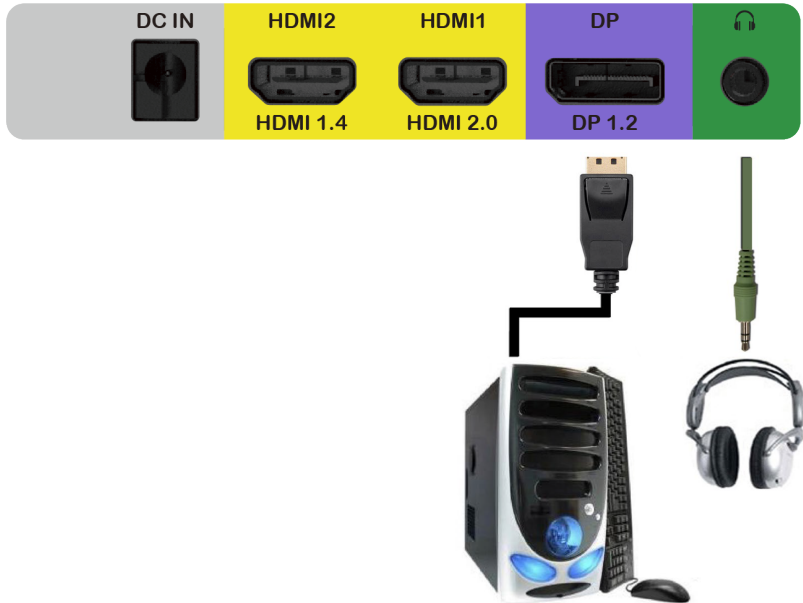


1. Make sure the power of the C27 LED MONITOR is turned off.
2. Obtain a HDMI cable and connect one end to the back of the monitor and the other end to the back of the computer.
3. The monitor supports Audio passthrough through the 3.5mm Audio Out Jack. To use, connect the auxiliary 3.5mm audio jack from your speaker or headphone to the C27 LED MONITOR's audio out.
4. Turn on the power of both the C27 LED MONITOR and the computer.

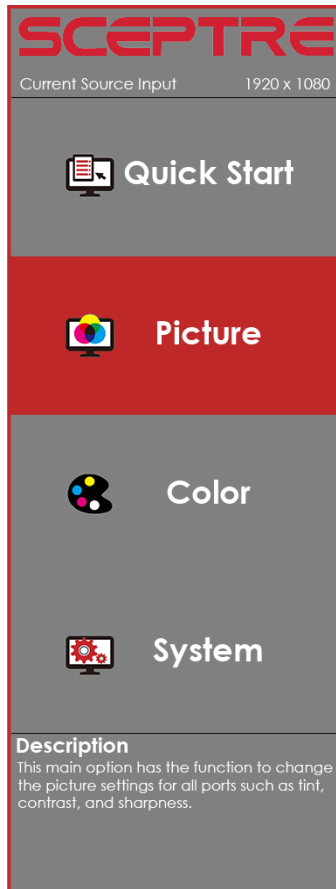



1. **TEMPERATURE** – This option let users select different color temperatures of the monitor.
 - a. **NORMAL** – This color temperature is for users who prefer a neutral white balance.

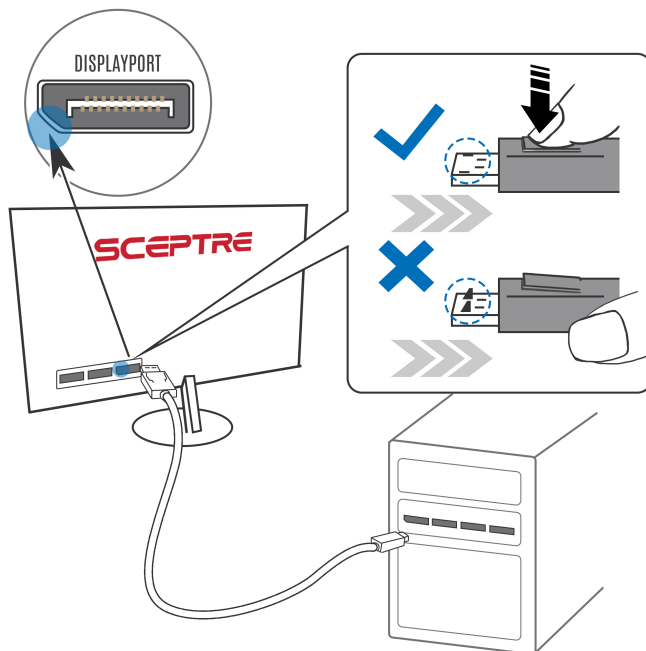

THERE IS NO LED DISPLAY or SCREEN SAYS NO SIGNAL	<p>Make sure you switched to the correct source. Check both sources to see video is on the other source. Check your video cable. It might be corrupt. Swap out the video cable for another one to see if the monitor will work. Check your power plug. See if it is fully plugged in on both the monitor and the wall.</p>
MONITOR SAYS "SIGNAL OUT OF RANGE"	<p>If you have a CRT monitor, please connect the CRT monitor to the computer and change the refresh rate down to 60 Hz via your video card's display settings menu. After the setting of 60 Hz has been change you can then use the LED on the computer.</p> <ol style="list-style-type: none"> 1. To change the setting go to display settings by right clicking on your desktop with nothing selected. Choose the PROPERTIES option. 2. Click on the SETTINGS tab, verify the resolution is NOT higher than 1920 x 1080, and click on the ADVANCED button. 3. Click on the MONITOR tab and change the refresh rate to 60 Hz. 4. Click on OK 2-3 times to finalize your change. <p>If you do NOT have a CRT monitor or it's already broken, please make sure both the C27 LED monitor and your computer is turned off.</p> <ol style="list-style-type: none"> 1. How do I detach the DisplayPort Cable?

To detach the DP cable from the monitor, press down on the cables unlocking button while pulling the cable out.



How do I clean the LED Monitor?

IMPORTANT

1. The power cable has to be removed from the socket before cleaning the display.
2. Do not use volatile solvent (alcohol, rosin, and toluene) to clean the display. These types of chemicals might damage the housing and the LCD glass.

Cleaning the bezel

1. Use a 100% cotton cloth or micro-fiber cloth for cleaning.
2. If the bezel is dirty to the point where you cannot simply dry wipe it, please lightly dampen the wiping material with clean water and wipe again. Wipe the display with a dry micro-fiber cloth or 100% cotton cloth afterwards.

Please Note:

- Make sure you wring the water out of the cloth before cleaning the bezel in order to prevent water from penetrating into the electronics.

Cleaning the Screen
