

4. Once the wall mount plate is installed, the monitor is ready to be wall mounted. The mounting pattern is 75mm x 75mm using M4 x 8mm screws.




Panel Tilt Adjustment



How do I detach the DisplayPort Cable?

To detach the DP cable from the monitor, press down on the cables unlocking button while pulling the cable out.
