# IMPORTANT INFORMATION

This product is designed and manufactured to operate within defined design limits, and misuse may result in electric shock or fire. - To avoid the risk of electric shock or component damage, switch off the power before connecting other components to the display.
- Unplug the power cord before cleaning the display. Please use a microfiber cleaning cloth for cleaning the bezel of the display only. Do not use a liquid or a spray cleaner for cleaning the product. Do not use abrasive cleaners.

## Installation

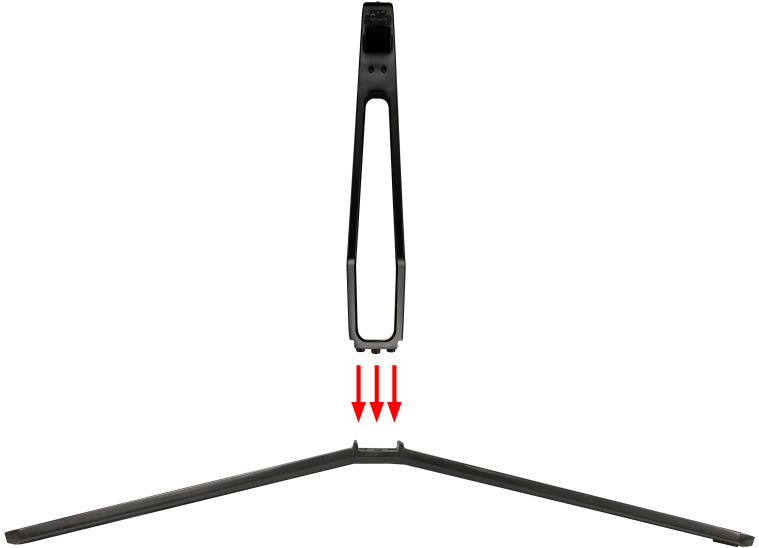

Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. Use only the Sceptre provided power cable or power adapter approved for use with this device. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and successive component damage.

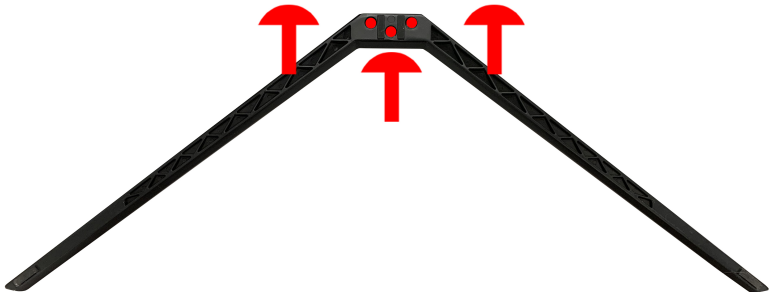
## Installing the Monitor Stand Assembly

---

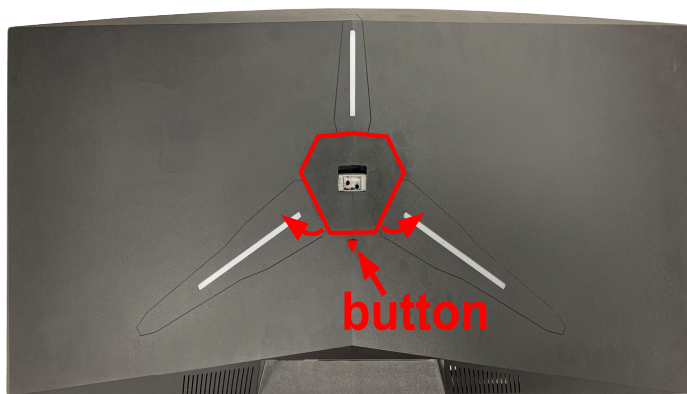
1. Take the monitor out of the box. Lay the monitor screen facing down on a table with the monitor still resting on the packing foam. Obtain the display neck and attach it to the display neck.



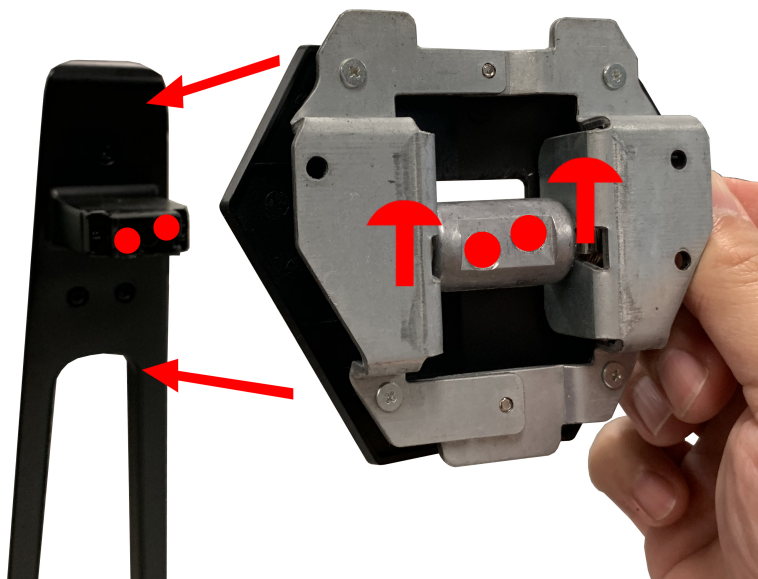
2. While the neck is attached to the base, insert, and tighten 3 base screws to the bottom of the base.



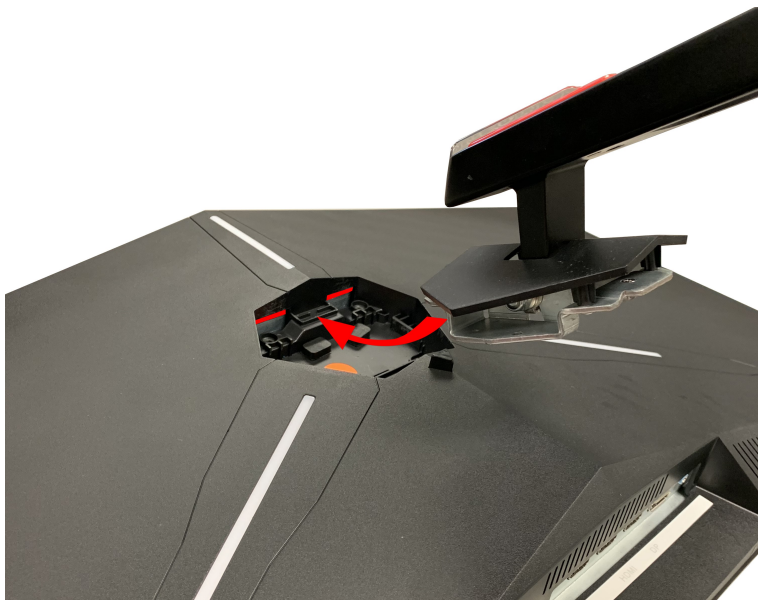
3. Locate the button on the back of the display. Push the button and lift the back plate off the display.



4. Insert the back plate to the neck + base (stand) assembly and secure the neck plate by inserting and tightening 2 neck screws.



5. Insert the stand + back plate into the back of the display with the back plate's top end going in first.



6. Once the back plate's top end goes in push down on the bottom end to secure the stand into the monitor.



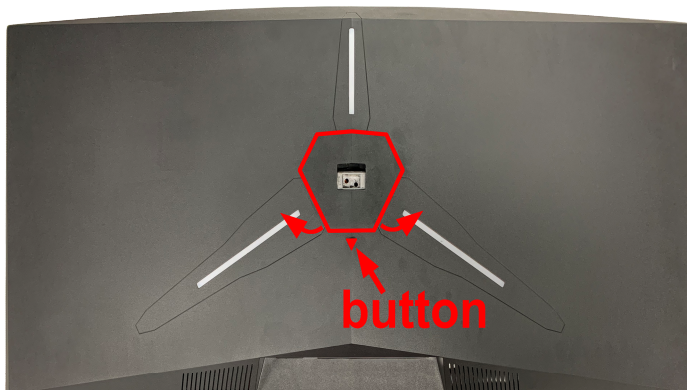
7. To finalize your installation of the display, please read the following:
  - a. If you are placing the display on a stand, we would recommend you to use a display safety strap (not included) in order to minimize the possibility of the display toppling over.
  - b. Securely install all screws and connections.



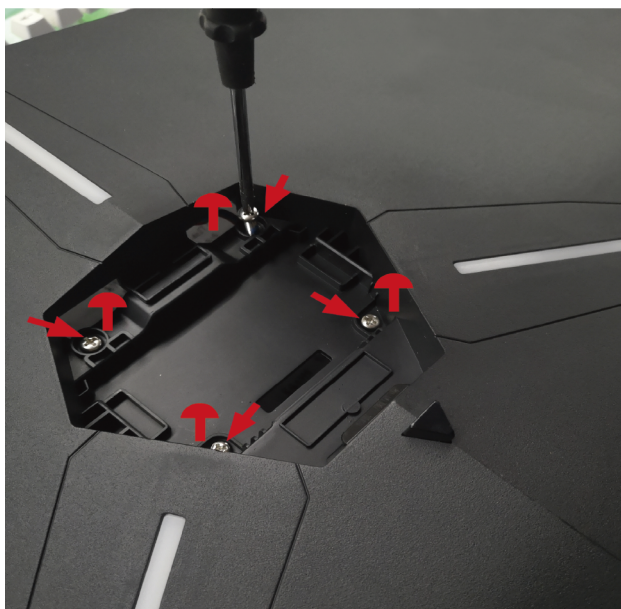
## Wall Mounting

---

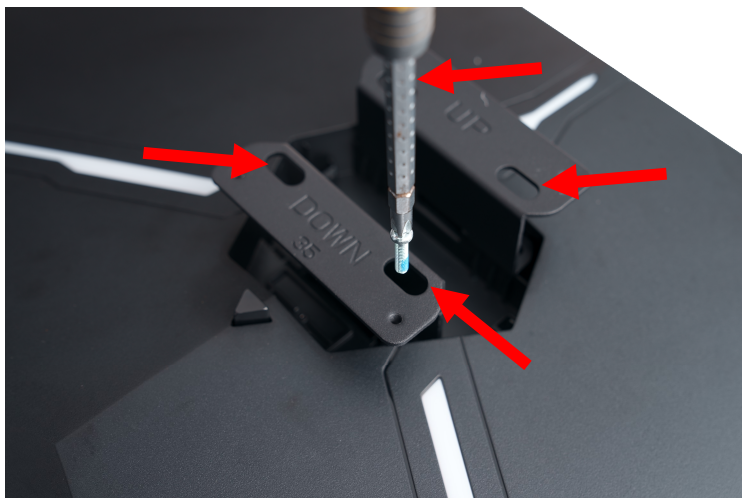
1. To prep the monitor for wall mounting, lay the monitor screen facing down on a table with the monitor still resting on the packing foam. Remove the back plate by pressing down on the triangular button near the bottom of the back plate and lifting the back plate upwards.



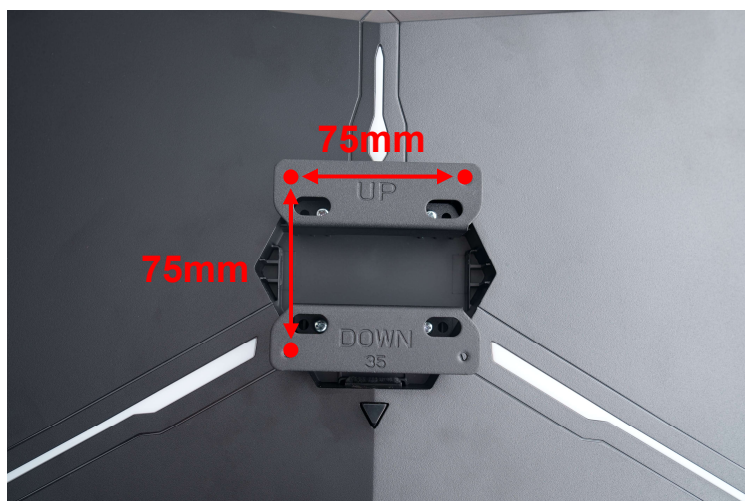
2. Remove the original screws from the opening in the back of the monitor. Please save these screws for Step 4.



- Through the indentation, you will see 4 holes. Place the wall-hanging plate on the bottom and fix the wall-hanging plate by tightening 4 wall-hanging screws to the plate.



- Once the wall mount plate is installed, the monitor is ready to be wall mounted. **The mounting pattern is 75mm x 75mm using M4 x 8mm screws.**

# Identifying Front and Rear Panel

---

## Front View



**Indicator Light** – The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

## Panel Tilt Adjustment

The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the specific model of the device. Generally, it may be inclined  $5\pm1^\circ$  forward and  $15\pm2^\circ$  backward.

Please Note:

- When adjust the angle of the monitor, be sure not to touch or press the LCD screen.

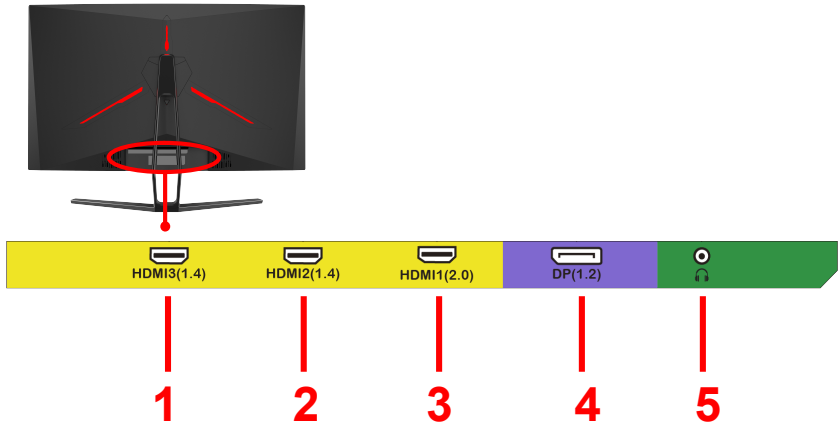
## Front View with Buttons



### Buttons from right to left

1. **M** – This button activates the On-Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
2. **▼** – With no OSD, this button opens the Volume OSD and decreases the monitor's volume output. With the OSD turned on, this button moves the selection downwards. This button will also decrease the value of an adjustment while an option is open.
3. **▲** – With no OSD, this button opens the Volume OSD and increases the monitor's volume output. With the OSD turned on, this button moves the selection upwards. This button will also increase the value of an adjustment while an option is open.
4. **E** – When the OSD is active, this button acts as the EXIT button and exits out of the option or OSD. This button switches between all the different inputs of the display.
5. **⏻** – This button turns the display on or off.

## Rear View with Connections



1. **HDMI 3** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video output. HDMI supports adaptive sync, a feature that eliminates picture tearing and stuttering. HDMI 3 is HDMI 1.4.
2. **HDMI 2** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video output. HDMI supports adaptive sync, a feature that eliminates picture tearing and stuttering. HDMI 2 is HDMI 1.4.
3. **HDMI 1** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video output. HDMI supports adaptive sync, a feature that eliminates picture tearing and stuttering. HDMI 1 is HDMI 2.0.
4. **DP** – DisplayPort (DP) is a digital video connection for connection to computers with display port video output.
5. **AUDIO OUT (3.5mm Mini-jack)** – This connection is for audio out from the monitor to multimedia speakers or headphones.

Please Note:

- HDMI2.0 at native resolution 1920 x 1080 will support 240Hz.
- HDMI1.4 at native resolution 1920 x 1080 will support 120Hz.
- DP at native resolution 1920 x 1080 will support 240Hz.
- To remove the DP cable from the monitor, you need to depress the buckle on the cable while unplugging.

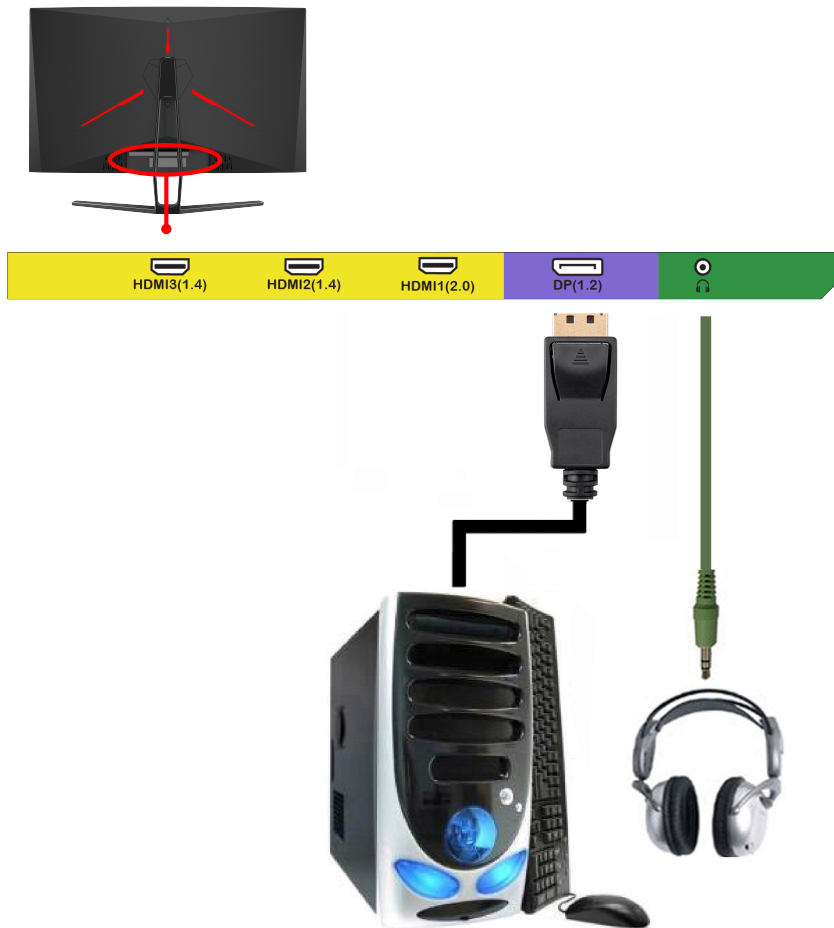


1. Make sure the power of the C32 LED MONITOR is turned off.
2. Obtain a HDMI cable and connect one end to the back of the monitor and the other end to the back of the computer.
3. Turn on the power of both the C32 LED MONITOR and the computer.

Please Note:

- HDMI2.0 supports up to 240Hz refresh rate.
- HDMI1.4 supports up to 120Hz refresh rate.

## If You have DisplayPort Connection on Your Video Card...



1. Make sure the power of the C32 LED MONITOR is turned off.
2. Obtain a DisplayPort cable and connect one end to the back of the monitor and the other end to the back of the computer.
3. Turn on the power of both the C32 LED MONITOR and the computer.

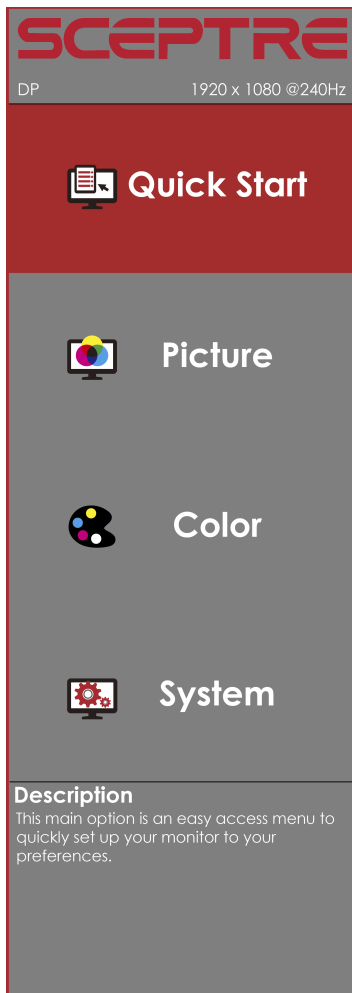

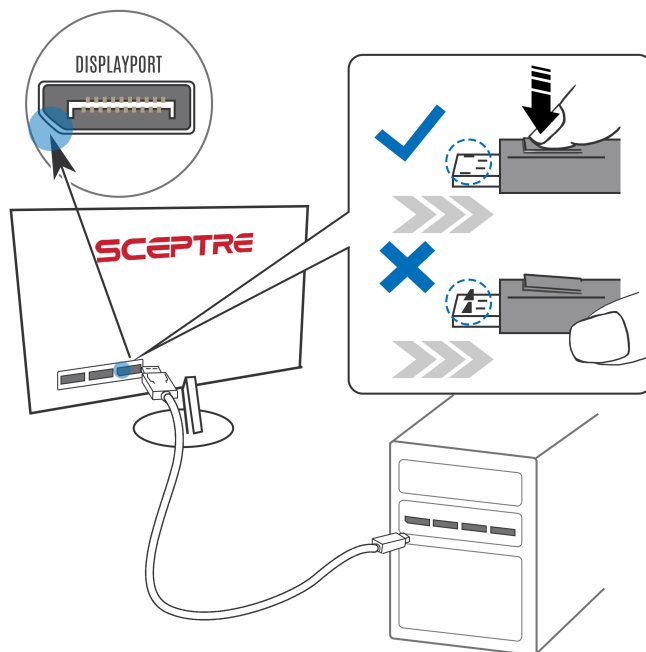

## How do I detach the DisplayPort Cable?

---

To detach the DP cable from the monitor, press down on the cables unlocking button while pulling the cable out.



## How do I clean the monitor?

---

### IMPORTANT

1. The power cable has to be removed from the socket before cleaning the display.
2. Do not use volatile solvent (alcohol, rosin, and toluene) to clean the display. These types of chemicals might damage the housing and the LCD glass.

### Cleaning the bezel

1. Use a 100% cotton cloth or micro-fiber cloth for cleaning.
2. If the bezel is dirty to the point where you cannot simply dry wipe it, please lightly dampen the wiping material with clean water and wipe again. Wipe the display with a dry micro-fiber cloth or 100% cotton cloth afterwards.

#### Please Note:

- Make sure you wring the water out of the cloth before cleaning the bezel in order to prevent water from penetrating into the electronics.

### Cleaning the Screen

1. Use a 100% cotton cloth or micro-fiber cloth for cleaning.
2. The LCD screen glass is extremely fragile. Do not scrape it with any material. Do not press or tap the screen to avoid cracking. When the screen is dirty to the point where you cannot simply dry wipe it, please lightly dampen the wiping material with clean water and wipe again. Wipe the display with a dry micro-fiber cloth or 100% cotton cloth afterwards.
