The SCEPTRE display is packaged in a carton. The size and weight of the product might be too heavy for 1 person to handle. In the event of that happening; it is recommended that the display package must be handled by a minimum of 2 or more persons. Since the glass can be easily scratched or broken, please handle the product gently. Never place the unit on a surface with the glass facing downwards unless it is on protective padding. When opening the carton, check that the product is in good condition and that all standard accessories and items are included. 

#### Installation


Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and successive component damage.

# **Installing the Monitor Stand Assembly**

1. Insert the monitor neck onto the base and secure the installation by tightening 3 screws (M4\*12mm) to the bottom of the base.



2. Make sure the top of the neck plate with the two protruding metallic ears faces upwards. Install the neck plate onto the top of the neck and secure the installation by tightening 2 screws (M4\*8.5mm) to the neck plate.



3. Take the monitor display and lay it flat on a table. Insert the stand to the back of the monitor by inserting the neck plate area to the back of the monitor at an angle. Match the two metallic ears into the back of the monitor first then close downwards until you hear a clicking sound.





- 1. To finalize your installation of the display, please read the following:
  - a. If you are placing the display on a stand, we would recommend you to use a display safety strap (not included) in order to minimize the possibility of the display toppling over.
  - b. Securely install all screws and connections.

# **Removing the Stand for Wall Mounting**

To uninstall the stand assembly, lay the monitor facing downwards on a table.
 Press the button on the back of the monitor located near the monitor's neck plate
 and while holding the button down lift the stand assembly up.



Once the stand is removed, you will see the indentation with 4 holes. You can mount the monitor using M4 screws at 30mm length.


# **Identifying Front and Rear Panel**

#### **Front View with Buttons**



- 1. This button activates the On Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
- 2. ▲ ¬With no OSD, this button cycles between PRESET modes. With the OSD turned on, this button moves the selection upwards. This button will also increase the value of an adjustment while an option is open.
- 3. ▼ -With no OSD, this button activates a permanent crosshair for first person shooting games. With the OSD turned on, this button moves the selection downwards. This button will also decrease the value of an adjustment while an option is open.
- 4. S—When the OSD is active, this button acts as the EXIT button and exits out of the option or OSD. This button switches between all the different inputs of the display.
- 5. U -This button turns the display on or off.

#### **Rear View with Connections**



- DVI -DVI stands for Digital Video Interface. This connection is for computers with DVI video output.
- HDMI HDMI stands for High Definition Multimedia Interface. This
  connection is for computers with HDMI video output.
- 3. **DP** –Display port is a digital video connection for connection to computers with display port video output
- Audio Out This port is for sending audio signal out to a headphone or speaker when there is audio signal sent to the monitor using HDMI or DisplayPort cables.

#### **WARNING:**

 When using display port or HDMI port, please take note that this monitor is not equipped with built in speakers.

#### **Panel Tilt Adjustment**




The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the specific model of the device. Generally, it may be inclined  $5\pm 2$  forward and  $15\pm 2$  backward with a combined angle of  $15\pm 4$ .

#### Please Note:

 When adjust the angle of the monitor, be sure not to touch or press the LCD screen.


