SAFETY INSTRUCTIONS

This product is designed and manufactured to operate within defined design limits, and misuse may result in electric shock or fire. To prevent the product from being damaged, the following rules should be observed for the installation, use and maintenance of the product. Read the following safety instructions before operating the display. Keep these instructions in a safe place for future reference.

- To avoid the risk of electric shock or component damage, switch off the power before connecting other components to the display.

Opening the Package

The SCEPTRE display is packaged in a carton. The size and weight of the product might be too heavy for 1 person to handle. In the event of that happening; it is recommended that the display package must be handled by a minimum of 2 or more persons. Since the glass can be easily scratched or broken, please handle the product gently. Never place the unit on a surface with the glass facing downwards unless it is on protective padding. When opening the carton, check that the product is in good condition and that all standard accessories and items are included. Save the original box and all packing materials for future shipping needs.

Installation

Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. Use only the Sceptre provided power cable or AC adapter approved for use with this device. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and successive component damage.

Installing the Monitor Stand Assembly

1. Take the monitor with packing foam out of the box. Lay the monitor screen facing down on a table with the monitor still resting on the packing foam. Obtain the display base and attach it to the display neck. While the neck is attached to the base, insert and tighten 3 base screws to the bottom of the base.



2. Open the packing foam with the monitor resting facing downwards. Take the assembled stand piece and insert it head first into the circular opening on the back of the monitor.



3. Once it is inserted press downwards on the neck until you hear a click sound.



4. Open up the cover at the bottom of the monitor, you will see the cable connections needed to connect to the computer and power.



5. To finalize your installation of the display, please read the following:
 - a. If you are placing the display on a stand, we would recommend you to use a display safety strap (not included) in order to minimize the possibility of the display toppling over.
 - b. Securely install all screws and connections.

Wall Mounting

1. To prep the monitor for wall mounting, remove the back plate by pulling down on the lever near the bottom of the monitor and lifting the stand piece upwards. Once the stand is lifted upwards you can slide out the entire stand assembly.



2. With the circular indentation now open to you, you will see 4 screws. Unscrew them.



3. Install the **long** wall mount stand offs onto the two top holes where the screws were removed. Install the **short** wall mount stand offs onto the two bottom holes where the screws were removed.



4. Once the wall mount standoffs are installed, the monitor is ready to be wall mounted. **The mounting pattern is 75mm x 75mm using M4 x 12mm screws.**

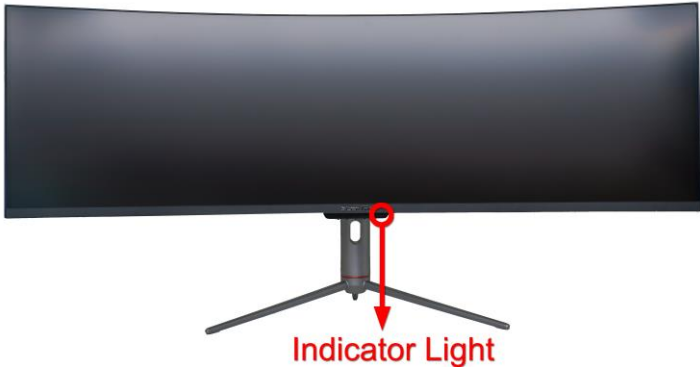

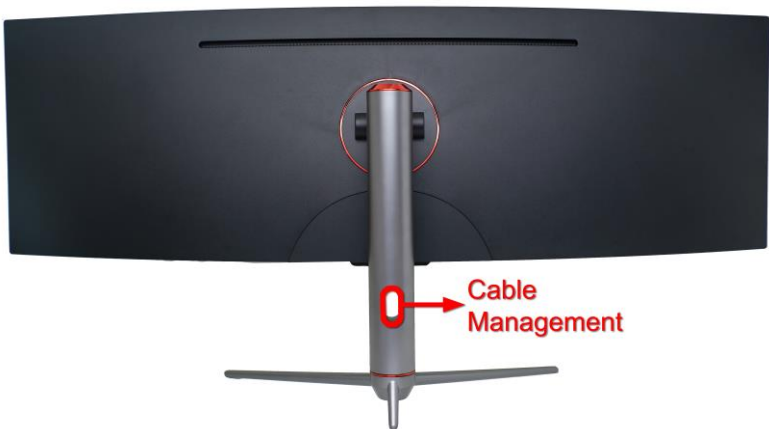
Identifying Front and Rear Panel

Front View



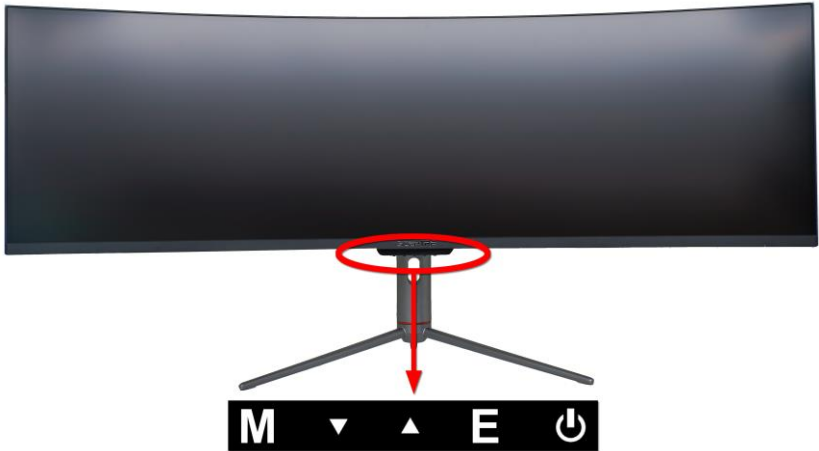
Indicator Light – The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

Rear View



The mounting holes are covered by the stand. The mounting pattern is 75mm x 75mm using M4 x 12mm screws.

Front View with Buttons



Buttons from right to left

1. **M** – This button activates the On Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
2. **▼** – With no OSD, this button opens the Volume OSD and decreases the monitor's volume output. With the OSD turned on, this button moves the selection downwards. This button will also decrease the value of an adjustment while an option is open.
3. **▲** – With no OSD, this button opens the Volume OSD and increases the monitor's volume output. With the OSD turned on, this button moves the selection upwards. This button will also increase the value of an adjustment while an option is open.
4. **E** – When the OSD is active, this button acts as the EXIT button and exits out of the option or OSD. This button switches between all the different inputs of the display.
5. **⏻** – This button turns the display on or off.

Panel Tilt Adjustment

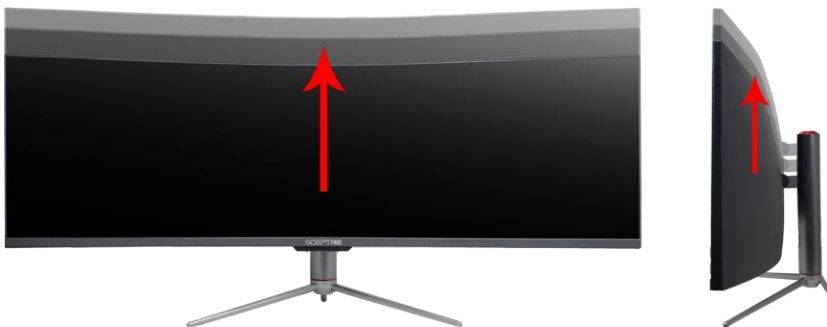


The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the specific model of the device. Generally, it may be inclined $5^{\circ}\pm 1^{\circ}$ forward and $15^{\circ}\pm 2^{\circ}$ backward.

Please Note:

- When adjust the angle of the monitor, be sure not to touch or press the LCD screen.

Panel Height Adjustment



The screen height can be adjusted by **3.75"**. The screen can be adjusted by lifting the bottom of the display.

Remote



: Press to turn the monitor on or off.



: Press to switch between HDMI or DP input.



: Press to enter the OSD menu or press to confirm.



: After entering the OSD settings menu, press any of the arrow buttons to move within the menu.



When OSD Menu is not open, Up and Down adjusts Volume.



When OSD Menu is not open, Left and Right adjusts Picture Presets (Standard, ECO, FPS, etc.)



: Mutes and unmutes volume.



: Press to exit the OSD menu or return to the previous menu.



: Cycles different multi window modes. (Normal, PBP, PIP)



: Cycles different multi window modes.

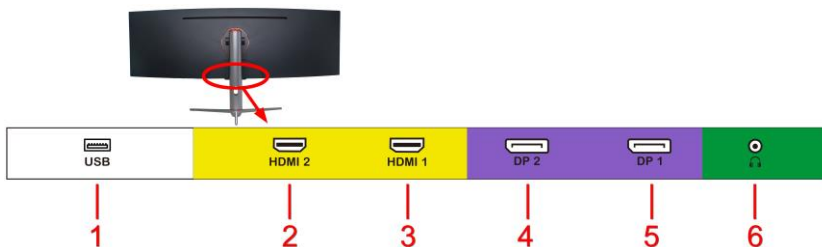

Rear View with Connections



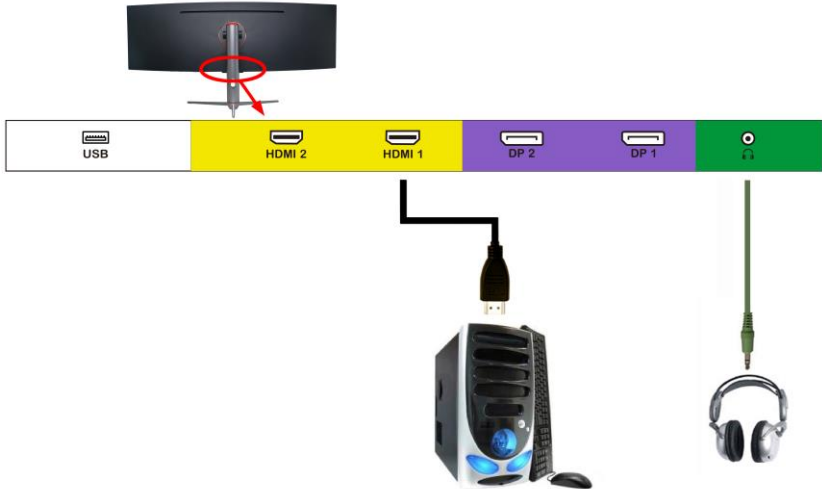
1. **USB** – This is the service port for the monitor.
2. **HDMI 2** – HDMI stands for High Definition Multimedia Interface. This connection is for computers with HDMI video output. HDMI supports adaptive sync, a feature that eliminates picture tearing and stuttering. HDMI 2 is HDMI 2.0 and supports up to 120Hz refresh rate depending on the resolution.
3. **HDMI 1** – HDMI stands for High Definition Multimedia Interface. This connection is for computers with HDMI video output. HDMI supports adaptive sync, a feature that eliminates picture tearing and stuttering. HDMI 1 is HDMI 2.0 and supports up to 120Hz refresh rate.
4. **DP 2** – DisplayPort (DP) is a digital video connection for connection to computers with display port video output. DP 2 is DP 1.4. DisplayPort supports up to 120Hz refresh rate depending on the resolution.
5. **DP 1** – DisplayPort (DP) is a digital video connection for connection to computers with display port video output. DP 1 is DP 1.4. DisplayPort supports up to 120Hz refresh rate depending on the resolution.
6. **AUDIO OUT (3.5mm Mini-jack)** – This connection is for audio out from the monitor to multimedia speakers or headphones.

Please Note:

- HDMI at native resolution 5120 x 1440 will **support only up to 60 Hz**.
- DP at native resolution 5120 x 1440 will support 120 Hz.
- In order to remove the DP cable from the monitor you need to depress the buckle on the cable while unplugging.

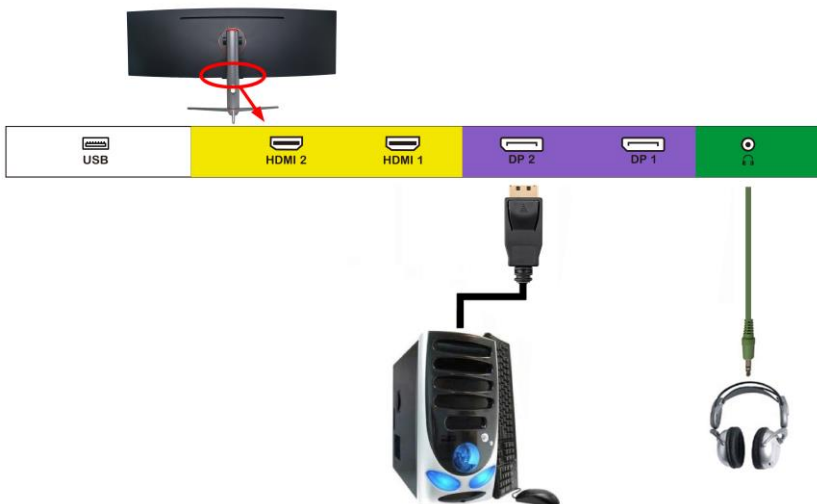

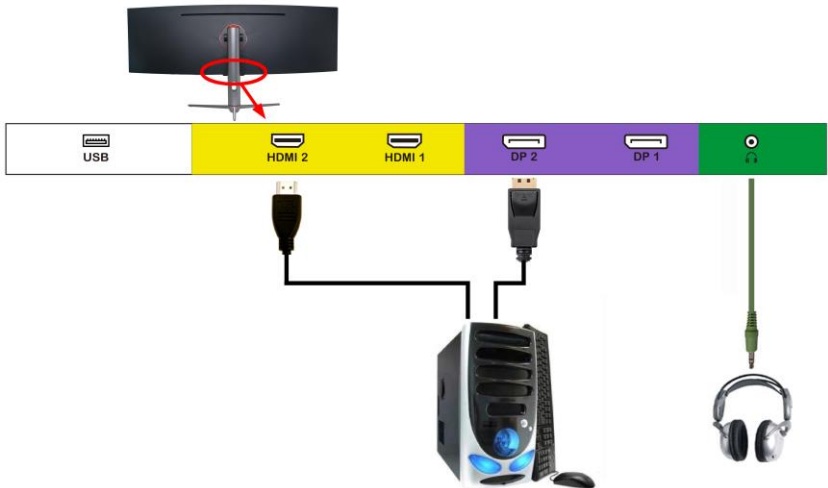

If You want to use dual input PIP/PBP on the monitor...



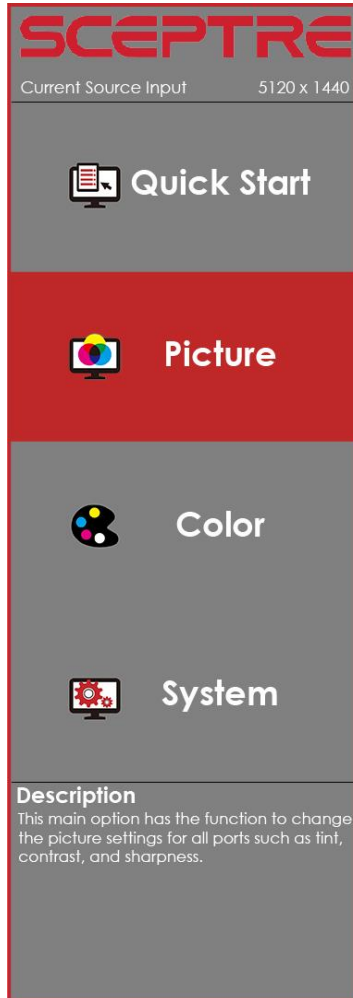
1. Make sure the power of the C50 LED MONITOR is turned off.
2. Obtain a DisplayPort cable and connect one end to the back of the monitor and the other end to the back of the computer.
3. Obtain a HDMI cable and connect one end to the back of the monitor and the other end to the back of the computer.
4. Turn on the power of both the C50 LED MONITOR and the computer.
5. From the monitor side, open the OSD by pressing the **M** button. Under PICTURE, select and turn on Multi Window either by using PIP or PBP. Change to the correct HDMI source (diagram above shows computer connected to HDMI 1) for the secondary input.
6. From windows go to display settings and select extend display to show the desktop on both inputs.

Please Note:

- When running multiple windows, the lowest refresh rate signal given will be the refresh rate for all windows.
- While the connection chart only shows 2 independent signals, for this monitor it is possible to run 4 independent signals for the screen to be split into 4 separate signal independent screens.


On Screen Display (OSD) Menu

The OSD menu of the monitor provides various adjustments for the monitor such as color, brightness, and contrastetc.



When you press the **M** button on the monitor, the OSD screen will appear. Select each of the functions with the **▲** or **▼** buttons. Use the **M** button again to enter each of the function or when you're in the function already, use the **M** button to select the option you want to adjust. Use the **▲** or **▼** buttons to adjust each option's values. When you want to exit press the **E** button.



- 9. **SECONDARY INPUT** – This option lets the user select the input of the second video.
- 10. **PIP SIZE** – This option changes the size of the PIP window.

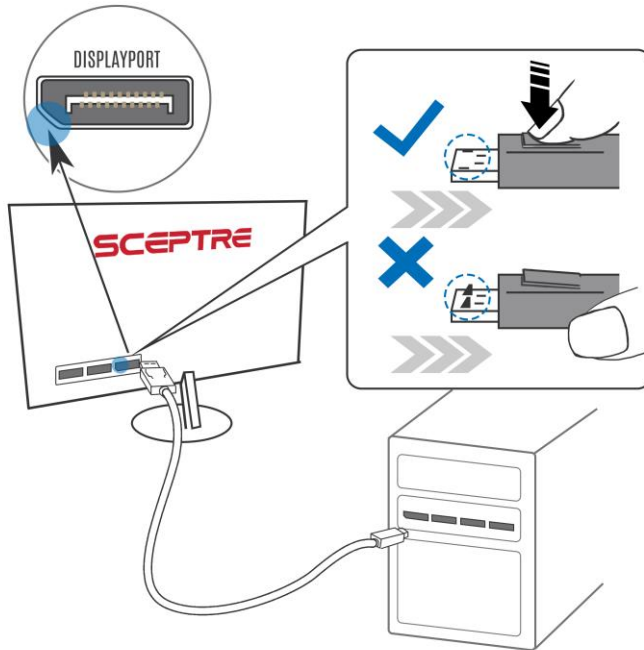

How do I detach the DisplayPort Cable?

To detach the DP cable from the monitor, press down on the cables unlocking button while pulling the cable out.



How do I clean the monitor?

IMPORTANT

1. The power cable has to be removed from the socket before cleaning the display.
