This product is designed and manufactured to operate within defined design limits, and misuse may result in electric shock or fire. To prevent the product from being damaged, the following rules should be observed for the installation, use and maintenance of the product. - To avoid the risk of electric shock or component damage, switch off the power before connecting other components to the display.
- Unplug the power cord before cleaning the display. Please use a microfiber cleaning cloth for cleaning the bezel of the display only. Do not use a liquid or a spray cleaner for cleaning the product. Do not use abrasive cleaners.
- Always use the accessories recommended by the manufacturer to insure compatibility.

When opening the carton, check that the product is in good condition and that all standard accessories and items are included. Installation

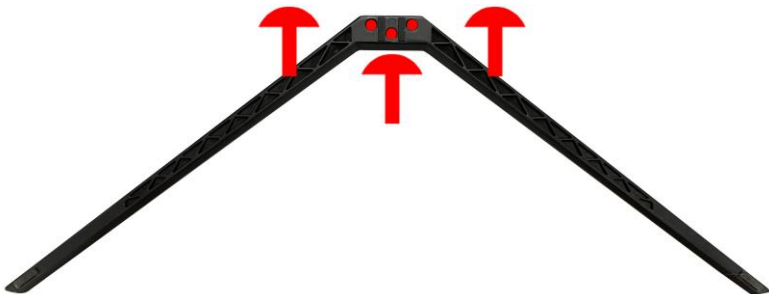
Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. Use only the Sceptre provided power cable or power adapter approved for use with this device. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and successive component damage.

Installing the Monitor Stand Assembly

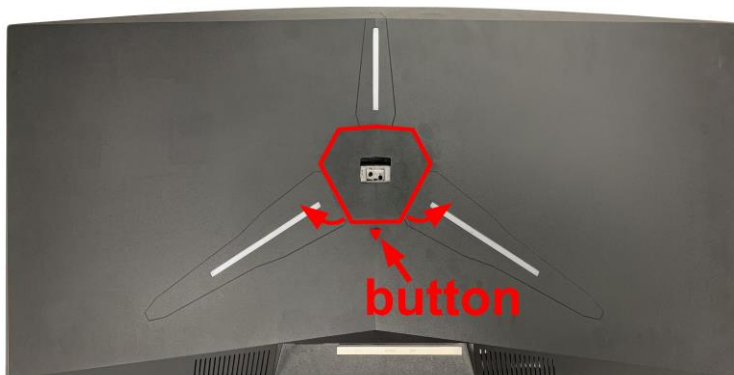
1. Take the monitor out of the box. Lay the monitor screen facing down on a table with the monitor still resting on the packing foam. Obtain the display neck and attach it to the display neck.



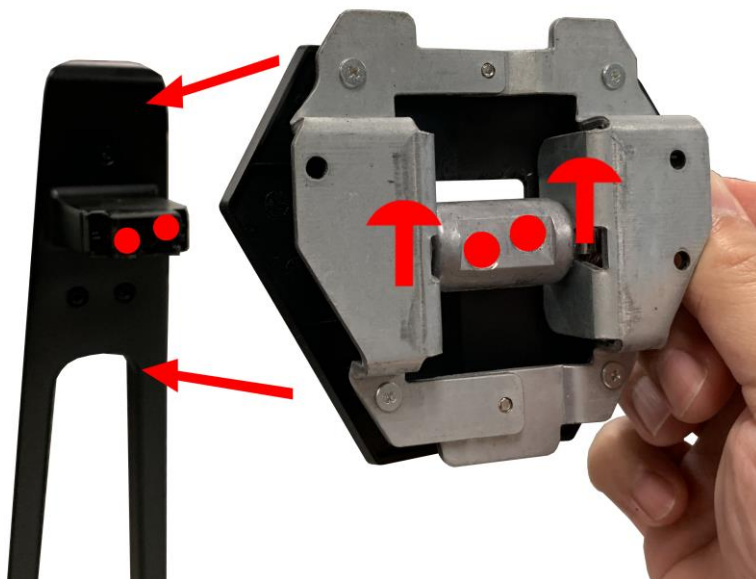
2. While the neck is attached to the base, insert, and tighten 3 base screws to the bottom of the base.



3. Locate the button on the back of the display. Push the button and lift the back plate off the display.



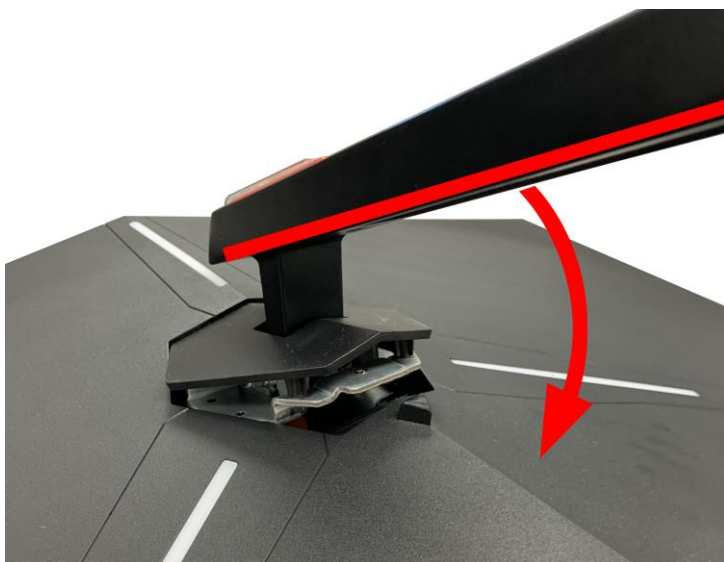
4. Insert the back plate to the neck + base (stand) assembly and secure the neck plate by inserting and tightening 2 neck screws.



5. Insert the stand + back plate into the back of the display with the back plate's top end going in first.



6. Once the back plate's top end goes in push down on the bottom end to secure the stand into the monitor.



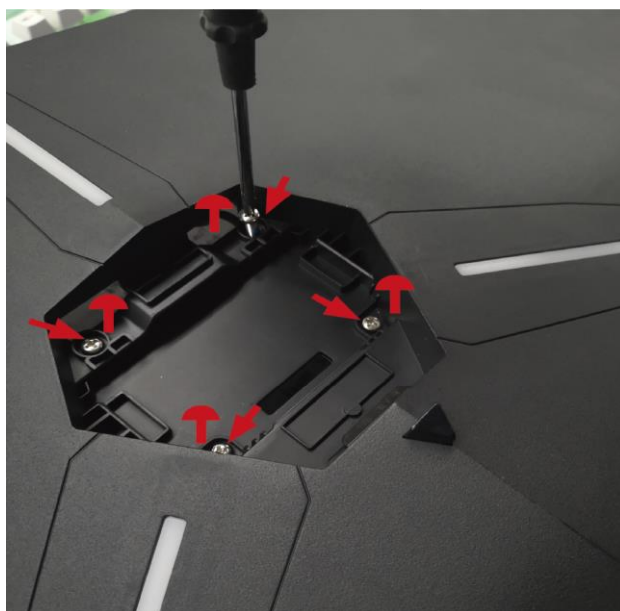
7. To finalize your installation of the display, please read the following:
 - a. If you are placing the display on a stand, we would recommend you to use a display safety strap (not included) in order to minimize the possibility of the display toppling over.
 - b. Securely install all screws and connections.

Wall Mounting

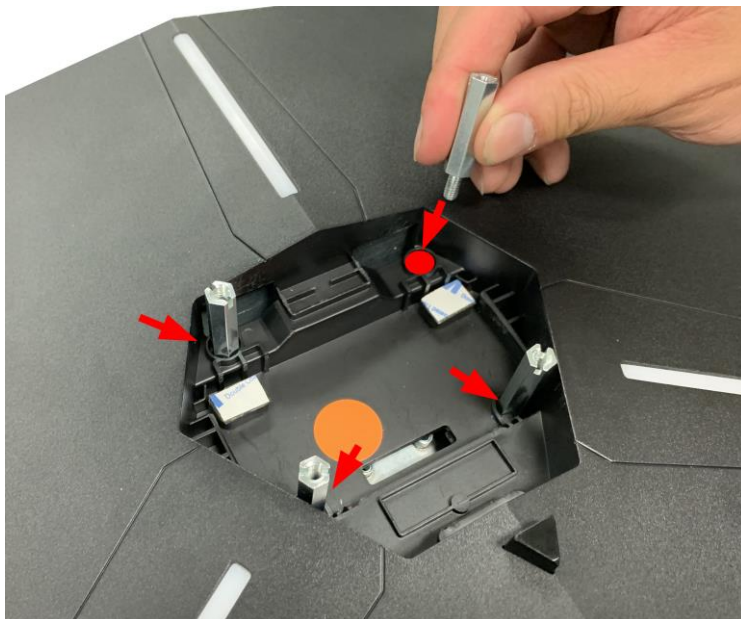
1. To prep the monitor for wall mounting, remove the back plate by pressing down on the triangular button near the bottom of the back plate and lifting the back plate upwards.



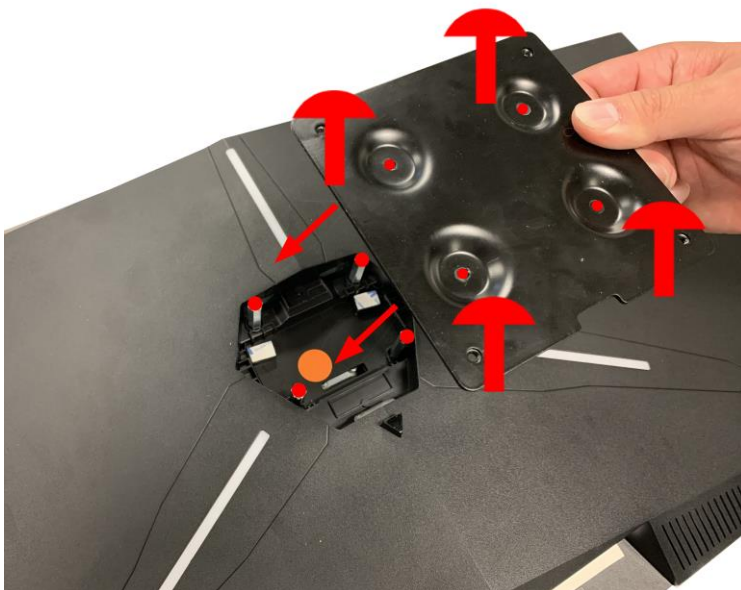
2. Remove the original screws from the opening in the back of the monitor. Please save these screws for Step 4.



3. With the indentation you will see 4 holes. Insert and screw in the 4 wall mount standoffs.



4. Install the wall mount plate on top of the standoffs and secure the plate by tightening 4 wall mount screws onto the plate.



5. Once the wall mount plate is installed, the monitor is ready to be wall mounted. **The mounting pattern is 100mm x 100mm using M4 x 8mm screws.**

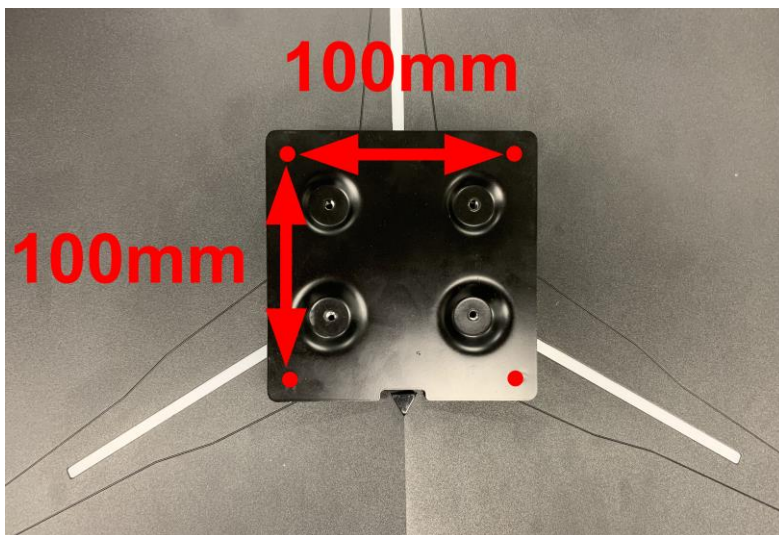

Identifying Front and Rear Panel

Front View



Indicator Light – The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

Panel Tilt Adjustment

The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the specific model of the device. Generally, it may be inclined $3\pm1^\circ$ forward and $15\pm2^\circ$ backward.

Please Note:

- When adjust the angle of the monitor, be sure not to touch or press the LCD screen.

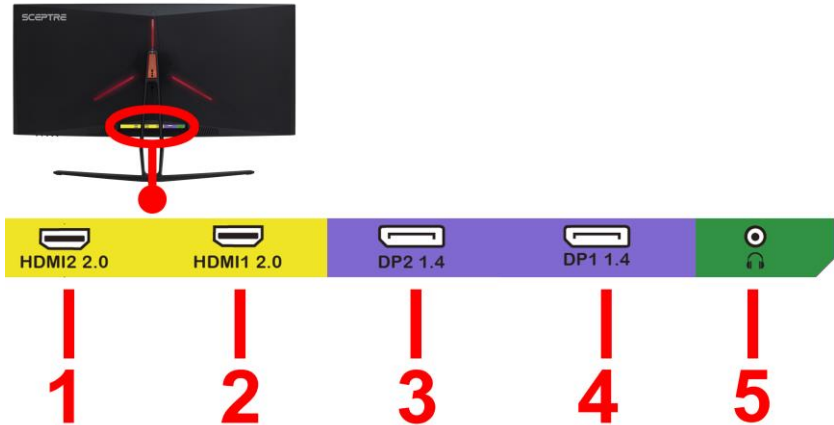
Front View with Buttons



Buttons from right to left

1. **M** – This button activates the On-Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
2. **▼** – With no OSD, this button opens the Volume OSD and decreases the monitor's volume output. With the OSD turned on, this button moves the selection downwards. This button will also decrease the value of an adjustment while an option is open.
3. **▲** – With no OSD, this button opens the Volume OSD and increases the monitor's volume output. With the OSD turned on, this button moves the selection upwards. This button will also increase the value of an adjustment while an option is open.
4. **E** – When the OSD is active, this button acts as the EXIT button and exits out of the option or OSD. This button switches between all the different inputs of the display.
5. **⏻** – This button turns the display on or off.

Rear View with Connections



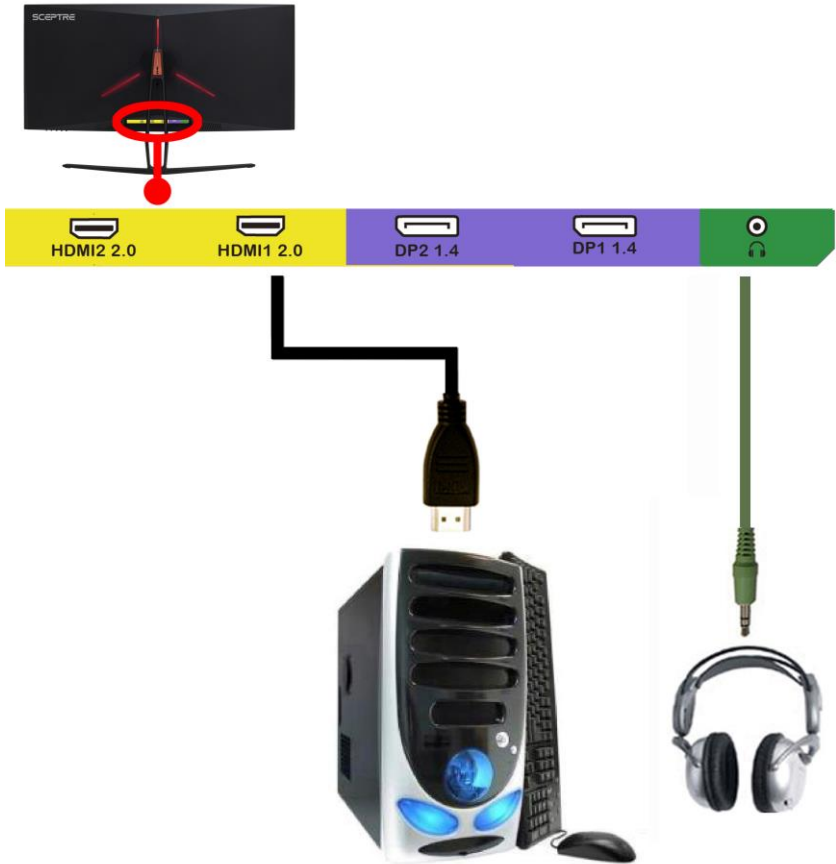
1. **HDMI 2** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video output. HDMI supports adaptive sync, a feature that eliminates picture tearing and stuttering. HDMI 2 is HDMI 2.0 and supports up to 100Hz refresh rate.
2. **HDMI 1** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video output. HDMI supports adaptive sync, a feature that eliminates picture tearing and stuttering. HDMI 1 is HDMI 2.0 and supports up to 100Hz refresh rate.
3. **DP 2** – DisplayPort (DP) is a digital video connection for connection to computers with display port video output. DisplayPort 2 supports up to 120Hz refresh rate.
4. **DP 1** – DisplayPort (DP) is a digital video connection for connection to computers with display port video output. DisplayPort 1 supports up to 120Hz refresh rate.
5. **AUDIO OUT (3.5mm Mini-jack)** – This connection is for audio out from the monitor to multimedia speakers or headphones.

Please Note:

- HDMI at native resolution 3440 x 1440 will support 100Hz.
- DP at native resolution 3440 x 1440 will support 120Hz.
- To remove the DP cable from the monitor, you need to depress the buckle on the cable while unplugging.

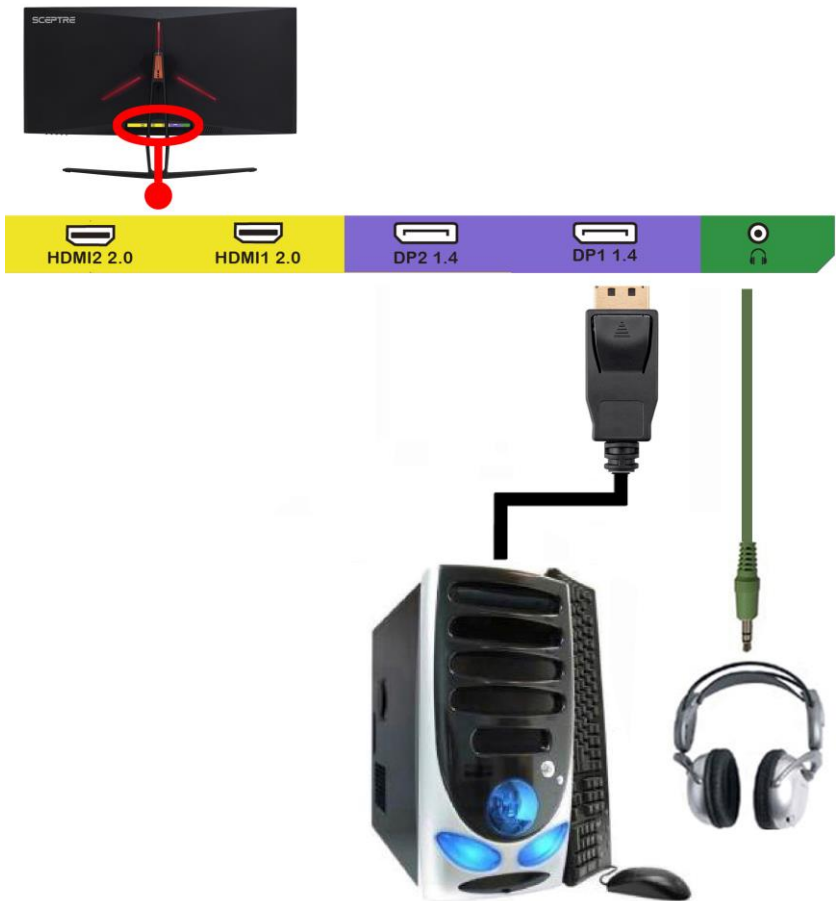

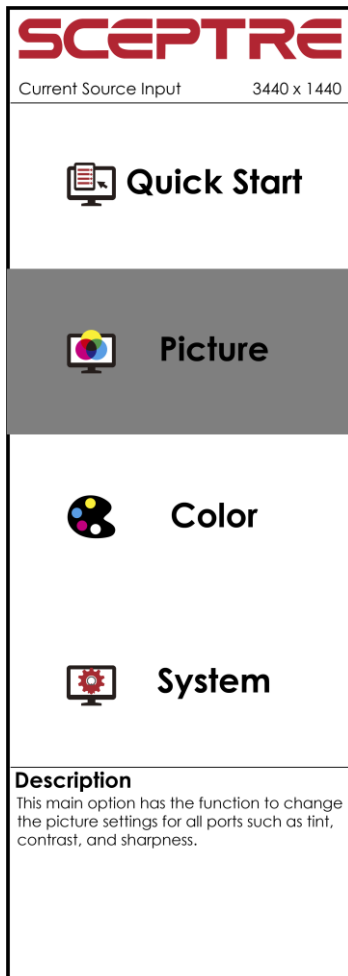

On Screen Display (OSD) Menu

The OSD menu of the monitor provides various adjustments for the monitor such as color, brightness, and contrast etc.



When you press the **M** button on the monitor, the OSD screen will appear. Select each of the functions with the **▲** or **▼** buttons. Use the **M** button again to enter each of the function or when you are in the function already, use the **M** button to select the option you want to adjust. Use the **▲** or **▼** buttons to adjust each option's values. When you want to exit press the **E** button.

1. **TEMPERATURE** – This option let users select different color temperatures of the monitor.
 - a. **NORMAL** – This color temperature is for users who prefer a neutral white balance.
 - b. **COOL** – This color temperature is for users who prefer a cool white balance.
 - c. **USER** – This color temperature is for users who would like to adjust the RGB (red, green, blue) values manually.

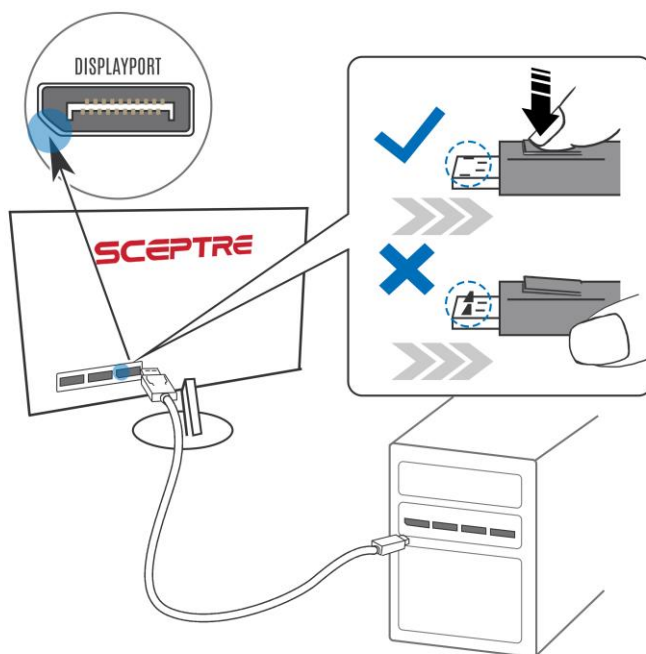

How do I detach the DisplayPort Cable?

To detach the DP cable from the monitor, press down on the cables unlocking button while pulling the cable out.



How do I clean the monitor?

IMPORTANT

1. The power cable has to be removed from the socket before cleaning the display.
2. Do not use volatile solvent (alcohol, rosin, and toluene) to clean the display. These types of chemicals might damage the housing and the LCD glass.

Cleaning the bezel
