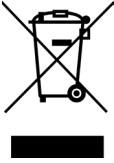

The SCEPTRE display is packaged in a carton. The size and weight of the product might be too heavy for 1 person to handle. Since the glass can be easily scratched or broken, please handle the product gently. Never place the unit on a surface with the glass facing downwards unless it is on a protective padding. When opening the carton, check that the product is in good condition and that all standard accessories and items are included. 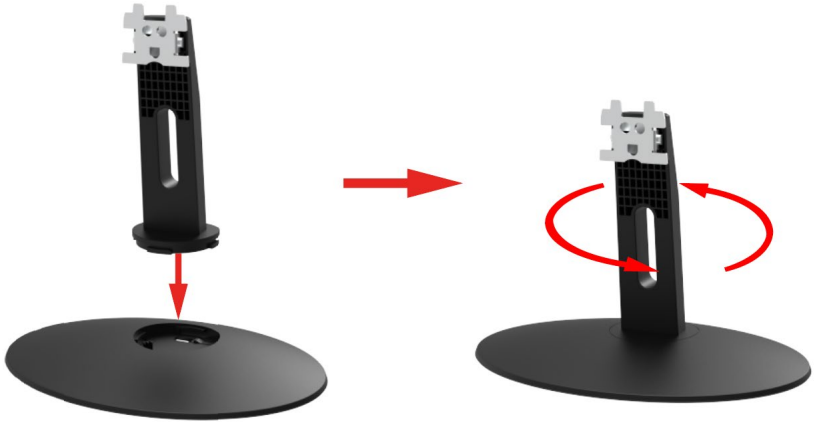

Installation

Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. Use only the Sceptre-provided power cable or AC adapter approved for use with this device. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom, or other places with high humidity, dust, or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and subsequent component damage.

Installing the Monitor Stand Assembly

Insert the neck into the base with the front of the neck facing the left at 45-degree angle and twice the neck clockwise until you hear a click sound and the neck is facing forward aligned with the base.



Take out the monitor and neck from the carton box and insert the neck into the bottom position of monitor

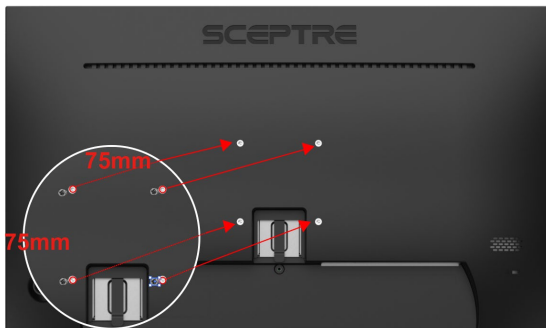


Wall Mounting

1. Lay the monitor down on a flat surface with the screen facing downwards. Remove the stand assembly by unlocking the locking clip.



1. With the circular indentation now open to you, you will see 4 screws installed on the back of the monitor. Please unscrew them.
2. Install the wall mount plate to the back of the monitor using the provided **Wall Mount Plate Screws (M4 x 10mm)**.



3. Once the wall mount spacer screws are installed, the monitor is ready to be wall mounted. **The mounting pattern is 75mm x 75mm.**

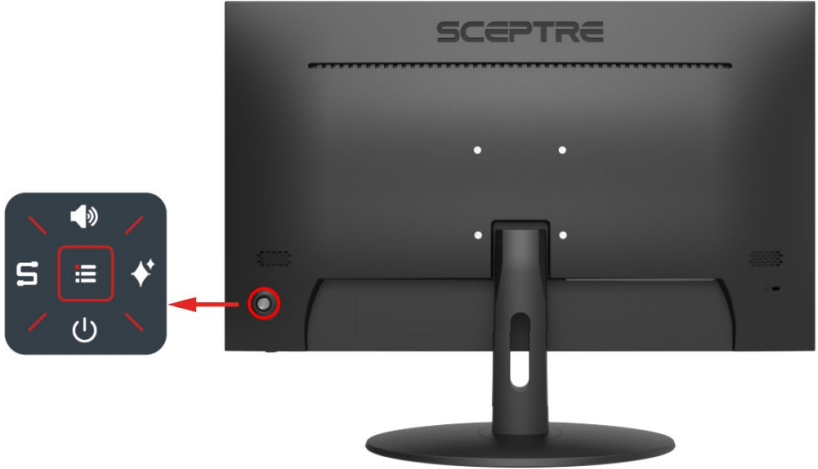
Identifying Front and Rear Panel

Front View








Indicator Light – The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

Rear View with Buttons



Buttons from left to right

1.  – This button activates the On-Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
2.  – When the OSD This option adjusts the loudness of the monitor speakers.
3.  – When the OSD Selects which input device is to be displayed on the monitor.
4.  – When the OSD Preset values that adjust color accordingly to your purpose of use.
5.  – When the OSD turns the display off.

Panel Tilt Adjustment

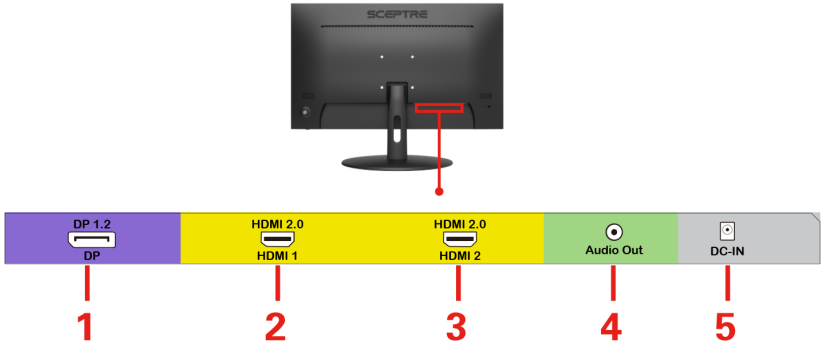


The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the particular model of the device. Generally, it may be inclined $5^{\circ}\pm 1^{\circ}$ forward and $15^{\circ}\pm 2^{\circ}$ backward.

Please Note:

- When adjusting the angle of the monitor, be sure not to touch or press the LCD screen.

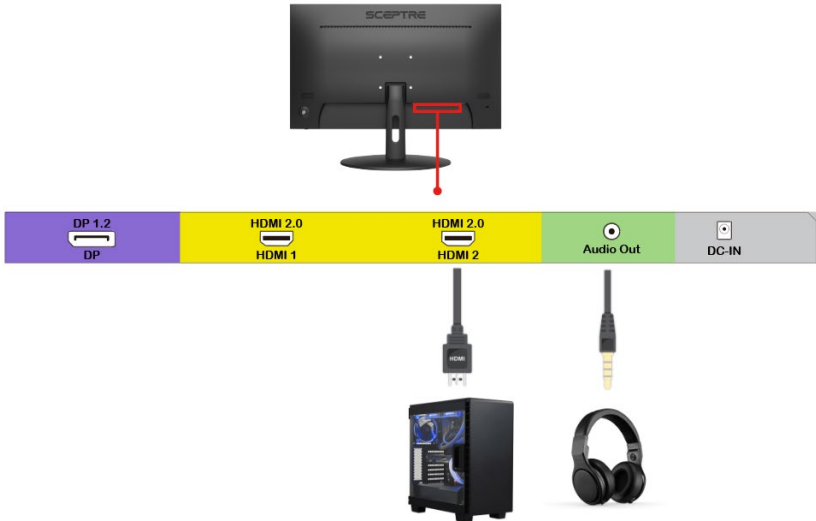
Rear View with Connections



1. **DISPLAYPORT1-2** – DisplayPort is a digital video connection for connection to computers with display port video and audio output. DisplayPort is DP v1.2.
2. **HDMI 1** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video and audio output. HDMI 1 and 2 are both HDMI v2.0.
3. **HDMI 2** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video and audio output. HDMI 1 and 2 are both HDMI v2.0.
4. **AUDIO OUT (3.5mm Mini-jack)** – This connection is for audio out from the monitor to multimedia speakers or headphones.
5. **POWER** – This plug is responsible for providing power to the monitor. Use it with the included AC adapter.

Troubleshooting

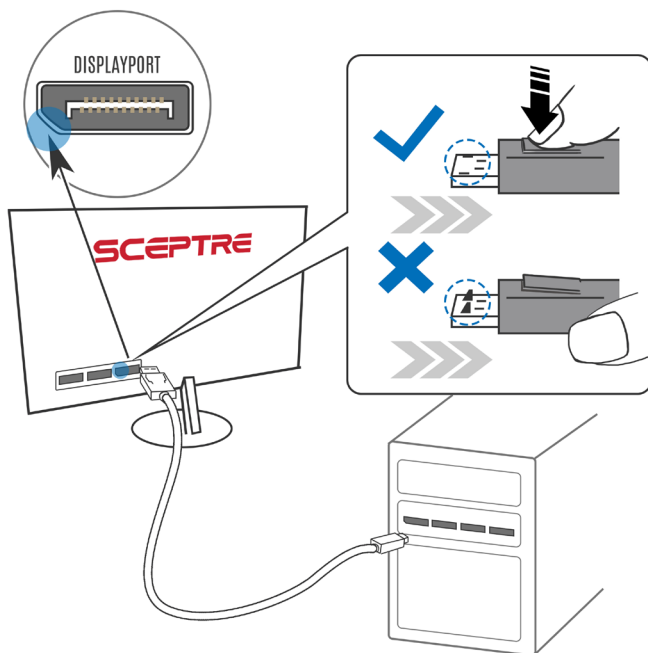
Problem	Possible solutions
THERE IS NO LED DISPLAY or SCREEN SAYS NO SIGNAL	Make sure you switched to the correct source. Check both sources to see the video is on the other source. Check your video cable. It might be corrupt. Swap out the video cable for another one to see if the monitor will work. Check your power plug. See if it is fully plugged in on both the monitor and the wall.
MONITOR SAYS "SIGNAL OUT OF RANGE"	<p>If you have a CRT monitor, please connect the CRT monitor to the computer and change the refresh rate down to 60Hz via your video card's display settings menu. After the setting of 60Hz has been changed; you can then use the E24 LED Monitor on the computer.</p> <ol style="list-style-type: none"><li data-bbox="493 536 1023 611">1. To change the setting, go to display settings by right-clicking on your desktop with nothing selected. Choose the PROPERTIES option.<li data-bbox="493 616 1023 691">2. Click on the SETTINGS tab, verify the resolution is NOT higher than 1920 x 1080, and click on the ADVANCED button.<li data-bbox="493 695 1023 743">3. Click on the MONITOR tab and change the refresh rate to 60Hz.<li data-bbox="493 748 975 772">4. How do I detach the DisplayPort Cable?

To detach the DP cable from the monitor, press down on the cables unlocking button while pulling the cable out.



How do I clean the monitor?
