Installation

Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. Use only the Sceptre-provided power cable or AC adapter approved for use with this device. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom, or other places with high humidity, dust, or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and subsequent component damage.

Installing the Monitor Stand Assembly

Wall Mounting

Lay the monitor down on a flat surface with the screen facing downwards.
 Remove the stand assembly by unlocking the locking clip.



- 1. With the circular indentation now open to you, you will see 4 screws installed on the back of the monitor. Please unscrew them.
- Install the wall mount plate to the back of the monitor using the provided Wall Mount Plate Screws (M4 x 10mm).



Once the wall mount spacer screws are installed, the monitor is ready to be wall mounted. The mounting pattern is 75mm x 75mm.


