The SCEPTRE display is packaged in a carton. The size and weight of the product might be too heavy for 1 person to handle. 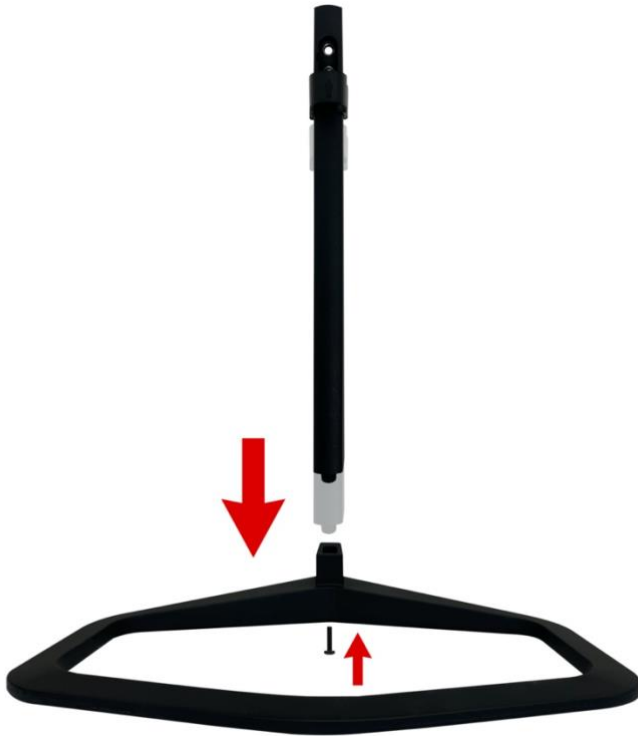

Installation

Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and successive component damage.

Installing the Monitor Stand Assembly

1. With the packing foam still on, lay the monitor screen facing down on a table and open the top half of the packing foam. Obtain the neck and base piece. Connect the neck to the base piece. Secure the base by inserting and tightening the base screw from the bottom of the base.



2. Insert the neck into mounting on the back of the monitor and secure the installation by inserting and tightening the 2 neck screws.



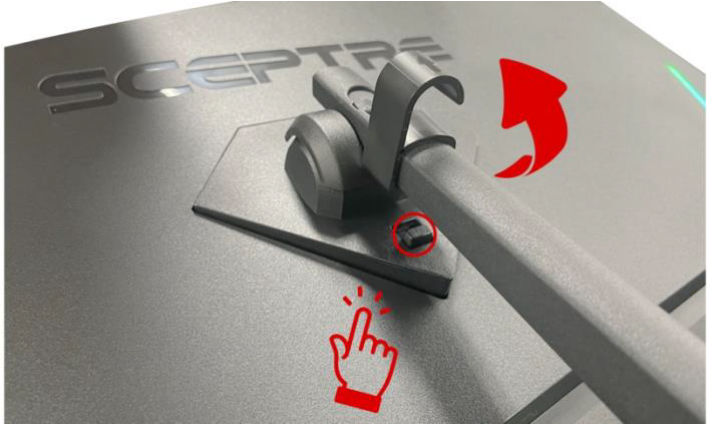
3. Align the cable clip with the hole on the display neck, and then snap it in.



4. To finalize your installation of the display, please read the following:
 - a. If you are placing the display on a stand, we would recommend you use a display safety strap (not included) in order to minimize the possibility of the display toppling over.
 - b. Securely install all screws and connections.

Preparing the Monitor for Wall Mount

1. Lay the monitor screen facing down on a table. Looking at the back of the monitor you will see a plastic cover that you can take off. Please remove the neck plate from the monitor.



2. Once removed, please look for four screw holes marked below in red. Please install the (4) Wall-mount spacers in these screw holes.



3. Align the Wall-Mount Plate that is included with your monitor. Screw in the plate with the provided Wall-Mount screws.



4. The mount specification is 75mm x 75mm using M4 screws.

Identifying Front and Rear Panel

Front View



Indicator Light –The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

Rear View



Panel Tilt Adjustment



The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the specific model of the device. Generally, it may be inclined $5^{\circ}\pm 1^{\circ}$ forward and $15^{\circ}\pm 2^{\circ}$ backward.

Rear View with Buttons



1. **M** – This button activates the On-Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
2. **E** – When the OSD is active, this button acts as the EXIT button and exits out of the option or OSD. This button switches between all the different inputs of the display.
3. **⏻** – This button turns the display on or off.
4. **▲** – With no OSD, this button will also increase the volume of the internal speaker. With the OSD turned on, this button moves the selection upwards.
5. **▼** – With no OSD, this button will also decrease the volume of the internal speaker. With the OSD turned on, this button moves the selection downwards.

Rear View with Connections



1. **POWER** – This plug is responsible for providing power to the monitor. Use it with the included AC adapter.
2. **HDMI 2** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video output. The HDMI port version is 2.0.
3. **HDMI 1** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video output. The HDMI port version is 2.0.
4. **DP 2** – Display port is a digital video connection for connection to computers with display port video output. The DisplayPort version is 1.4.
5. **DP 1** – Display port is a digital video connection for connection to computers with display port video output. The DisplayPort version is 1.4.
6. **AUDIO OUT (3.5mm Mini-jack)** – This connection is for audio out from the monitor to multimedia speakers or headphones.

Connections

If You have HDMI Connection on Your Video Card...



1. Make sure the power of the K25 LED MONITOR is turned off.
2. Obtain an HDMI cable and connect one end to the back of the monitor and the other end to the back of the computer.
3. Turn on the power of both the K25 LED MONITOR and the computer.

Please Note:

- Make sure to set audio output from your computer to PCM output.
- This connection supports up to 240Hz refresh rate.

If You have DisplayPort Connection on Your Video Card...



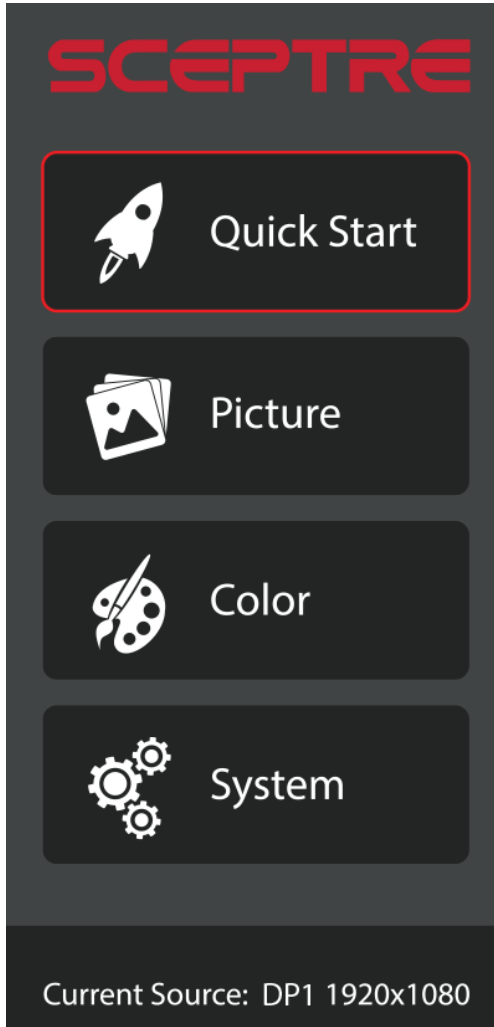
1. Make sure the power of the K25 LED MONITOR is turned off.
2. Obtain a DisplayPort cable and connect one end to the back of the monitor and the other end to the back of the computer.
3. Obtain a 3.5mm mini-jack cable connect one end to the audio out of your PC. Connect the other end of the cable to your K25 LED MONITOR's audio in.
4. Turn on the power of both the K25 LED MONITOR and the computer.

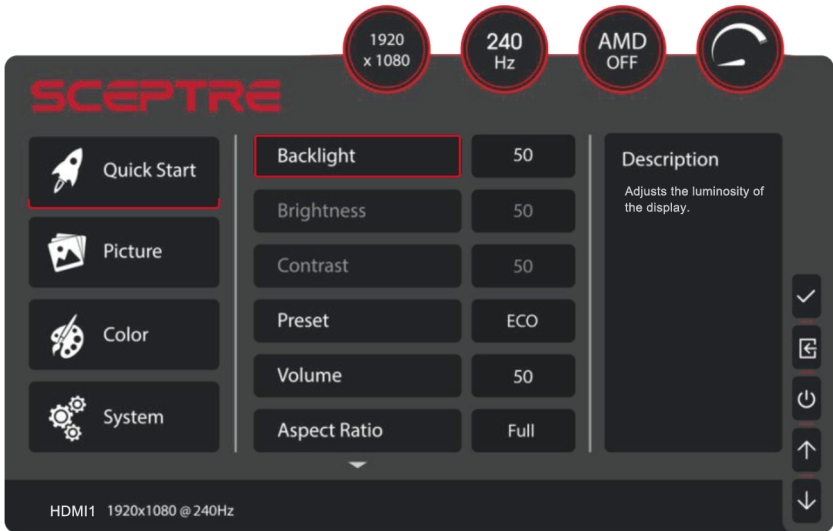
The OSD menu of the monitor provides various adjustments for the monitor such as color, brightness, and contrast etc.



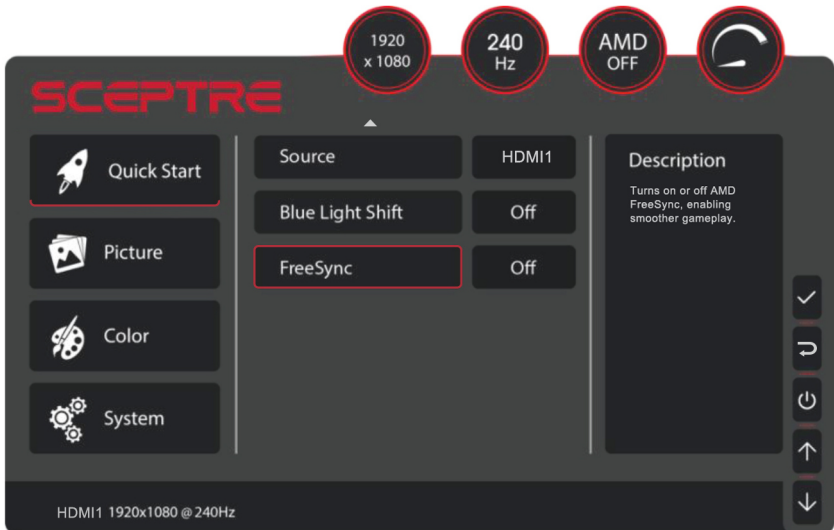

Use the **▲** or **▼** buttons to adjust each option's values. When you want to exit, press the **E** button.

Troubleshooting

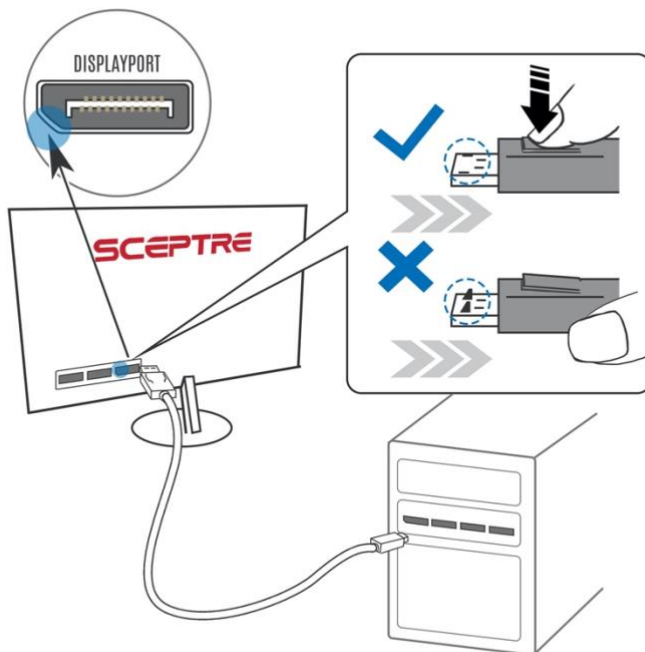
Problem	Possible solutions
THERE IS NO LED DISPLAY or SCREEN SAYS NO SIGNAL	<p>Make sure you switched to the correct source. Check both sources to see the video is on the other source. Check your video cable. It might be corrupt. Swap out the video cable for another one to see if the monitor will work. Check your power plug. See if it is fully plugged in on both the monitor and the wall.</p>
MONITOR SAYS "SIGNAL OUT OF RANGE"	<p>If you have a CRT monitor, please connect the CRT monitor to the computer and change the refresh rate down to 60Hz via your video card's display settings menu. After the setting of 60Hz has been changed; you can then use the LED Monitor on the computer.</p> <ol style="list-style-type: none">1. To change the setting, go to display settings by right-clicking on your desktop with nothing selected. Choose the PROPERTIES option.2. To detach the DP cable from the monitor, press down on the cables unlocking button while pulling the cable out.



How do I clean the LED Monitor?
