



Installation

Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Installing the Monitor Stand Assembly

2. Insert the neck into mounting on the back of the monitor and secure the installation by inserting and tightening the 2 neck screws.






3. Align the cable clip with the hole on the display neck, and then snap it in.

3. Align the Wall-Mount Plate that is included with your monitor. Screw in the plate with the provided Wall-Mount screws.



4. The mount specification is 75mm x 75mm using M4 screws.



To detach the DP cable from the monitor, press down on the cables unlocking button while pulling the cable out.
