# IMPORTANT INFORMATION

This product is designed and manufactured to operate within defined design limits, and misuse may result in electric shock or fire. - To avoid the risk of electric shock or component damage, switch off the power before connecting other components to the display.
- Unplug the power cord before cleaning the display. Please use a microfiber cleaning cloth for cleaning the bezel of the display only. Do not use a liquid or a spray cleaner for cleaning the product. Do not use abrasive cleaners.

# Opening the Package

---

The SCEPTRE display is packaged in a carton. The size and weight of the product might be too heavy for 1 person to handle. In the event of that happening, it is recommended that the display package must be handled by a minimum of 2 or more persons. Since the glass can be easily scratched or broken, please handle the product gently. Never place the unit on a surface with the glass facing downwards unless it is on a protective padding. When opening the carton, check that the product is in good condition and that all standard accessories and items are included. Save the original box and all packing materials for future shipping needs.

# Installation

---

Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. Use only the Sceptre-provided power cable or AC adapter approved for use with this device. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom, or other places with high humidity, dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and subsequent component damage.



# Installing the Monitor Stand Assembly

---

1. Take the monitor with packing foam out of the box. Lay the monitor screen facing down on a table with the monitor still resting on the packing foam. Obtain the display base and attach it to the display neck. While the neck is attached to the base, insert and tighten 3 base screws to the bottom of the base.



2. Install the assembled stand to the back of the monitor and screw in the 2 neck screws to secure the stand to the monitor.



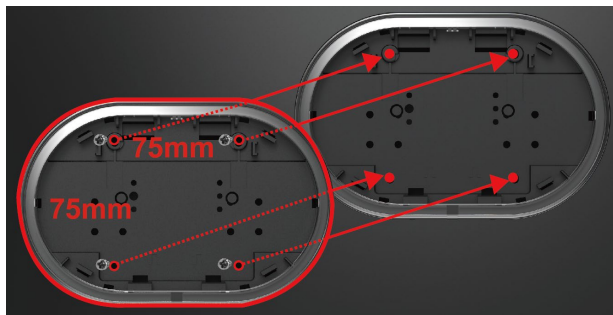
3. Insert the rubber cover to the back of the neck.
4. To finalize your installation of the display, please read the following:
  - a. If you are placing the display on a stand, we would recommend using a display safety strap (not included) to minimize the possibility of the display toppling over.
  - b. Securely install all screws and connections.

# Wall Mounting

1. To uninstall the stand assembly, lay the monitor facing downwards on a table with the monitor still resting on the packing foam. Remove the rubber cover and unscrew the two screws to remove the stand.



2. With the neck removed, insert your finger into the gap to pull back the plastic cover covering the mounting holes.
3. With the circular indentation now open to you, you will see 4 screws installed on the back of the monitor. Please unscrew them.
4. Install the wall mount spacers to the back of the monitor using the provided **Wall Mount Spacers (M4 x 10mm)**.



5. Once the wall mount spacer screws are installed, the monitor is ready to be wall mounted. **The mounting pattern is 75mm x 75mm.**

# Identifying Front and Rear Panel

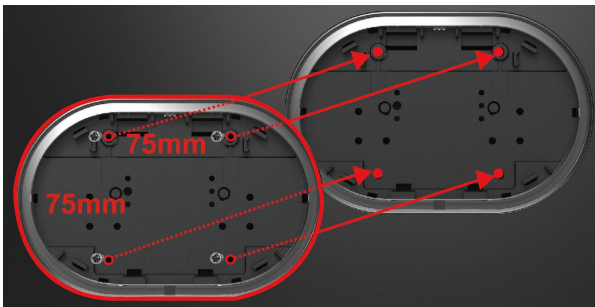
---

## Front View



**Indicator Light** – The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

## Rear View



The stand covers the mounting holes. Once you remove the stand, you will need to attach a mounting plate to wall mount the monitor. The mounting pattern is 100mm x 100mm using M4 x 10mm screws.

## Front View with Buttons



### Buttons from left to right.

1. **M** – This button activates the On-Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
2. **▼** – With no OSD, this button opens the Volume OSD and decreases the monitor's volume output. With the OSD turned on, this button moves the selection downwards. This button will also decrease the value of an adjustment while an option is open.
3. **▲** – With no OSD, this button opens the Volume OSD and increases the monitor's volume output. With the OSD turned on, this button moves the selection upwards. This button will also increase the value of an adjustment while an option is open.
4. **E** – When the OSD is active, this button acts as the EXIT button and exits out of the option or OSD. This button switches between all the different inputs of the display.
5. **⏻** – This button turns the display on or off.

## Panel Tilt Adjustment

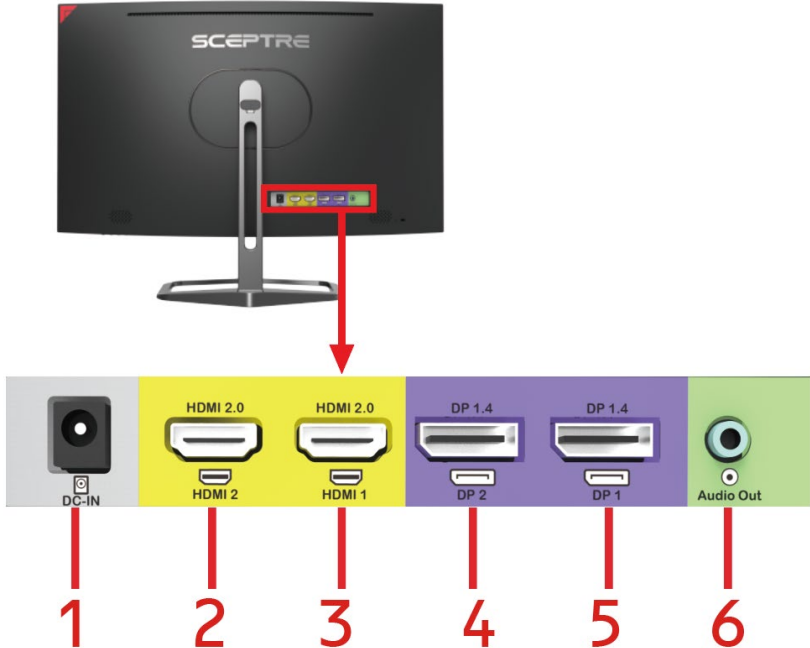


The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the particular model of the device. Generally, it may be inclined  $5^{\circ}\pm 1^{\circ}$  forward and  $15^{\circ}\pm 2^{\circ}$  backward.

Please Note:

- When adjusting the angle of the monitor, be sure not to touch or press the LCD screen.

## Rear View with Connections



1. **POWER** – This plug is responsible for providing power to the monitor. Use it with the included AC adapter.
2. **HDMI 2** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video and audio output. The HDMI port version is 2.0.
3. **HDMI 1** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video and audio output. The HDMI port version is 2.0.
4. **DP 2** – DisplayPort is a digital video connection for connection to computers with display port video and audio output. DisplayPort is DP v1.4.
5. **DP 1** – DisplayPort is a digital video connection for connection to computers with display port video and audio output. DisplayPort is DP v1.4.
6. **AUDIO OUT (3.5mm Mini-jack)** – This connection is for audio out from the monitor to multimedia speakers or headphones.

Please Note:

- HDMI at native resolution 1920 x 1080 will support 240Hz.
- DP at native resolution 1920 x 1080 will support 240Hz.
- To remove the DP cable from the monitor, you need to depress the buckle on the cable while unplugging.

## If You have HDMI Connection on Your Video Card...



1. Make sure the power of the C27 LED MONITOR is turned off.
2. Obtain an HDMI cable and connect one end to the back of the monitor and the other end to the back of the computer.
3. For audio, you can plug in a set of headphones or speakers into the headphone jack.
4. Turn on the power of both the C27 LED MONITOR and the computer.

- HDMI 1-2 supports up to 240Hz refresh rate.

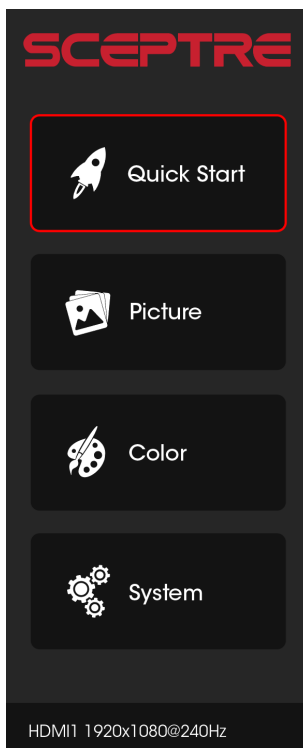

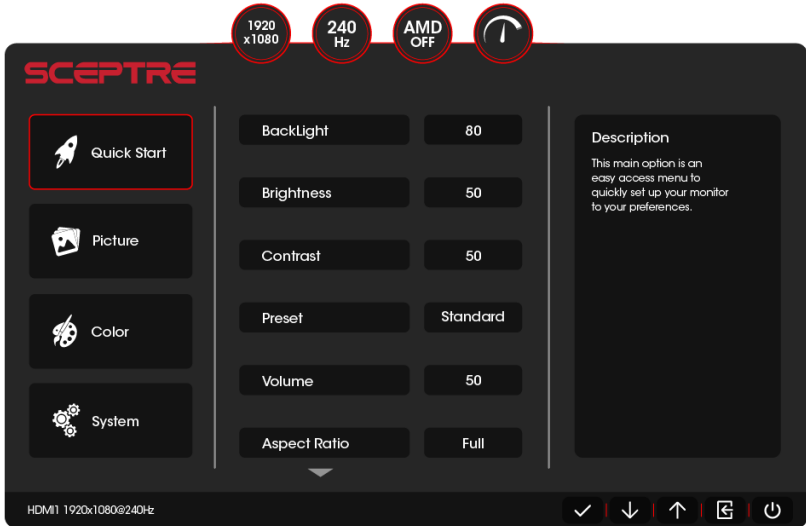

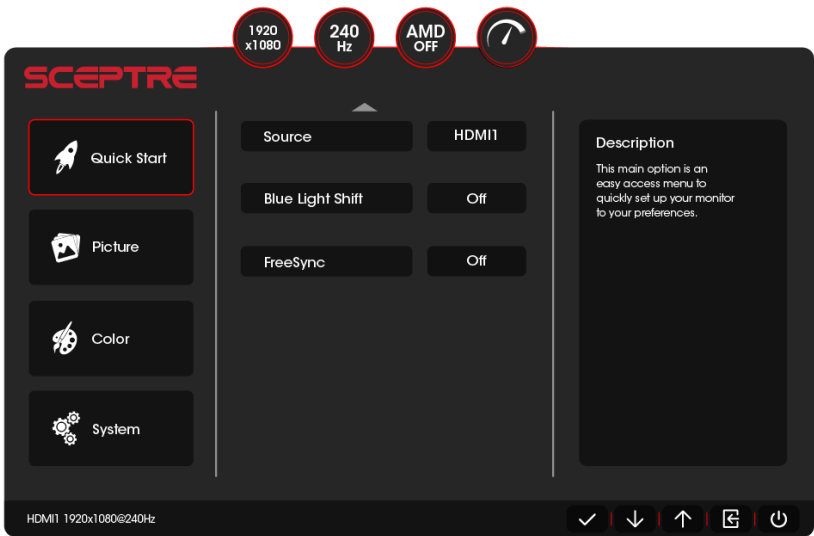

Use the **M** button again to enter each of the functions, or when you are in the function already, use the **M** button to select the option you want to adjust. Use the **▲** or **▼** buttons to adjust each option's values. When you want to exit, press the **E** button.

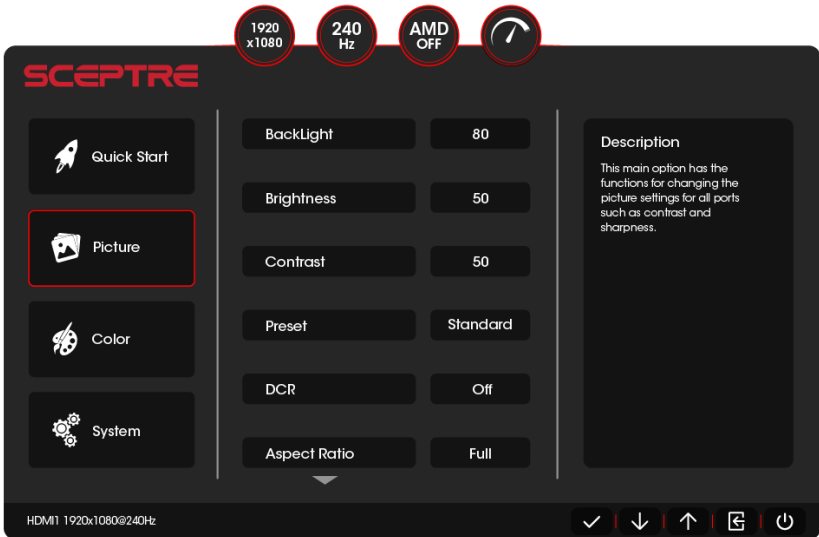

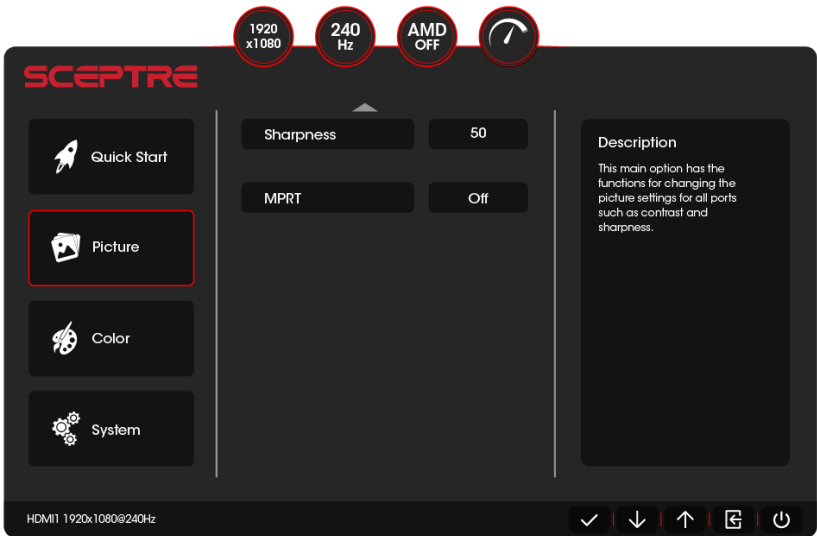


7. **SOURCE** – This option selects which input device is to be displayed on the monitor.
8. **BLUE LIGHT SHIFT** – This option adjusts the blue light value to reduce strain on eyes.
9. **Freesync™** – This option turns on or off the FreeSync™ function, which reduces screen tearing with compatible graphics cards.

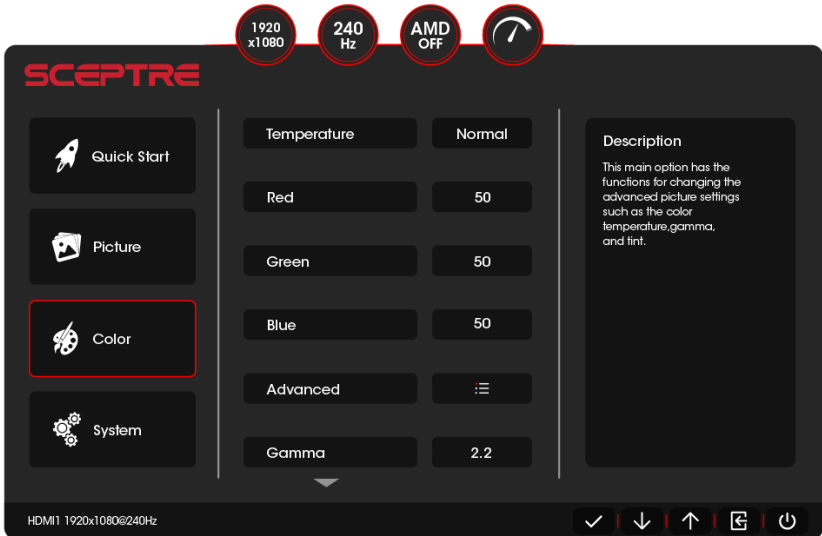

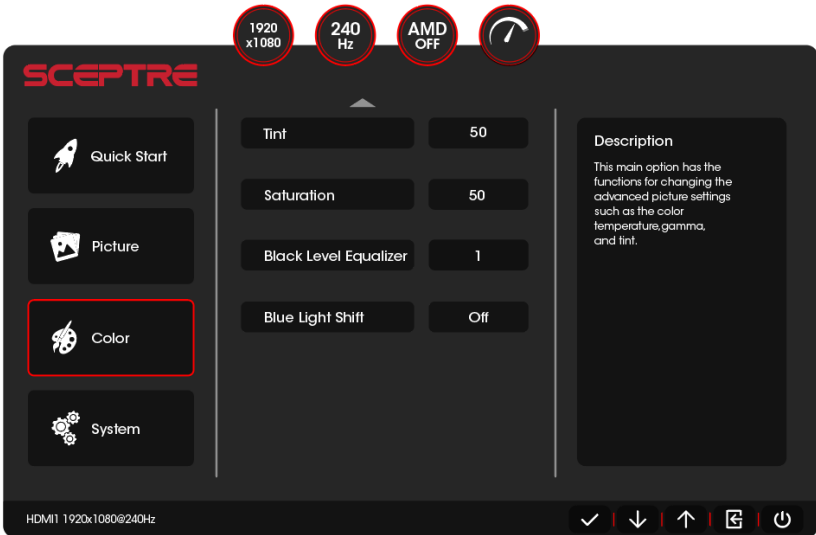
7. **SHARPNESS** – This option changes picture softness and clarity.

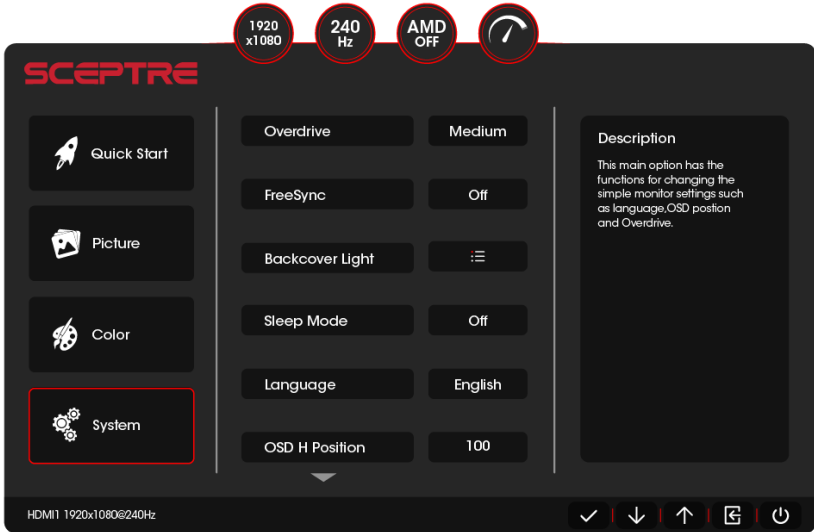
1. **TEMPERATURE** – This option adjusts the RGB Color scale of the monitor display.
  - a. **WARM** – This color temperature is for users who prefer a warm white balance.
  - b. **NORMAL** – This color temperature is for users who prefer a neutral white balance.
  - c. **COOL** – This color temperature is for users who prefer a cool white balance.
  - d. **USER** – This color temperature is for users who would like to adjust the RGB (red, green, blue) values manually.
2. **ADVANCED** – Adjusts the tint and saturation of the six colors (Red, Green, Blue, Cyan, Magenta, Yellow).
3. **GAMMA** – This option adjusts the picture's white color details.



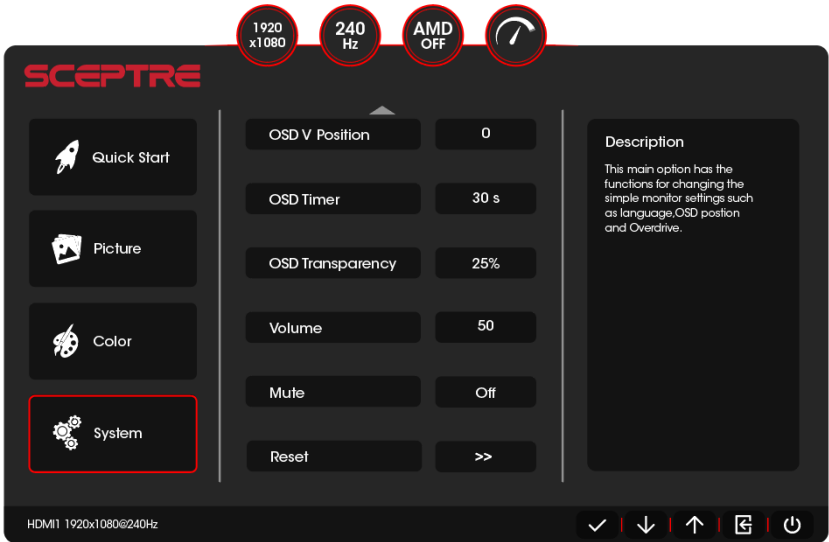


4. **TINT** – This option changes the color white balance.
5. **SATURATION** – This option changes the color saturation level.
6. **BLACK LEVEL EQUALIZER** – This option finetunes the black level of the monitor, allowing for clearer detail.
7. **BLUE LIGHT SHIFT** – This display adjusts the blue light value to reduce strain on eyes.

## SYSTEM



1. **OVERDRIVE** – This option adjusts overdrive levels, increasing panel performance.
2. **FREESYNC™** – This option turns on or off AMD FreeSync™, enabling smoother gameplay.
3. **BACKCOVER LIGHT** – This option cycles through different light modes from the LED lights that are from the back cover of the monitor.
4. **SLEEP MODE** – This option turns off the monitor if there has been no signal for a period of time.
5. **LANGUAGE** – This option changes the monitor menu language.
6. **OSD H POSITION** – This option moves the On-Screen Display (OSD) left or right.



7. **OSD V POSITION** – This option moves the On-Screen Display (OSD) up or down.
8. **OSD TIMER** – This option adjusts the On-Screen Display (OSD) screen time.
9. **OSD TRANSPARENCY** – This option adjusts the opacity of the On-Screen Display (OSD).
10. **VOLUME** – This option adjusts the loudness of the monitor speakers.
11. **MUTE** – This option turns on or off the Mute function, silencing the audio output of the monitor source.
12. **RESET** – This option resets the monitor to Sceptre's factory default settings.

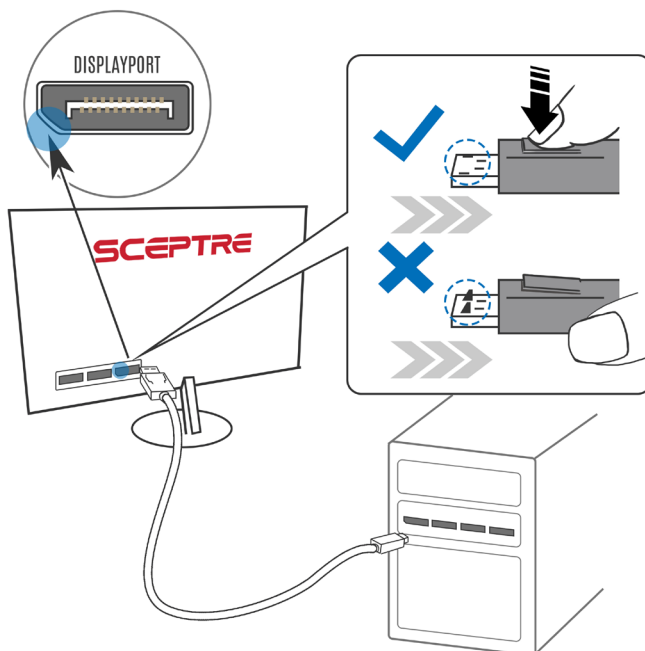

To detach the DP cable from the monitor, press down on the cables unlocking button while pulling the cable out.





# How do I clean the monitor?

---

## IMPORTANT

1. The power cable has to be removed from the socket before cleaning the display.
2. Do not use a volatile solvent (alcohol, rosin, and toluene) to clean the display. These types of chemicals might damage the housing and the LCD glass.

## Cleaning the bezel

1. Use a 100% cotton cloth or micro-fiber cloth for cleaning.
2. If the bezel is dirty to the point where you cannot simply dry-wipe it, please lightly dampen the wiping material with clean water and wipe again. Wipe the display with a dry microfiber cloth or 100% cotton cloth afterward.

Please Note:

- Make sure you wring the water out of the cloth before cleaning the bezel to prevent water from penetrating the electronics.

## Cleaning the Screen

1. Use a 100% cotton cloth or microfiber cloth for cleaning.
2. The LCD screen glass is extremely fragile. Do not scrape it with any material. Do not press or tap the screen to avoid cracking. When the screen is dirty to the point where you cannot simply dry-wipe it, please lightly dampen the wiping material with clean water and wipe again. Wipe the display with a dry microfiber cloth or 100% cotton cloth afterward.
