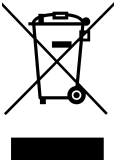

# IMPORTANT INFORMATION

This product is designed and manufactured to operate within defined design limits, and misuse may result in electric shock or fire. - To avoid the risk of electric shock or component damage, switch off the power before connecting other components to the display.

The SCEPTRE display is packaged in a carton. The size and weight of the product might be too heavy for 1 person to handle. In the event of that happening, it is recommended that the display package must be handled by a minimum of 2 or more persons. Since the glass can be easily scratched or broken, please handle the product gently. Never place the unit on a surface with the glass facing downwards unless it is on a protective padding. When opening the carton, check that the product is in good condition and that all standard accessories and items are included. ## Installation

---

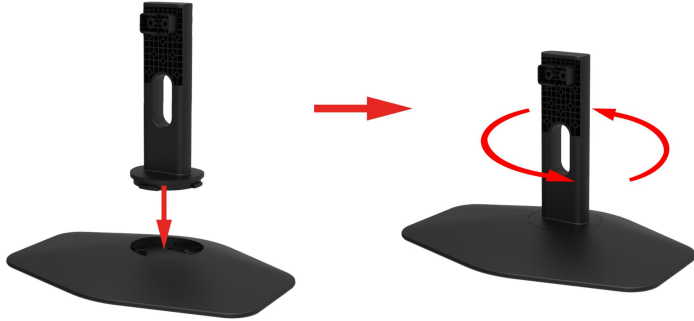
Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. Use only the Sceptre-provided power cable or AC adapter approved for use with this device. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom, or other places with high humidity, dust, or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and subsequent component damage.



# Installing the Monitor Stand Assembly

---

1. Insert the neck into the base with the front of the neck facing the left at 45-degree angle and twice the neck clockwise until you hear a click sound and the neck is facing forward aligned with the base.



2. Install the assembled stand to the back of the monitor and screw in the 2 neck screws to secure the stand to the monitor.



3. Insert the rubber cover to the back of the neck.
4. To finalize your installation of the display, please read the following:
  - a. If you are placing the display on a stand, we would recommend using a display safety strap (not included) to minimize the possibility of the display toppling over.
  - b. Securely install all screws and connections.

# Wall Mounting

---

1. To uninstall the stand assembly, lay the monitor facing downwards on a table. Remove the rubber cover and unscrew the two screws to remove the stand.



2. Install the wall mount plate to the back of the monitor using the provided **Wall Mount Plate Screws (M4 x 10mm)**.



3. Once the wall mount spacer screws are installed, the monitor is ready to be wall mounted. **The mounting pattern is 100mm.**

# Identifying Front and Rear Panel

---

## Front View








**Indicator Light** – The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

## Rear View with Buttons



**Buttons from left to right,**

1.  – This button activates the On-Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
2.  – When the OSD This option adjusts the loudness of the monitor speakers.
3.  – When the OSD Selects which input device is to be displayed on the monitor.
4.  – When the OSD Preset values that adjust color accordingly to your purpose of use.
5.  – When the OSD turns the display off.

## Panel Tilt Adjustment

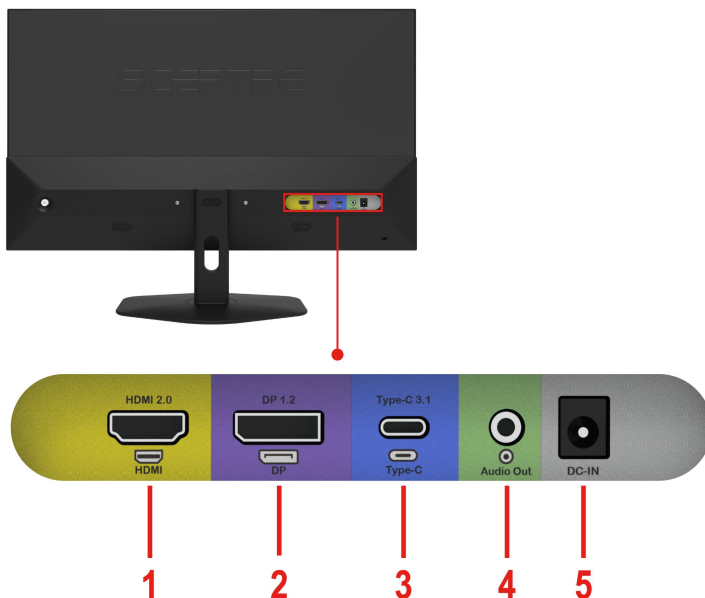


The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the particular model of the device. Generally, it may be inclined  $5^{\circ}\pm 1^{\circ}$  forward and  $15^{\circ}\pm 2^{\circ}$  backward.

Please Note:

- When adjusting the angle of the monitor, be sure not to touch or press the LCD screen.

## Rear View with Connections



1. **HDMI** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video and audio output. HDMI is HDMI v2.0.
2. **DISPLAYPORT** – DisplayPort is a digital video connection for connection to computers with display port video and audio output. DisplayPort is DP v1.2.
3. **TYPE-C** – USB Type-C DisplayPort utilizes the flexible USB-C port to connect to all types of versatile devices, carrying video and audio output to your monitor. USB-C Port is USB v3.1.
4. **AUDIO OUT (3.5mm Mini-jack)** – This connection is for audio out from the monitor to multimedia speakers or headphones.
5. **POWER** – This plug is responsible for providing power to the monitor. Use it with the included AC adapter.

MONITOR SAYS "SIGNAL OUT OF RANGE"	<p>If you have a CRT monitor, please connect the CRT monitor to the computer and change the refresh rate down to 60Hz via your video card's display settings menu. After the setting of 60Hz has been changed; you can then use the E24 LED Monitor on the computer.</p> <ol style="list-style-type: none"> <li>1. To change the setting, go to display settings by right-clicking on your desktop with nothing selected. Choose the PROPERTIES option.</li> <li>2. Click on the SETTINGS tab, verify the resolution is NOT higher than 1920 x 1080, and click on the ADVANCED button.</li> <li>3. 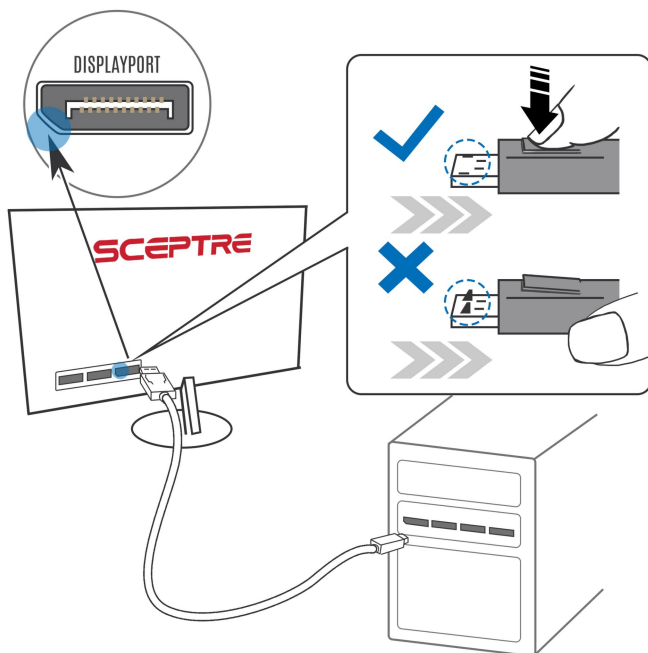

To detach the DP cable from the monitor, press down on the cables unlocking button while pulling the cable out.



# How do I clean the monitor?

---

## IMPORTANT

1. The power cable has to be removed from the socket before cleaning the display.
2. Do not use a volatile solvent (alcohol, rosin, and toluene) to clean the display. These types of chemicals might damage the housing and the LCD glass.

## Cleaning the bezel

1. Use a 100% cotton cloth or micro-fiber cloth for cleaning.
2. If the bezel is dirty to the point where you cannot simply dry wipe it, please lightly dampen the wiping material with clean water and wipe again. Wipe the display with a dry microfiber cloth or 100% cotton cloth afterward.

Please Note:

- Make sure you wring the water out of the cloth before cleaning the bezel to prevent water from penetrating the electronics.

## Cleaning the Screen

1. Use a 100% cotton cloth or microfiber cloth for cleaning.
2. The LCD screen glass is extremely fragile. Do not scrape it with any material. Do not press or tap the screen to avoid cracking. When the screen is dirty to the point where you cannot simply dry wipe it, please lightly dampen the wiping material with clean water and wipe again. Wipe the display with a dry microfiber cloth or 100% cotton cloth afterward.
