The SCEPTRE display is packaged in a carton. The size and weight of the product might be too heavy for 1 person to handle. In the event of that happening, it is recommended that the display package must be handled by a minimum of 2 or more persons. Since the glass can be easily scratched or broken, please handle the product gently. Never place the unit on a surface with the glass facing downwards unless it is on protective padding. When opening the carton, check that the product is in good condition and that all standard accessories and items are included. # Installation

---

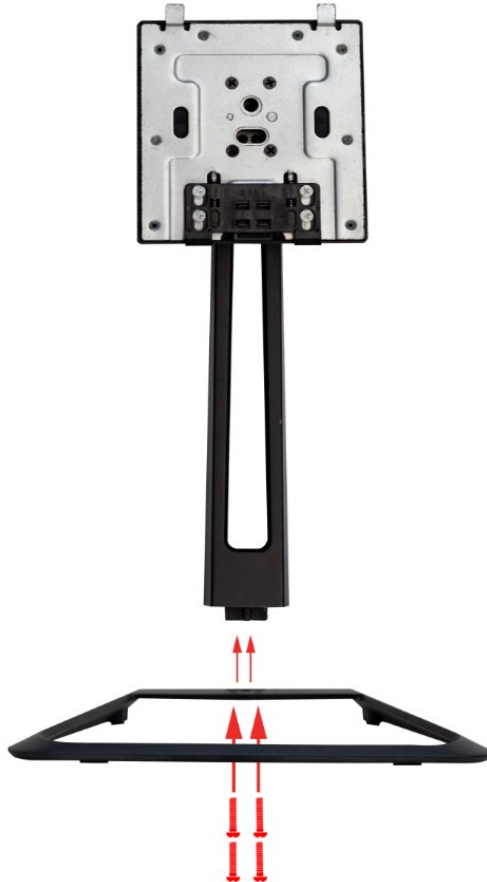
Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and successive component damage.



# Assembling the Stand

---

1. With the packing foam still on, lay the monitor screen facing down on a table and open the top half of the packing foam. Install the neck to the base and insert the 4 base screws from the bottom. Tighten the screws to secure the base.



2. Insert the neck into mounting hole , then press down until you hear the locking clip lock down.



3. To finalize your installation of the display, please read the following:
  - a. If you are placing the display on a stand, we would recommend you to use a display safety strap (not included) in order to minimize the possibility of the display toppling over.
  - b. If you are mounting the display on the wall
    - i. Make sure the wall is structurally safe for the weight of the display.
    - ii. Make sure the wall mount kit is compatible with the display.
    - iii. Read and follow all instructions provided by the wall mounting kit.
    - iv. Securely install all screws and connections.

# Disassembling the Stand for Wall Mounting

---

1. Lay the monitor down on a flat surface with the screen facing downwards. Remove the stand assembly by unlocking the locking clip.



2. The mounting pattern is 100mm x 100mm using M4 x 10mm screws. Please install the provided wall-mount spacers into the VESA mounting pattern.

# Identifying Front and Rear Panel

---

## Front View



**Indicator Light** – The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

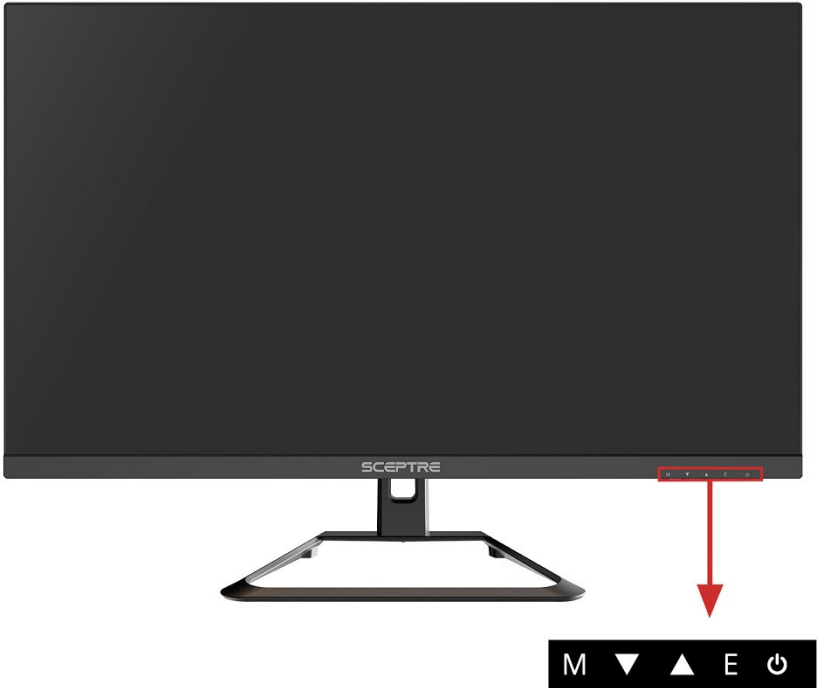
## Panel Tilt Adjustment

The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the specific model of the device. Generally, it may be inclined  $-5^{\circ} \sim 15^{\circ}$ .

Please Note:

- When adjust the angle of the monitor, be sure not to touch or press the LCD screen.

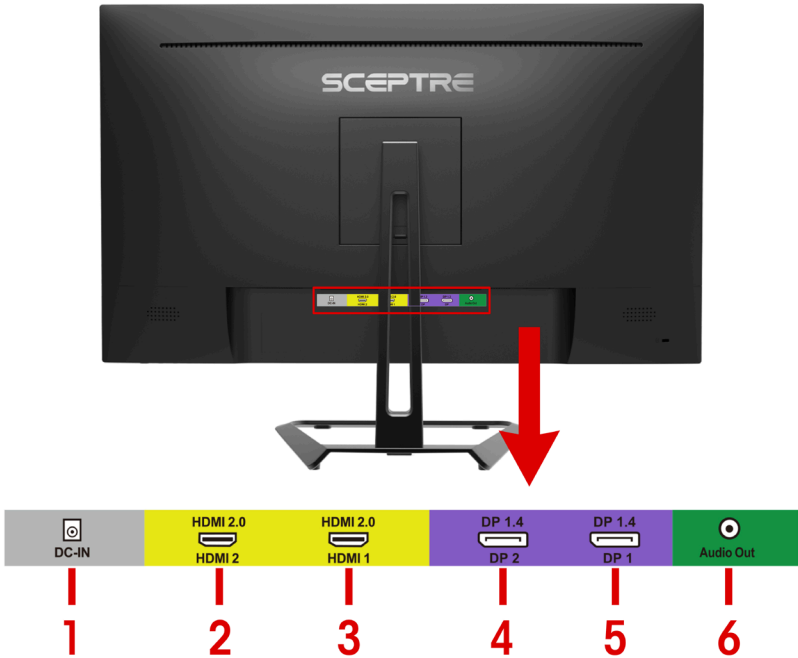
## Rear View with Buttons



### Buttons from left to right.

1. **M** – This button activates the On-Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
2. **▼** – With no OSD, this button decreases the volume of the monitor's speakers. With the OSD turned on, this button moves the selection downwards. This button will also decrease the value of an adjustment while an option is open.
3. **▲** – With no OSD, this button increases the volume of the monitor's speakers. With the OSD turned on, this button moves the selection upwards. This button will also increase the value of an adjustment while an option is open.
4. **E** – When the OSD is active, this button acts as the EXIT button and exits out of the option or OSD. This button switches between all the different inputs of the display.
5. **⏻** – This button turns the display on or off.

## Rear View with Connections



1. **POWER** – This plug is responsible for providing power to the monitor. Use it with the included AC adapter.
2. **HDMI 2** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video and audio output. The HDMI port version is 2.0.
3. **HDMI 1** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video and audio output. The HDMI port version is 2.0.
4. **DP 2** – DisplayPort is a digital video connection for connection to computers with display port video and audio output. DisplayPort is DP v1.4.
5. **DP 1** – DisplayPort is a digital video connection for connection to computers with display port video and audio output. DisplayPort is DP v1.4.
6. **AUDIO OUT (3.5mm Mini-jack)** – This connection is for audio out from the monitor to multimedia speakers or headphones.

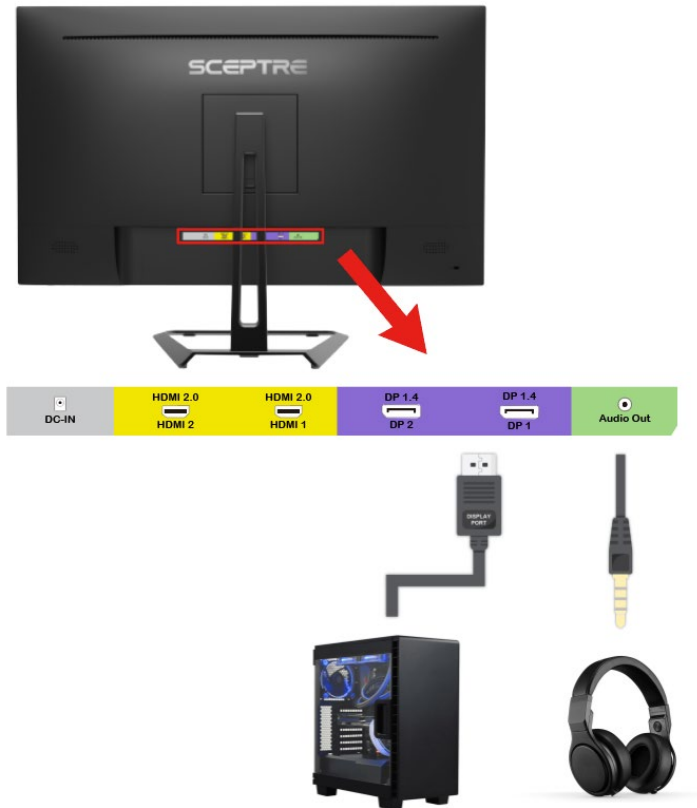
## If You have HDMI Connection on Your Video Card...

## If You have DisplayPort Connection on Your Video Card...

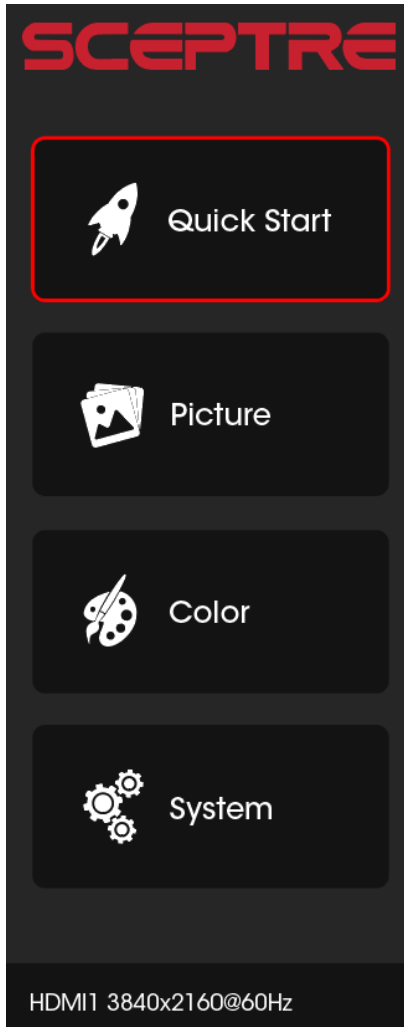


1. Make sure the power of the U27 LED MONITOR is turned off.

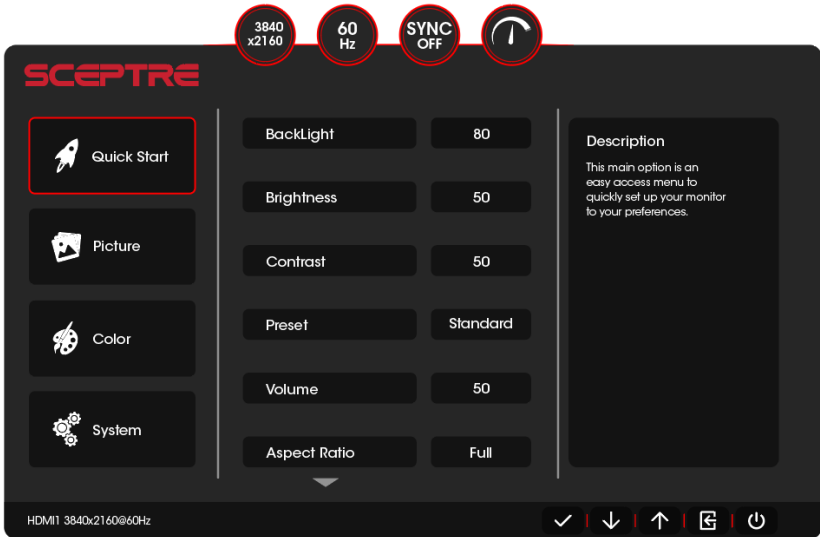
The OSD menu of the monitor provides various adjustments for the monitor such as color, brightness, and contrast .... etc.



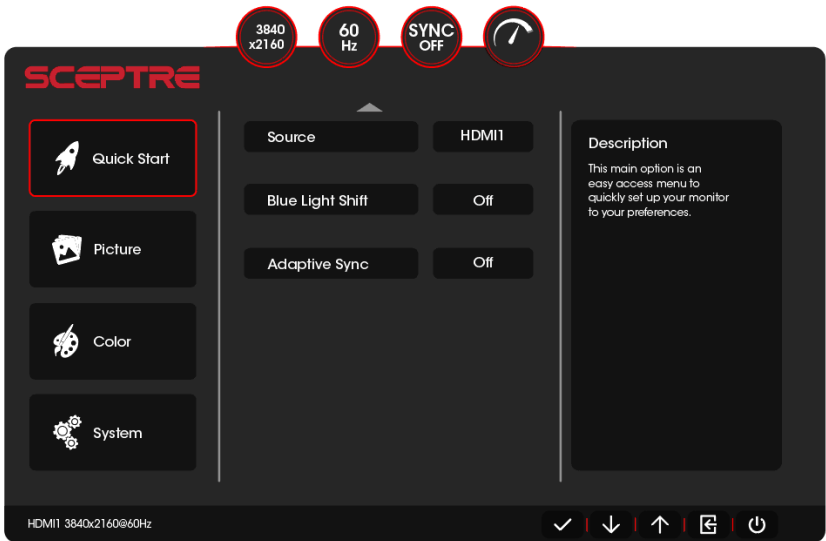
When you press the **M** button on the monitor, the OSD screen will appear. Select each of the functions with the **▲** or **▼** buttons. Use the **M** button again to enter each of the functions, or when you are in the function already, use the **M** button to select the option you want to adjust. Use the **▲** or **▼** buttons to adjust each option's values. When you want to exit, press the **E** button.

## QUICK START

Quick Start offers users a variety of often adjusted options for users.

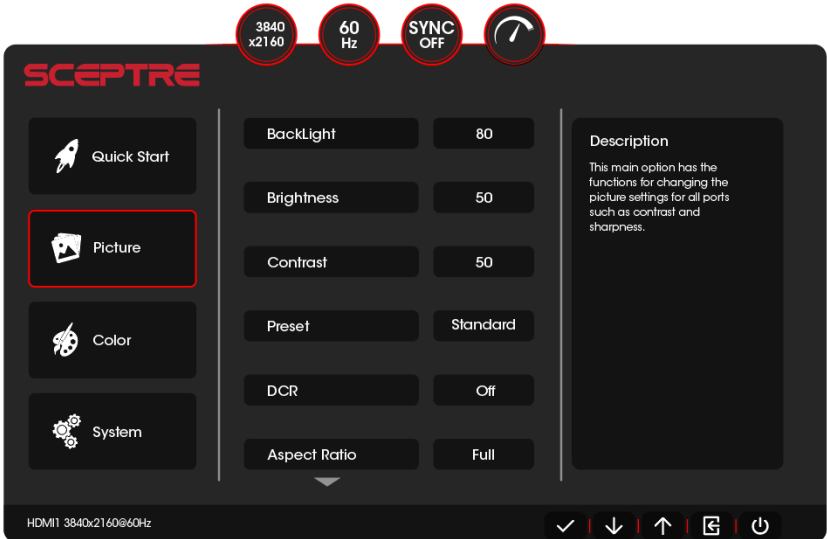

4. **LANGUAGE** – This option changes the monitor menu language.

6. **OSD V POSITION** – This option adjusts the On-Screen Display (OSD) up or down.



7. **OSD TIMER** – This option adjusts the time it takes for the OSD menu to automatically shut off.

# Troubleshooting

Problem	Possible solutions
THERE IS NO LED DISPLAY or SCREEN SAYS NO SIGNAL	<p>Make sure you switched to the correct source. Check both sources to see the video is on the other source. Check your video cable. It might be corrupt. Swap out the video cable for another one to see if the monitor will work. Check your power plug. See if it is fully plugged in on both the monitor and the wall.</p>
MONITOR SAYS "SIGNAL OUT OF RANGE"	<p>If you have a CRT monitor, please connect the CRT monitor to the computer and change the refresh rate down to 60Hz via your video card's display settings menu. After the setting of 60Hz has been changed; you can then use the LED Monitor on the computer.</p> <ol style="list-style-type: none"> <li>1. To change the setting, go to display settings by right-clicking on your desktop with nothing selected. Choose the PROPERTIES option.</li> <li>2. Click on the SETTINGS tab, verify the resolution is NOT higher than 3840 x 2160, and click on the ADVANCED button.</li> <li>3. 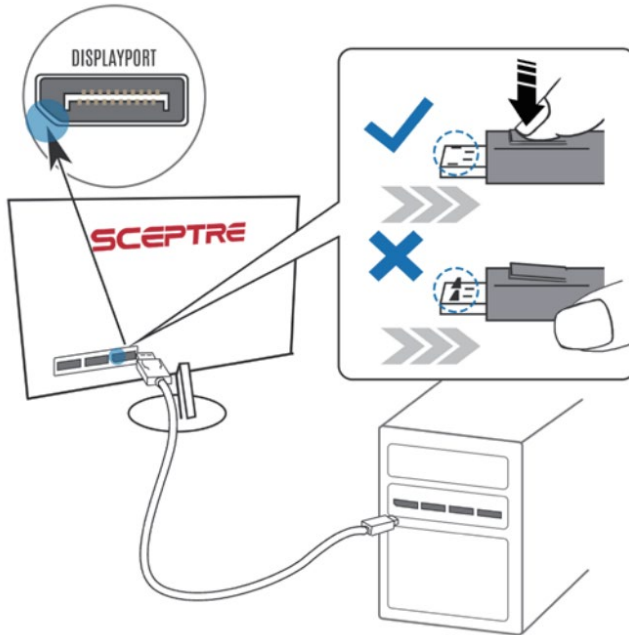

To detach the DP cable from the monitor, press down on the cables unlocking button while pulling the cable out.



# How do I clean the LED Monitor?

## IMPORTANT

1. The power cable has to be removed from the socket before cleaning the display.
2. Do not use volatile solvent (alcohol, rosin, and toluene) to clean the display. These types of chemicals might damage the housing and the LCD glass.

## Cleaning the bezel

1. Use a 100% cotton cloth or micro-fiber cloth for cleaning.
2. If the bezel is dirty to the point where you cannot simply dry wipe it, please lightly dampen the wiping material with clean water and wipe again. Wipe the display with a dry micro-fiber cloth or 100% cotton cloth afterwards.

### Please Note:

- Make sure you wring the water out of the cloth before cleaning the bezel in order to prevent water from penetrating into the electronics.

## Cleaning the Screen

1. Use a 100% cotton cloth or micro-fiber cloth for cleaning.
2. The LCD screen glass is extremely fragile. Do not scrape it with any material. Do not press or tap the screen to avoid cracking. When the screen is dirty to the point where you cannot simply dry wipe it, please lightly dampen the wiping material with clean water and wipe again. Wipe the display with a dry micro-fiber cloth or 100% cotton cloth afterwards.
