

Installation

Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. Use only the Sceptre-provided power cable or AC adapter approved for use with this device. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom, or other places with high humidity, dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and subsequent component damage.

Installing the Monitor Stand Assembly

 Take the monitor with packing foam out of the box. Lay the monitor screen facing down on a table with the monitor still resting on the packing foam. Obtain the display base and attach it to the display neck. While the neck is attached to the base, insert and tighten 3 base screws to the bottom of the base.



Open the packing foam with the monitor resting facing downwards. Take the assembled stand piece and insert it headfirst into the circular opening on the back of the monitor.





- 3. Once inserted, press downwards on the neck until you hear a click sound.
- 4. To finalize your installation of the display, please read the following:
 - a. If you are placing the display on a stand, we would recommend using a display safety strap (not included) to minimize the possibility of the display toppling over.
 - b. Securely install all screws and connections.

Wall Mounting

 To prepare the monitor for wall mounting, remove the backplate by pushing up on the lever near the neck joint with the monitor and lifting the stand piece upwards. Once the stand is lifted upwards, you can slide out the entire stand assembly.





 With the square indentation now open to you, install 4 spacers by screwing them in. Once spacers are tightened, the monitor is ready to be mounted.
 The mounting pattern is 100mm x 100mm.




Identifying Front and Rear Panel

Front View



Indicator Light – The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

Rear View



The stand covers the mounting holes. Once you remove the stand, you will need to attach a mounting plate to wall mount the monitor. The mounting pattern is $100 \text{mm} \times 100 \text{mm}$ using M4 x 10 mm screws.

Front View with Buttons



Buttons from left to right:

- 1. **M** This button activates the On-Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
- ▼ With no OSD, this button opens the Volume OSD and decreases the
 monitor's volume output. With the OSD turned on, this button moves the selection
 downwards. This button will also decrease the value of an adjustment while an
 option is open.
- A With no OSD, this button opens the Volume OSD and increases the monitor's volume output. With the OSD turned on, this button moves the selection upwards. This button will also increase the value of an adjustment while an option is open.
- E When the OSD is active, this button acts as the EXIT button and exits out of the option or OSD. This button switches between all the different inputs of the display.
- 5. U This button turns the display on or off.




Problem	Possible solutions	
THERE IS NO LED DISPLAY or SCREEN SAYS NO SIGNAL	Make sure you switched to the correct source. Check both sources to see the video is on the other source. Check your video cable. It might be corrupt. Swap out the video cable for another one to see if the monitor will work. Check your power plug. See if it is fully plugged in on both the monitor and the wall.
