Installation

Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom, or other places with high humidity, dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and subsequent component damage.

Installing the Monitor Stand Assembly

 With the packing foam still on, lay the monitor screen facing down on a table and open the top half of the packing foam. Obtain the neck and base piece. Connect the neck to the base piece.




Secure the base by inserting and tightening the base screw provided from the bottom of the base.



Insert the neck into the mounting hole , then press down until you hear the locking clip lockdown.



4. Align the cable clip with the hole on the display neck, and then snap it in.



- 5. To finalize your installation of the display, please read the following:
 - a. If you are placing the display on a stand, we would recommend you use a display safety strap (not included) in order to minimize the possibility of the display toppling over.
 - b. Securely install all screws and connections.

Preparing the Monitor for Wall Mount

With the packing foam still on, lay the monitor screen facing down on a table and open the top half of the packing foam. Looking at the back of the monitor, you will see a plastic cover that you can take off. Please remove the neck plate from the monitor. Once removed, please look for four screw holes marked below in red. Please install the 4 Wall-mount Stand-offs in these screw holes.





2. Align the Wall-Mount Plate that is included with your monitor. Screw in the plate with the provided Wall-Mount screws.



3. The mount specification is 75mm x 75mm using M4 screws.



Identifying Front and Rear Panel

Front View



Indicator Light –The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

Rear View



Panel Swivel Adjustment



The monitor stand can swivel 15°±2°.

Panel Tilt Adjustment



The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the particular model of the device. Generally, it may be inclined 5°±1°forward and 15°±2° backward.

Panel Height Adjustment

The screen height can be adjusted by 4.13" in height.






Problem	Possible Solutions
Problem THERE IS NO LED DISPLAY OF SCREEN SAYS NO SIGNAL MONITOR SAYS "SIGNAL OUT OF RANGE"	Make sure you switched to the correct source. Check both sources to see if the video is on the other source. Check your video cable. It might be corrupt. Swap out the video cable for another one to see if the monitor will work. Check your power plug. See if it is fully plugged in on both the monitor and the wall. If you have a CRT monitor, please connect the CRT monitor to the computer and change the refresh rate down to 60 Hz via your video card's display settings menu. After the setting of 60 Hz has been changed; you can then use the LED on the computer. 1. To change the setting, go to display settings by right-clicking on your desktop with nothing selected. Choose the PROPERTIES option. 2. Click on the SETTINGS tab, verify the resolution is NOT higher than 2560 x 1440, and click on the ADVANCED button. 3. Click on the MONITOR tab and change the refresh rate to 60 Hz. 4. Click on OK 2-3 times to finalize your change. If you do NOT have a CRT monitor or it is already broken, please make sure both the E27 LED monitor and your computer is turned off. 1. Turn on the LED monitor and the computer. 2. While the computer is turned on, press the "F8" key on your keyboard continuously until a selection menu appears and select the "Safe Mode" option. 3.
