Installation


Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. Use only the Sceptre provided power cable or AC adapter approved for use with this device. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and successive component damage.

Installing the Monitor Stand Assembly

1. With the packing foam still on, lay the monitor screen facing down on a table and open the top half of the packing foam. Install the neck to the base and insert the 2 base screws from the bottom. Tighten the screws to secure the base.



2. Install the assembled stand to the back of the monitor and screw in the 2 neck screws to secure the stand to the monitor.



- 3. Insert the rubber cover to the back of the neck.
- 4. To finalize your installation of the display, please read the following:
 - If you are placing the display on a stand, we would recommend you to use a display safety strap (not included) in order to minimize the possibility of the display toppling over.
 - b. Securely install all screws and connections.

Removing the Stand for Wall Mounting

1. To uninstall the stand assembly, lay the monitor facing downwards on a table. Remove the rubber cover and unscrew the two screws to remove the stand.



2. The mounting pattern is 100mm x 100mm using M4 x 10mm screws.

Identifying Front and Rear Panel

Front View



Indicator Light – The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

Panel Tilt Adjustment

The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the specific model of the device. Generally, it may be inclined $-5^{\circ} \sim 15^{\circ}$.

Please Note:

When adjust the angle of the monitor, be sure not to touch or press the LCD screen.


Rear View with Buttons



Buttons from right to left

- 1. This button activates the On Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
- ▲ With no OSD, this button increases the volume of the monitor's speakers. With the OSD turned on, this button moves the selection upwards. This button will also increase the value of an adjustment while an option is open.
- ▼ With no OSD, this button decreases the volume of the monitor's speakers. With the OSD turned on, this button moves the selection downwards. This button will also decrease the value of an adjustment while an option is open.
- 4. S When the OSD is active, this button acts as the EXIT button and exits out of the option or OSD. This button switches between all the different inputs of the display.
- 5. \mathbf{U} This button turns the display on or off.

Rear View with Connections



- 1. **POWER** This plug is responsible for providing power to the monitor. Use it with the included AC adapter.
- HDMI 1-3 HDMI stands for High Definition Multimedia Interface. This connection is for computers with HDMI video output. HDMI1 is version 2.0 while HDMI2's and HDMI3's version is 1.4.
- 3. **DISPLAYPORT** Displayport is a digital video connection for connection to computers with display port video output.
- 4. **AUDIO OUT (3.5mm Mini-jack)** This connection is for audio out from the monitor to multimedia speakers or headphones.



If You have DisplayPort Connection on Your Video Card...



- 1. Make sure the power of the E27 LED MONITOR is turned off.
- 2. Obtain a DisplayPort cable and connect one end to the back of the monitor and the other end to the back of the computer.
- 3. Turn on the power of both the E27 LED MONITOR and the computer.

On Screen Display (OSD) Menu

The OSD menu of the monitor provides various adjustments for the monitor such as color, brightness, and contrastetc.
