## Installation

Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. Use only the Sceptre provided power cable or AC adapter approved for use with this device. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and successive component damage.

# **Installing the Monitor Stand Assembly**

 With the packing foam still on, lay the monitor screen facing down on a table and open the top half of the packing foam. Install the neck to the base and insert the one base screw from the bottom. Tighten the screws to secure the base.



Align the monitor stand with the four screw holes marked in red. Once the stand has been aligned, please use a screw driver to install the four provided Neck Screws (M4 x 10mm).




- 3. To finalize your installation of the display, please read the following:

# **Identifying Front and Rear Panel**

#### **Front View**



**Indicator Light** – The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

# **Panel Tilt Adjustment**

The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the specific model of the device. Generally, it may be tilted -5 $^{\circ}$  ~ 15 $^{\circ}$ .

#### Please Note:

 When adjust the angle of the monitor, be sure not to touch or press the LCD screen.

### Buttons from right to left

- 1. U This button turns the display on or off.






