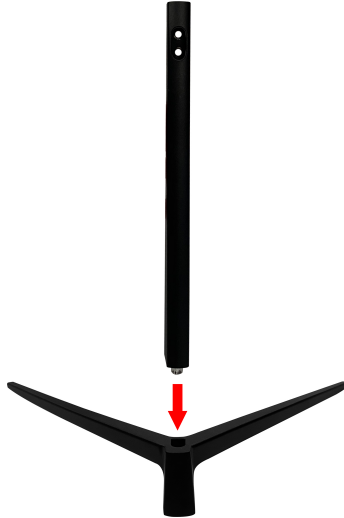

Installation

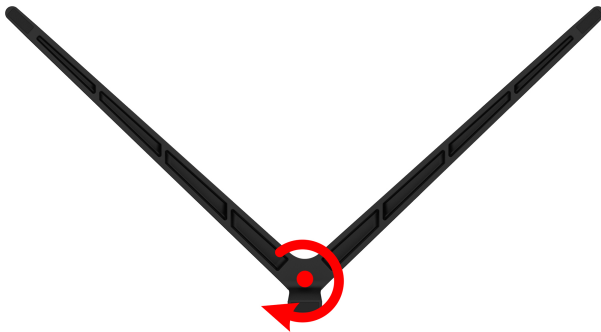
Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and successive component damage.

Installing the Monitor Stand Assembly

1. With the packing foam still on, lay the monitor screen facing down on a table and open the top half of the packing foam. Obtain the neck and base piece. Connect the neck to the base piece.



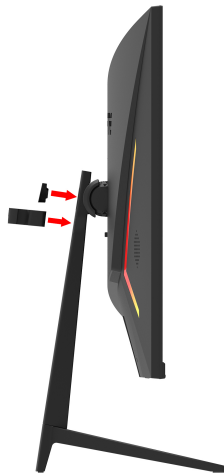
2. Secure the base by inserting and tightening the base screw provided from the bottom of the base.



3. Fix the neck and lock it with 2pcs M4*8 screws



4. Align the rubber piece and cable clip with the hole on the display neck, and then snap it in.



5. To finalize your installation of the display, please read the following:
 - a. If you are placing the display on a stand, we would recommend you use a display safety strap (not included) in order to minimize the possibility of the display toppling over.
 - b. Securely install all screws and connections.

Preparing the Monitor for Wall Mount

1. With the packing foam still on, lay the monitor screen facing down on a table and open the top half of the packing foam. Looking at the back of the monitor you will see a plastic cover that you can take off. Please remove the neck plate from the monitor. Once removed, please look for four screw holes marked below in red. Please install the 4 Wall-mount Stand-offs in these screw holes.



2. Align the Wall-Mount Plate that is included with your monitor. Screw in the plate with the provided Wall-Mount screws.



3. The mount specification is 75mm x 75mm using M4 screws.

Front View



Indicator Light –The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

Rear View

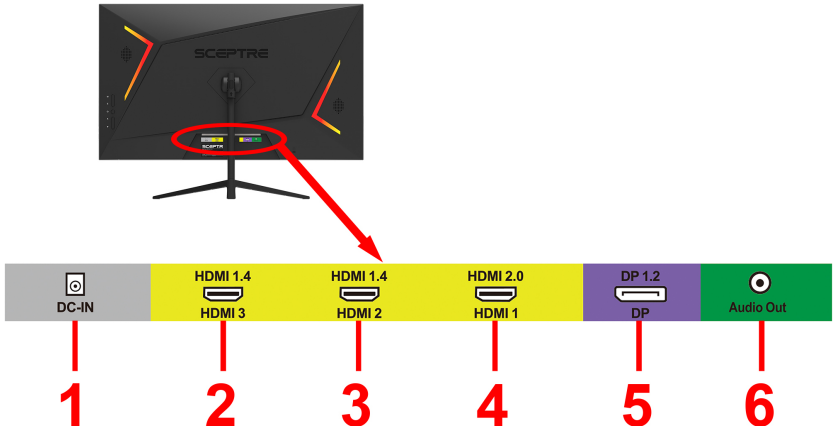


Rear View with Buttons



1. **M** – This button activates the On-Screen Display (OSD). While the OSD is active, this button will act as the select button to open an option for adjustment.
2. **E** – When the OSD is active, this button acts as the EXIT button and exits out of the option or OSD. This button switches between all the different inputs of the display.
3. **Power** – This button turns the display on or off.
4. **▲** – With no OSD, this button will also increase the volume of the internal speaker. With the OSD turned on, this button moves the selection upwards.
5. **▼** – With no OSD, this button will also decrease the volume of the internal speaker. With the OSD turned on, this button moves the selection downwards.

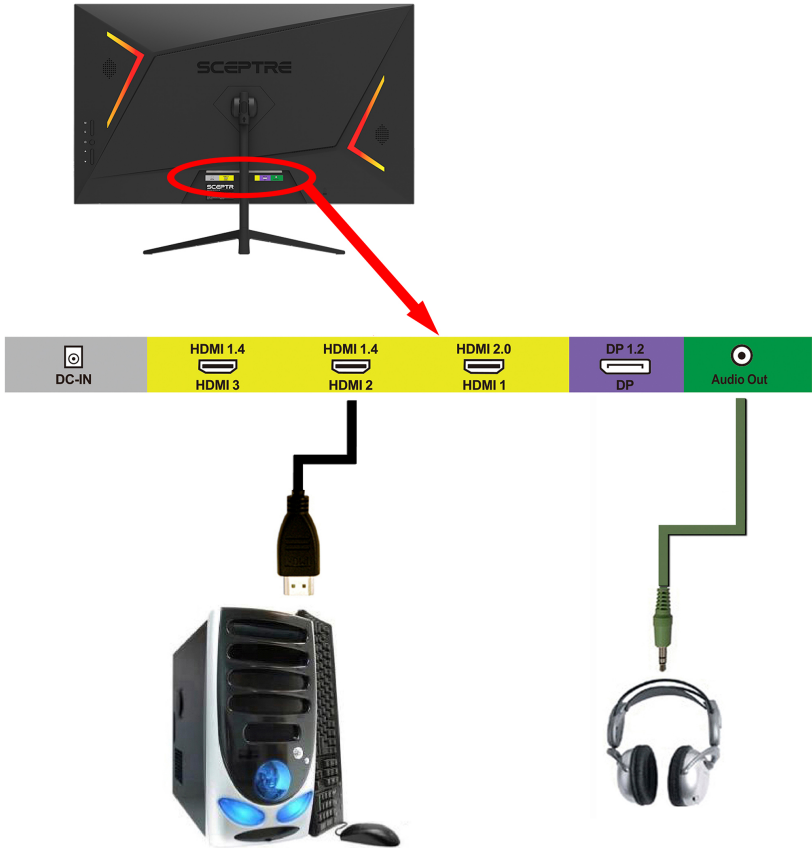
Rear View with Connections



1. **DC-IN** – This plug is responsible for providing power to the monitor. Use it with the included AC adapter.
2. **HDMI 3** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video output. This connection supports up to 144Hz refresh rate.
3. **HDMI 2** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video output. This connection supports up to 144Hz refresh rate.
4. **HDMI 1** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video output. This connection supports up to 165Hz refresh rate.
5. **DP** – DisplayPort (DP) is a digital video connection for connection to computers with DisplayPort video output. This connection supports up to 165Hz refresh rate.
6. **AUDIO OUT (3.5mm Mini-jack)** – This connection is for audio out from the monitor to multimedia speakers or headphones.

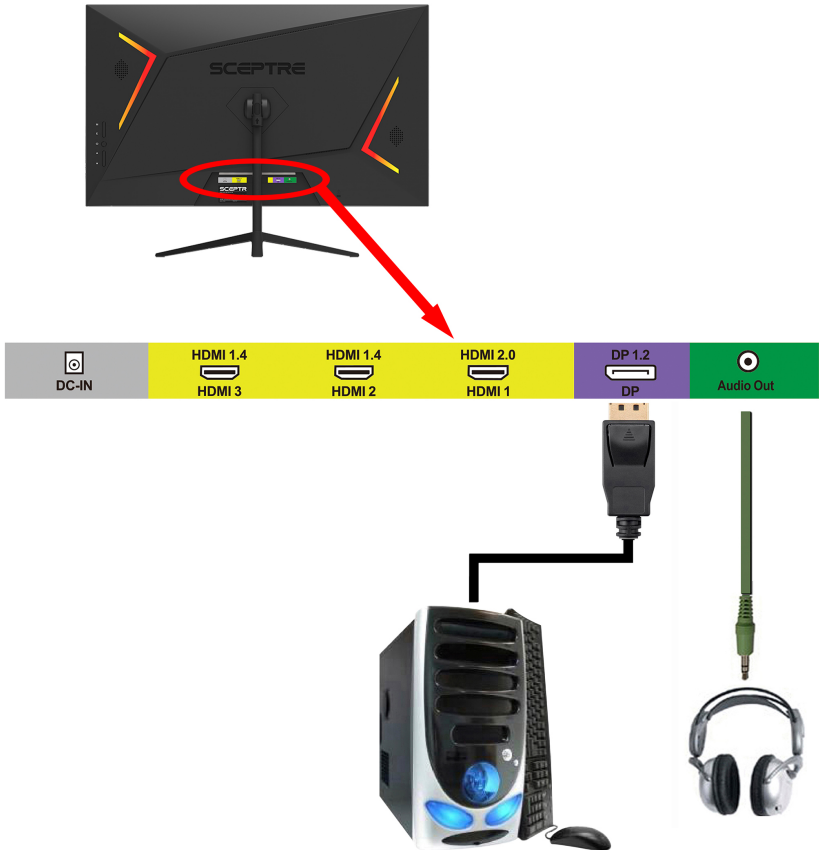


1. Make sure the power of the E27 LED MONITOR is turned off.
2. Obtain a HDMI cable and connect one end to the back of the monitor and the other end to the back of the computer.
3. Turn on the power of both the E27 LED MONITOR and the computer.

- This connection supports up to 144Hz (HDMI2, HDMI3) refresh rate.

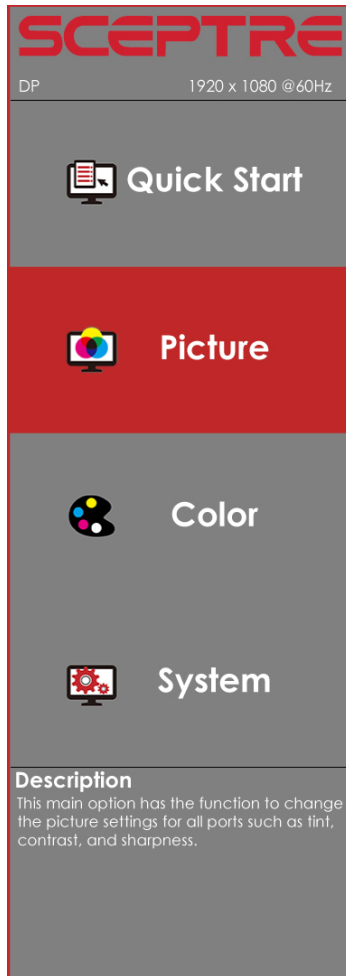
1. Make sure the power of the E27 LED MONITOR is turned off.

3. Obtain a 3.5mm mini-jack cable connect one end to the audio out of your PC. Connect the other end of the cable to your E27 LED MONITOR's audio in.
4. Turn on the power of both the E27 LED MONITOR and the computer.



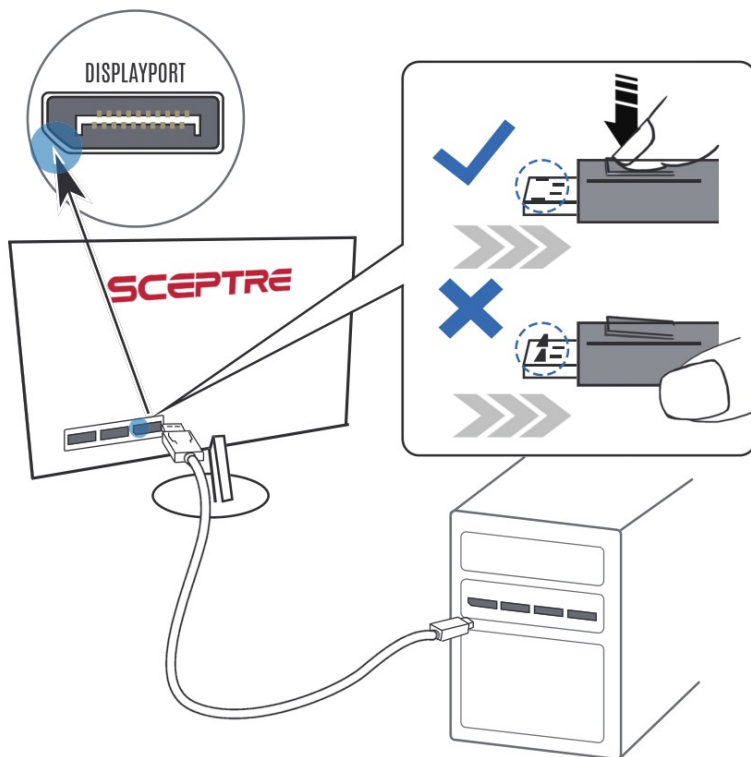

How do I detach the DisplayPort Cable?

To detach the DP cable from the monitor, press down on the cables unlocking button while pulling the cable out.



How do I clean the LED Monitor?

IMPORTANT

1. The power cable must be removed from the socket before cleaning the display.
2. Do not use volatile solvent (alcohol, rosin, and toluene) to clean the display. These types of chemicals might damage the housing and the LCD glass.

Cleaning the bezel
