This product is designed and manufactured to operate within defined design limits, and misuse may result in electric shock or fire. 

Installation


Please read the user manual carefully before performing the installation. Please use the AC Adapter designated for the product. When an extension cord is required, use one with the correct power rating. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. If you would like to mount the display onto the wall, please be sure to read all instructions provided by the display mounting company and this manual. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and successive component damage.

Assembling the Stand

1. Clear the table. Obtain the display base and set it flat on a table. Obtain the display neck and insert the display neck into the display base, clockwise rotation until you hear a light click.




2. Obtain the display and lay it flat on a table with the screen side facing downwards. Slide the neck + base display stand assembly into the indentation on the lower back of the monitor.



3. To finalize your installation of the display, please read the following:
 - a. If you are placing the display on a stand, we would recommend you to use a display safety strap (not included) in order to minimize the possibility of the display toppling over.
 - b. If you are mounting the display on the wall
 - i. Make sure the wall is structurally safe for the weight of the display
 - ii. Make sure the wall mount kit is compatible with the display
 - iii. Read and follow all instructions provided by the wall mounting kit.
 - iv. Securely install all screws and connections.

Disassembling the Stand

1. To disassembly the base, place the monitor face down on a flat, smooth surface and look at the bottom of the base. You will see two small plastic buckles that secure the base. **Lightly pinch the buckles** and pull the base off.
2. To disassemble the neck press the button on the back of the monitor and slide out the neck.



Please Note:

The buckle at the bottom of the base is made of plastic. Users are cautioned not to apply too much force.



Rear View Mounting Pattern




Mounting Specification: **100mm x 100mm** using screw size **M4**. Length of screw should not exceed **14mm**. Please Note: The **14mm** length of screw refers to how deep the screw can go inside the mounting holes. When you're buying screws, you should add the original 14mm to the thickness of your mounting plate in order to get the total screw length.

Rear Control Buttons



1. **M** – This button activates the On Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
2. **◀** – With no OSD, this button will also decrease the volume of the internal speaker. With the OSD turned on, this button moves the selection downwards.
3. **▶** – With no OSD, this button will also increase the volume of the internal speaker. With the OSD turned on, this button moves the selection upwards.
4. **E** – When the OSD is active, this button acts as the EXIT button and exits out of the option or OSD. This button switches between all the different inputs of the display.
5.  – This button turns the display on or off.

Rear View Connections



1. **HDMI 2** – HDMI stands for High Definition Multimedia Interface. This connection is for computers with HDMI video output.
2. **HDMI 1** – HDMI stands for High Definition Multimedia Interface. This connection is for computers with HDMI video output.
3. **VGA** – VGA stands for Video Graphics Array. This connection is for computers to send video signals to the monitor by an analog signal. This method of connection is the most commonly used connection.
4. **AUDIO IN** – This connection is for audio in from the computer going into the monitor. This connection is used with VGA.
5. **AUDIO OUT** – This connection is for connecting to 3.5mm mini-jack headphones or audio out to multimedia speakers.
6. **DC IN** – This connection is for electricity supplied from the included power adapter.




1. Make sure the power of the E27 LED MONITOR is turned off.
2. Obtain a HDMI cable and connect one end to the back of the monitor and the other end to the back of the computer.
3. Turn on the power of both the E27 LED MONITOR and the computer.

Please Note:

- Make sure to set audio output from your computer to PCM output.

If You have VGA Connection on Your Video Card...




1. Make sure the power of E27 LED MONITOR is turned off.
2. **If you were previously using a CRT (bulky) monitor**, please hook up your old monitor first and make sure your refresh rate is set to 75 Hz frequency before using the E27 LED MONITOR. You can find the refresh rate information and change it by RIGHT CLICKING on the desktop with nothing selected. After you have right clicked, select the PROPERTIES option. Click on the SETTINGS tab. Click on the ADVANCED button. Click on the MONITOR tab. In that tab, change the refresh rate to 75 Hz and click on APPLY. After the refresh rate changed, please shut down the computer and monitor.
3. Obtain the VGA cable and connect to the VGA connection on your PC. Connect the other end of the cable to your E27 LED MONITOR.
4. Turn on the power of both the E27 LED MONITOR and the PC.

Please Note:

- The PC's clearest picture is ran with 1920 x1080 at 75 Hz.
- If the VGA port receives no signal for over 1 hour, the monitor will auto shut-off.

On Screen Display (OSD) Menu

The OSD menu of the monitor provides various adjustments for the monitor such as color, brightness, and contrastetc.



When you press the **M** button on the monitor, the OSD screen will appear. Select each of the functions with the ◀ or ▶ buttons. Use the **M** button again to enter each of the function or when you're in the function already, use the **M** button to select the option you want to adjust. Use the ◀ or ▶ buttons to adjust each option's values. When you want to exit press the **E** button.

How do I clean the LED Monitor?

IMPORTANT

1. The power cable has to be removed from the socket before cleaning the display.
2. Do not use volatile solvent (alcohol, rosin, and toluene) to clean the display. These types of chemicals might damage the housing and the LCD glass.

Cleaning the bezel

1. Use a 100% cotton cloth or micro-fiber cloth for cleaning.
2. If the bezel is dirty to the point where you cannot simply dry wipe it, please lightly dampen the wiping material with clean water and wipe again. Wipe the display with a dry micro-fiber cloth or 100% cotton cloth afterwards.
