## Installation


Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and successive component damage.

# **Attaching the Base**

1. To install the base, connect the neck to the base as indicated in the picture and secure the installation by screwing in the 2 base screws provided.



2. Once the entire stand assembly is complete, lay the monitor flat on a table and install the neck to the back of the monitor. Secure the installation by inserting and tightening the two screws.



- 3. To finalize your installation of the display, please read the following:
  - a. If you are placing the display on a stand, we would recommend you to use a display safety strap (not included) in order to minimize the possibility of the display toppling over.
  - b. Securely install all screws and connections.

# **Identifying Front and Rear Panel**

## **Front View**



• INDICATOR LIGHT – The light is solid when turned the monitor is powered on. If the light is flashing, that means there is no signal sent to the monitor.


## **Rear View**



• Mounting pattern is 100mm x 100mm using M4 screws at 8mm length.

## **Rear View with Connections**



- 1. **HEADPHONE** This connection is for audio out from the monitor to multimedia speakers or headphones.
- 2. **DVI** DVI stands for Digital Video Interface. This connection is for computers with DVI video output.
- 3. **HDMI 2** HDMI stands for High Definition Multimedia Interface. This connection is for computers with HDMI video output.
- 4. **HDMI 1** HDMI stands for High Definition Multimedia Interface. This connection is for computers with HDMI video output.
- 5. **DP** Display port is a digital video connection for connection to computers with display port video output.



- 1. This button activates the On Screen Display (OSD). While the OSD is active, this button will act as the select button to open up an option for adjustment.
- ▲ With no OSD, this button increases the internal speaker's volume. With the OSD turned on, this button moves the selection upwards. This button will also increase the value of an adjustment while an option is open.
- 3. ▼ With no OSD, this button decreases the internal speaker's volume. With the OSD turned on, this button moves the selection downwards. This button will also decrease the value of an adjustment while an option is open.
- 4. S When the OSD is active, this button acts as the EXIT button and exits out of the option or OSD. This button switches between all the different inputs of the display.
- 5.  $\mathbf{O}$  This button turns the display on or off.

## **Panel Tilt Adjustment**



The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the specific model of the device. Generally, it may be inclined  $3\pm1^{\circ}$  forward and  $12\pm1^{\circ}$  backward with a combined angle of  $15\pm2^{\circ}$ .

Please Note:

• When adjust the angle of the monitor, be sure not to touch or press the LCD screen.





- 1. **TEMPERATURE** This option let users select different color temperatures of the monitor.

I CAN'T OPEN THE OSD	You need to have a valid video signal going through the monitor before you can turn on the OSD.

Problem	Possible solutions
I CANNOT GET THE RESOLUTION 3840 x 2160	Sometimes your video card will not read the monitor correctly and will not allow you to achieve the resolution you want. Rebooting your computer will solve the situation.
	You can also make sure your video card's video drivers are up to date. You can find what video card you have by clicking on START then RUN. Type in "DXDIAG". When the diagnostic window pops up, click on the DISPLAY tab. The program will tell you what video chipset you have. Copy that name then search it with an online search engine like GOOGLE™. Find your video card company's web address and search for newer drivers. If updating your drivers does not work, you probably have one of the older video cards and cannot achieve a widescreen resolution. You'll need to upgrade your video card to a newer one.
