Opening the Package

The SCEPTRE display is packaged in a carton. The size and weight of the product might be too heavy for 1 person to handle. In the event of that happening, it is recommended that the display package must be handled by a minimum of 2 or more persons. Since the glass can be easily scratched or broken, please handle the product gently. Never place the unit on a surface with the glass facing downwards unless it is on protective padding. When opening the carton, check that the product is in good condition and that all standard accessories and items are included. Save the original box and all packing materials for future shipping needs.

Installation

Please read the user manual carefully before performing the installation. When an extension cord is required, use one with the correct power rating. The product should be installed on a flat surface to avoid tipping. Space should be maintained between the back of the product and the wall for proper ventilation. Avoid installing the product in the kitchen, bathroom or other places with high humidity dust or smoke, so as not to shorten the service life of the electronic components. Please ensure the product is installed with the screen in landscape orientation. Any 90° clockwise or counterclockwise installation may induce poor ventilation and successive component damage.

Assembling the Stand

1. With the packing foam still on, lay the monitor screen facing down on a table and open the top half of the packing foam. Install the neck to the base and insert the 2 base screws from the bottom. Tighten the screws to secure the base.



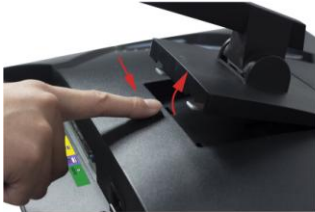
2. Insert the buckle on the bracket into the "notch" of the back shell, and press it down, when you hear a "click" sound, the installation is com.



3. To finalize your installation of the display, please read the following:
 - a. If you are placing the display on a stand, we would recommend you to use a display safety strap (not included) in order to minimize the possibility of the display toppling over.
 - b. If you are mounting the display on the wall
 - i. Make sure the wall is structurally safe for the weight of the display.
 - ii. Make sure the wall mount kit is compatible with the display.
 - iii. Read and follow all instructions provided by the wall mounting kit.
 - iv. Securely install all screws and connections.

Disassembling the Stand for Wall Mounting

1. Lay the monitor flat on a flat surface with the screen facing down. It can be disassembled by lifting the bracket by unlocking the locking button.



2. The mounting pattern is 100mm x 100mm using M4 screws.

Identifying Front and Rear Panel

Front View



Indicator Light – The light is blue when the monitor is turned on. The light is red when the monitor is turned off but plugged into power. The light is flashing blue when there is no signal given to the monitor.

Panel Tilt Adjustment

The screen can be adjusted by inclining forward and backward; however, the specific adjustment depends on the specific model of the device. Generally, it may be inclined -5° ~ 15° .







- When adjust the angle of the monitor, be sure not to touch or press the LCD screen.

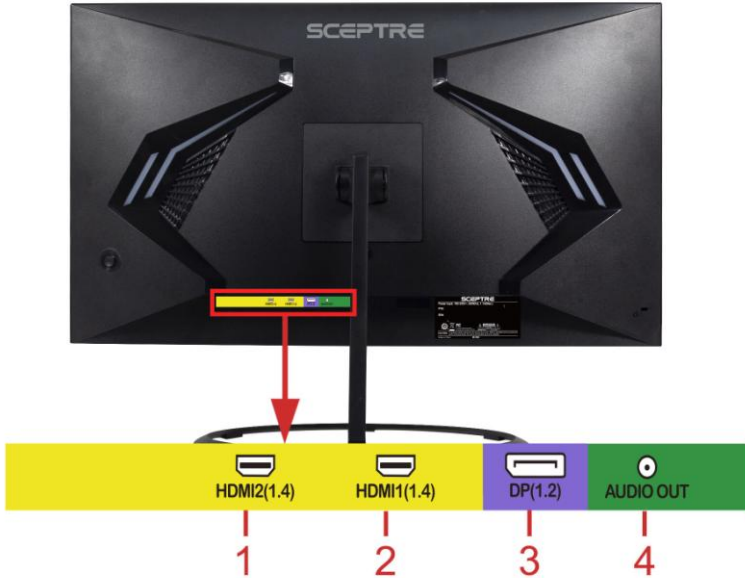
Rear View with Buttons



The following instructions are for the user to operate the joystick while facing the front of the monitor.

1.  – Press and hold this button to turn the display on or off. With no OSD, pressing the power / joystick button briefly will open the monitor's OSD. With the OSD turned on, pressing the power / joystick button briefly will enter into the selected option.
2.  – With no OSD, pushing the joystick up adjusts the monitor's Picture Preset settings. While the OSD is active, pushing the joystick up moves the selection upwards. This button will also increase the value of an adjustment while an option is open.
3.  – With no OSD, pushing the joystick left opens the Volume OSD and decreases the monitor's volume output. With the OSD turned on, pushing the joystick left exits the OSD Menu.
4.  – With no OSD, pushing the joystick right opens the Volume OSD and increases the monitor's volume output. With the OSD turned on, pushing the joystick right selects or enters the selected option.
5.  – With no OSD, pushing the joystick down opens the Source OSD, allowing you to change the input source of the monitor. With the OSD turned on, pushing the joystick down moves the selection downwards. This button will also decrease the value of an adjustment while an option is open.

Rear View with Connections



1. **HDMI 2** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video and audio output. HDMI 2 is version 1.4.
2. **HDMI 1** – HDMI stands for High-Definition Multimedia Interface. This connection is for computers with HDMI video and audio output. HDMI 1 is version 1.4.
3. **DISPLAYPORT** – DisplayPort is a digital video connection for connection to computers with display port video and audio output. DisplayPort is DP v1.2.
4. **AUDIO OUT (3.5mm Mini-jack)** – This connection is for audio out from the monitor to multimedia speakers or headphones.

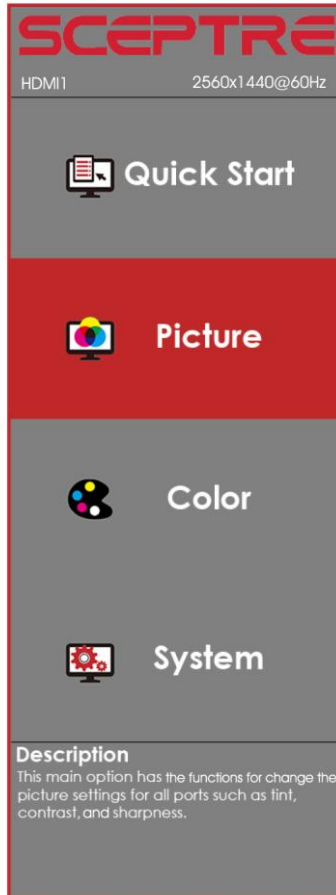




On Screen Display (OSD) Menu

The OSD menu of the monitor provides various adjustments for the monitor such as color, brightness, and contrast etc.









1. **TEMPERATURE** – This option let users select different color temperatures of the monitor.
 - a. **NORMAL** – This color temperature is for users who prefer a neutral white balance.
 - b. **COOL** – This color temperature is for users who prefer a cool white balance.
 - c. **USER** – This color temperature is for users who would like to adjust the RGB (red, green, blue) values manually.
 - i. **ADVANCED** – This setting adjusts finer values besides RGB going into red, green, blue, cyan, magenta, and yellow.
 - d. **WARM** – This color temperature is for users who prefer a warm white balance.
2. **GAMMA** – This option adjusts the gamma curve value of the monitor.
3. **TINT** – This option adjusts the tint of the entire monitor.
4. **SATURATION** – This option adjusts the color saturation of the entire monitor.

1. **OVERDRIVE** – This option increases the pixel response time of the LED screen.
2. **FREESYNC™ PREMIUM** – This option enables syncing with variable frequency with AMD video cards.
3. **SLEEP MODE** – With the monitor given no video signal, enabling this option will make the monitor automatically shut off after 30 minutes, 60 minutes, or 2 hours.
4. **Backcover Light** – Press to turn the display backcover Light on/off.
5. **LANGUAGE** – This option allows users to change the menu language of the monitor.
6. **OSD H POSITION** – This option adjusts the placement of the OSD menu horizontally.
7. **OSD TIMER** – This option adjusts the time it takes for the OSD menu to automatically shut off.
8. **OSD TRANSPARENCY** – This option adjusts the opacity of the OSD menu.
9. **MUTE** – This option allows users to silence the monitor's speakers.
10. **VOLUME** – This option allows users to change the output level of the audio out port.
11. **RESET** – This option resets all values of the menu back to factory default.

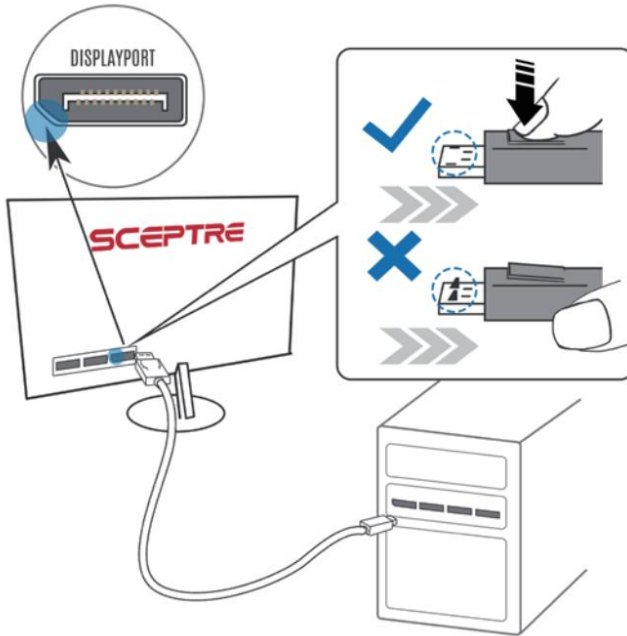

How do I detach the DisplayPort Cable?

To detach the DP cable from the monitor, press down on the cables unlocking button while pulling the cable out.



How do I clean the LED Monitor?

IMPORTANT

1. The power cable must be removed from the socket before cleaning the display.
2. Do not use volatile solvent (alcohol, rosin, and toluene) to clean the display. These types of chemicals might damage the housing and the LCD glass.

Cleaning the bezel

1. Use a 100% cotton cloth or micro-fiber cloth for cleaning.
